# **Downtown Facade Improvement** Introduced

A facade improvement program has been announced for the downtown area. Businesses on Front St., Hamilton Blvd. and a portion of South Plainfield Ave. will be eligible for a low cost loan and matching grants will be offered to improve the buildings.

This program is an innovative approach to improving the physical appearance of the center of downtown district. With the as-

sistance of Community Devel-

opment Block Grant Funds and

the support of Columbia Savings

Bank, businesses and property

owners will be offered a combi-

nation of grants and loans for im-

provements to their buildings and

working relationships between the public and private sector and ultimately increase South Plainfield's business base and desirabil-

ity.

The Borough will commit up to \$40,000 in Community Development Block Grant Funds for individual grants and Columbia Savings Bank has committed \$500,000 in the form of low-interest loans

Business owners located in OBC-2 Zone can apply for funding. The Borough will have available matching grants of up to \$5,000 per application for exterior facade improvements. The applicant will have to provide 50% of the total cost of renovation and the grant will provide 50%, not to exceed \$5,000.

The applicant may seek funding for the match or

Terms of the loan are prime rate minus 1% with loan amounts from \$3,000 to \$50,000 per application. The repayment schedule is up to seven years. Origination fees will be Origination '

#### Dear Residents:

Thank you for your patience, support and understanding durthe storm of Sept. 7, and its aftermath.

We were confronted with hundreds of downed trees, electrical wires, transformer fires, branches, damaged homes, damaged cars and blocked roadways. Throughout the early afternoon, late into the night and next day, our Emergency Management Coordinator Michael Zushma. along with our Police Depart-Fire Department, Rescue Squad and Public Works worked feverishly to restore order to our Borough.

As Mayor I am angry at the lack of adequate response from Public Service Electric & Gas Company. Throughout Monday night and Tuesday morning, not one work crew was dispatched to South Plainfield despite repeated requests for assistance. Public Service Electric & Gas management could not provide information as to when we would receive assistance. While I sincerely appreciate the dedi-cation and hard work of their field crews who spent countless hours working to repair the damage, it is the management of Public Service Electric & Gas that I hold accountable for their failure to mobilize a workforce and respond to our emergency demands.

We have some six residents on life-support systems requiring generators, which were provided by the Borough as Public Service could provide no assurance as to when service would be restored.

I have filed a formal complaint with the Board of Public Utilities demanding that Public Service Electric & Gas Company design and implement an emergency action plan, detailing responsibilities, response schedules and deployment of personnel and equipment to be able to meet the needs of our residents.

I have asked that this plan be presented to our Emergency Management Coordinator, Police, Fire, Rescue Squad and Governing Body to provide assurance of needed assistance during emergencies.

I thank you for what you have done during the emergency.

# **Father Thomas Ganley Joins** Sacred Heart Church


Sacred Heart Church recently announced Father Thomas Ganley will be joining the church

# Residents Reject Developer's Plans

Developer Bill Wilkins returned to the Planning Board asking to sub-divide and build four houses on property which extends from Pershing Place to Bullard Place.

The property is said to have several old trees, some of which date back over a hundred years. The developer has agreed to preserve two of the trees.

Residents objected to the construction of four homes on lot widths just 60 or 75 feet wide, saying the homes on each side on Bullard Place have property lines of 100 feet wide or more. Walter K. Abrams, the attorney representing the applicant, entered into evidence a map showing homes

in the area that are located on less than the required width. John Hogan, Board Chairman, was not impressed with the map, saying past decisions on lot size would not affect the Board's decision in this case. He also said he felt the builder is proposing to construct too many houses on the lot. He felt three houses would be better than four.

Mayor Gallagher reiterated what John Hogan said. He said he would vote no to four houses on that lot. Mr. Abrams then asked for a continuance so he could bring in a planner to fur-ther explain his case. Mayor Gallagher thought Abrams should

come prepared with a planner. The session was opened to the public with the understanding that the public would be able to speak during the next hearing. Most residents felt four houses would be too many for this size lot; they preferred just two houses. Residents also objected to the ancient trees being removed. One of the trees the builder proposed to keep will be only 25 feet from the front of the house, "a sure death to that tree," said one resident. Future flooding was also a concern because so many trees and shrubs would be removed.

The Planning Board continued the case until the Oct. 13 meeting.



# AMERICAN COMPLIER CORNER

I've heard it said that when a dog bites a man it is not news, but that the opposite always is. That's just another way of pointing out the unusual as being newsworthy. In that vein, and with my apologies for being a bit late, I'd like to be one to go to print with a word of thanks for our town's cleanup efforts after the Labor Day storm. To be sure, a lot of us were left with major inconveniences, but let's consider the good side too. Just a few short weeks afterwards, we are all cleaned up and back to normal. Very few surrounding towns bounced back as well and as quickly as we did. I believe the coordinated efforts of all involved paid off handsomely and showed us what we can do when we need to. South Plainfield did well and you won't soon hear me complaining about things around town.

Getting back on track here, I want to mention a few more good help resources for those needing support with computer issues. I know it's easy and customary to call someone else, but you would be amazed how simple it is to solve your computer problems for yourself these days. We've already covered the wealth of online and CBT (computer based training) subjects available for everyone to learn how to handle most of the problems they'll ever encounter. Here's one that's even simpler and, in some ways, better: Just listen to the radio! WCTC, 1450 AM, carries an interactive program called "On Computers." This show airs on Sundays from 1:00 to 4:00 in the afternoon.

The "On Computers" show is supported by Dell Computers who provides a free call-in tech support line (1-800-677-0874) during the show. You can call in with any question or problem in any computer area and they'll help you at no cost. You can even call into the show itself at (1-800-827-7777) and go live on the air with your situation. You may also send Email to them at oncomputers@msn.com, or check into their website at www.oncomputers.com. (Now if more of my

friends read this column and followed some of this advice...)

TIP: When seeking assistance with a problem, first go to your own "Help" button in the upper left of your screen. Search through the index and explore some the suggestions given there. You'll very likely learn a bit more about your own system, and you'll be able to give more intelligent feedback to those who you may ultimately have to call on for further aid.

Last issue I delved into the realm of voice recognition software. I did hear (from a call-in to the "On Computers" show) that these programs work better with faster computers and with more RAM. The listener who called in suggested CPU speeds in the 200+MHz range and memory capacity (RAM) of 64MB and up! Again, if any readers know, or have used such programs, please share your impressions and knowledge with all of us.

TIP: For anyone needing research help for term papers, etc., here are some good web sites to look into: www.clearinghouse. net, www.studyweb.com, www. lehigh.net/zuzu/genlink/ htm. Don't forget the venerable Strunk & White's Elements of Style www.columbia.edu/acis/ bartleby/strunk. With all this online help available for researching term papers etc., I can't imagine anyone spending the time we "older" folks had to spend in libraries doing our "homework.

TIP: To be sure you're not late with term papers and other important dates try www.getreminded. com. It's free, and leaves you with one less reason for not remem-

TIP: Here's a last minute item for high school seniors. Go visit www.pbs.org/jobs/teenindex. html. This is good guidance source for help in planning your future. Good luck!


# **Police Conduct Surprise** Search At High School

On Friday, Sept. 25 at 8:30 a.m., the South Plainfield Police Department, along with the Middlesex County Prosecutor's Office Narcotic Task Force, conducted a K-9 locker and vehicle search at the South Plainfield High School. The operation was done at the request of/and in cooperation with school officials which included school Superintendent Guy Ferri and South Plainfield High School Principal Anthony Massaro. The operation was in response to com-munity concerns of the possibilcotics being sold or pos sessed on school property.

The operation resulted in the seizure of a small amount of narcotics (marijuana). There was one on-scene arrest of a seventeen-year-old male student. The search included both floors of the school

as well as the entire parking lot. K-9s from the Middlesex County Prosecutor's Office, US Coast Guard, Woodbridge Police Department, Carteret Police Department and Sayreville Police Department were utilized for the operation. A total of seven dogs were on the scene.

This operation is a sign of the cooperation between law enforcement and school officials in combating the problem of drug u by the youth of our community. The police department and school officials are looking forward to this continuing cooperation.

Continued from page 1 waived. All applications for loans and grants will be reviewed on a first come, first served basis. An applicant may apply for a grant, loan or both.

One major advantage of participating in this program is the grant money does not have to be paid back, except in certain cases of the business closing or property sale. In addition, the terms of the loans available through this program are much better than most business or property owners could obtain individually.

Grant and loan funds under this program must be used exclusively for exterior facade improvements. The following are examples of work which qualify: correction of exterior code violations, painting and siding, signs and awnings, exterior repairs, door and window replacement, shutters, trimwork and landscaping. However, site amenities such as paving of parking areas and sidewalk repairs will apply only to loans.

An applicant's 50% match, when provided by his or her own funds, may be met with other types of building improvements, such as: correction of interior code violations, HVAC system replacement and general interior renovation and repairs. Other types of work may qualify. All applications will be reviewed on a case by case basis for participation.

Through this program, limited free design assistance will be provided from the Borough of South Plainfield Office of Community & Economic Development. Many publications, videos, slide shows and other materials are available that may also be of assistance. The Borough will help in any way to make the best use of your funding.

When you complete and submit your application for funding, the Office of Community and Economic Development will determine what type of professional services you will need. If approved, you may be eligible for an additional grant of \$500 to pay for architectural services. The department also keeps a list of contractors to assist you in getting bids.

The Borough is committed to making this program as simple as possible by helping businesses get the required permits and approvals quickly and easily. In most cases of exterior facade work, no Board appearance will be required.
