# VINNIE IS GOING!

Petronko To Seek Re-Election; Buttiglieri Declines Bid for Third Term

Councilman Vincent Buttiglieri announced at last week's Democratic Organization meeting that he will not seek reelection to a third term on the council.

"My six years as a councilman have been the most fulfilling of my life. I will miss it. Due to professional and family responsibilities, I cannot devote the time required to do the job right. However, I do not intend to remove myself from public service. I have already told Mayor Gallagher that I want to serve on a board or agency next year. I will always be available to continue working to keep South Plainfield the nicest town in New Jersey."

Mayor Dan Gallagher summed up the feelings of the Democratic Organization, "Vinnie Buttiglieri is irreplaceable. He has been a tremendous councilperson and he will definitely be missed. It was Vinnie who first came up with the idea of partnering with Middlesex County to repave our roads. As a result, over 80 roads have been repayed over the last six years on a "pay as you go" basis. Vinnie has organized Democracy Day and has been the liaison to the Taxpayers Advisory Group since its inception. He has served on the Administration and Finance committee, and to a large extent, because of his background in accounting, we have had a flat budget for six straight years. I

must be honest, we tried hard to change his mind but obviously we will respect his decision not to seek reelection."

Councilperson Buttiglieri was first elected to the South Plainfield Borough Council in 1994 and has chaired the Public Works Committee during his tenure in addition to serving on virtually every committee within borough government.

Borough Councilman Raymond Petronko also announced that he will be seeking a second term on the Borough Council.

Petronko, who has served as chairperson of the Recreation Department, has overseen upgrades to several parks in town, including Putnam and Shadyside. He has also been working with

the seniors on their new senior center and with the Recreation Department on the expansion of the PAL Building. Ray has also served on the public celebrations committee, working on the Labor Day Parade Committee.

# PAL Building **Expansion Planners** Seek New Approach

At the Feb. 8 Recreation Commission's monthly meeting the topic of discussion centered on what the next step for the PAL expansion should be. The commissioners heard from two companies, Joe DeAndrea, the PAL architect and AST Management and discussed the possibility of hiring a construction or project manager. The idea was to find a way to save money and get the project underway. They are also looking into the possibility of local businesses donating the build-

At last Thursday night's council meeting, the council passed a resolution to enter into an agreement with AST Development Corp. to conduct a bidding/negotiating phase with the original bidders. The cost for this service is \$6500. In effect AST will sit down with those who have already bid on the project and any additional interested contractors to negotiating the cost of the construc-

New Jersey law permits negotiations with bidders when bids have been twice rejected to determine if negotiations can lead to more acceptable prices. The first two bids came back approximately \$400,000 above the estimated cost and were subsequently rejected by the mayor and council.

Recreation Director Mike English said he is also getting a materials list and will be asking businesses to either donate materials or sell them at cost. English said the PAL building is utilized by 200,000 to 300,000 people who pass through the facility during the year. The number of people using the weight room has also increased as well those who use the PAL for sports, meetings and functions

# School Board Extends School Year, Caps Class Sizes and Suspends Open Enrollment

Monday evening, the Board of Education held a special meeting to allow the public to speak on agenda items which were passed during the February meeting. That meeting was adjourned because of a disruption by some members of the teachers union and the public was never given a

chance to ask speak.

An extra large crowd of teachers and parents attended this meeting. Spectators spilled out into the hall; others sat on the floor, the window sills and many stood in the back of the room.

The board explained that schools which have reached their maximum student class size will be forced to bus any newly enrolled students to a school that can accommodate them. Open enrollment will also be suspended, but those now in the program will be grandfathered. This means that kindergarten children may not go to their neighborhood school if the class

capacity is reached. Some families may end up with children in different schools. Enrollment is on a first come, first serve basis.

Board members emphasized how important the upcoming referendum is. If it passes the overcrowding can be addressed with the addition of more classrooms.

"My hope is the referendum will pass and we can start construction right away and get Grant School ready by the fall to give the district some relief," said Superintendent of Schools Guy

The enrollment cap for kindergarten is 20 students; grades Continued on page 12





# **Police Conduct Surprise Sweep of High School**

On Tuesday, police and school officials conducted a sweep of South Plainfield High School in order to ascertain if drugs or other controlled dangerous substances were present.

Superintendent of Schools Guy Ferri described the action as "a continuing effort to be certain the high school maintains a safe and healthy learning atmosphere." The district requested the assistance of the Middlesex County Prosecutor's Office late last spring to make tentative arrangements. According to Ferri, he and high school principal Tony Massaro are determined to help students who were drug use victims and to take a hard line with anyone involved in the sale or distribution of drugs.

Prosecutor's officers were assisted by representatives of the Middlesex County Sheriff's Office and the South Plainfield Police Department. Teams of police and specially trained K-9 dogs swept the school's parking areas and sniffed the student lockers soon after the start of the school day. Students were kept in their classrooms and classes were extended while the search was con-

No drugs were found within the school or in the parking lots. The fact that there were no drugs uncovered was seen as heartening by the district leadership. Furthermore, the continued use of task force resources is seen as an assist in deterring drug possession in the schools.

The squad's volunteers spent 319 member hours answering the January calls.




## **Beginners Learn How to Get** 'Connected' on the Internet



# Cub Pack 205 Holds Blue and Gold Dinner











The council held a public meeting and voted that this year's Community Development Grant (CDBG) money in the amount of \$61,000 will be used for the construction of the Senior Center.






