ERS REJECT REFERE

South Plainfield voters once again rejected a proposed \$22.6 million bond referendum, which would have built a new Roosevelt School, expanded the administration building, installed new boilers in the Middle School, upgraded electrical capacity in all schools and installed a new track at Jost Field.

The final vote count was 1750-1600, with 28 percent of the registered voters casting ballots. Approximately 3,350 registered

voters turned out, versus only about 2,000 in December. This was the second time voters rejected a bond referendum in the past few months. Last December voters turned down a similar bond referendum.

After their defeat in December, the Board of Education came right back asking to voters to approve another referendum with just a few changes. This time they proposed to keep the old Roosevelt School for ad-

ditional classrooms and build a new administration building. This new plan increased the costs of the bond by \$100,000.

The board also launched a major public relations campaign this time around. They held meetings and focus groups, put up signs and did mass mailings. All of these efforts still did not produce voter approval at the polls. Many residents had asked that the referendum be divided into two questions, but the board rejected

that idea.

South Plainfield is undergoing a dramatic rise in student enrollment due to increased housing construction. The board recently voted to put a cap on class sizes and to suspend open enrollment.

Plans are also in the works to renovate a portion of the administration building for additional classrooms.

Next month, on Tuesday, April 18, voters will again go to the polls

Councilman Petronko stated, "The DARE program is an important part of your youth instruction and support, and the mayor and council recognize the





Senior Center, Housing Closer to Reality

Two projects, a senior housing complex and the senior center, are coming closer to becoming a reality because of the actions that took place last week.

The property for the new 10,000 sq. ft. senior center, to be located on the corner of Maple and Lake Ave., (the former site of the Shell Station) was purchased by the borough for \$365,000. Financing will come from the annual Community Development Block Grant Fund. The borough is asking to

float a five year advance on future grant allocations. The actual building will be donated to the borough by Jack Morris, builder of the proposed townhouses and condominiums on the Coppola Farm property.


The other project is the 100unit senior housing complex planned on Morris Ave. Plans for this complex have been ongoing for more than 10 years.

The project developer, Lutheran Social Ministries, a non-profit corporation, gained financial support last week when the Middlesex County Improvement Authority approved \$6 million in bonds. The borough has donated the seven acres of land for the project as well as \$1.9 million. The rest of the estimated \$11 million will be raised through grants and loans.

The bonds will be paid off through rents from the apartments. The senior complex also helps South Plainfield fulfill its obligation to provide affordable housing.



Author Tells More Than Stories at Roosevelt School

When children pick up a book, they seldom think about the author or the process it takes to create that book. To them the author is simply a name and perhaps a face on a book cover. Roosevelt School students recently received a visit from children's author Pat Brisson. The visit introduced them to far more than just the author. During several assemblies throughout the day, Ms. Brisson addressed the various grade levels. She made books come alive for students. The young readers learned how an author writes a book, from the early stages of notes and drafts to the final work on a computer. They discussed the illustrations as well. Ms. Brisson pointed out that the illustrator does not work side by side with the author but receives the written material at a later date. The illustrator then creates pictures that help tell the story. An interesting note Brisson made was that the cover picture has to have room for the title of the book and is something that the artist has to consider when creating this

After a lunch break Ms. Brisson sat in the library for a book signing session. Group after group of smiling youths entered to have their books autographed. Each child smiled as their book was addressed to them, the smiles were returned by the author. The last group to be visited by the author was Miss Frank's Kindergar-

ten class. The children saw a slide show that featured the author's family as well as the various steps in creating a book. The children learned that an author is just a regular person who writes stories as a job.

Ms. Brisson used her book, Benny's Pennies, as an example and the students heard the story directly from the author while viewing the corresponding illustrations. The story is a rhyming tale that younger students delight in. The class talked about other words that rhyme. It was a long day for the author but she truly seemed to enjoy it. She expressed a sincere interest in each question or comment the children had.

Pat Brisson is the author of ten books, including The Summer My Father Was Ten which, along with illustrator Andrea Shine, received The Christopher Award. The awards honor creators, writers, directors, and producers of film, television specials and books that affirm the highest values of the human spirit.

Other works by Brisson include Your Best Friend Kate, Kate Heads West, Kate on the Coast, Sky Memories, Hot Fudge Hero, Little Sister, Magic Carpet and Wanda's Roses. Pat Brisson was born in Rahway and lived in Woodbridge. She attended Rutgers and taught in New Jersey schools. She presently resides in Phillipsburg with her husband and four sons. Brisson regularly tours schools giving children a glimpse into the world of books

This year members will receive 10 free passes with their membership. Guest pass books which contain 10 daily passes may be purchased by members at \$50 per book. There is a limit of one book per month.


