## **Police Use** Defibrillator, Save a Life

Last Tuesday, South Plainfield Police Officers Garret Cassio and John Petruello responded to the report of an unresponsive man at his residence on Frederick Ave.

When they arrived, both officers found a 70-year-old man lying in the rear yard. He was unresponsive and had no pulse. A family member explained that he had been unconscious for almost 10 minutes.

The officers immediately started C.P.R and utilized the police department's defibrillator (AED). On three different occasions the AED recommended that a shock be given to the patient. The rescue squad arrived as the officers were delivering their third shock to the patient. Shortly thereafter, the patient's pulse and blood pressure returned. He was later admitted to the intensive care unit at Muhlenberg Hospital.

This is the third 'save' for the SP PD since obtaining the AEDs. Three units were obtained by the police department in 1999 through donations by local merchants. Since receiving the units, the entire department has received training in proper operation and use.

# Municipal **Budget** Introduced

The 2001 municipal budget was introduced at last week's council meeting. A public hearing on the budget is planned for Thursday, Sept. 28.

If this years budget numbers do not change, the budget will result an increase in the municipal tax rate of 5 to 6 points, or about a \$60-\$65 increase per household. During the last few years, the council has kept the municipal budget flat, with no tax increases.

According to Councilman Ed Kubala, the budget that was introduced is still being tweaked and the

in lower.

According to Kubala, one reason for the rise in the tax rate is that discretionary aid from the state has been decreasing each year. In fact, last year South Plainfield received no discretionary aid at all from the state. He plans to go back to the state and ask them to restore the funds. The reason the state gave for denying past funds was that the borough had maintained a flat budget for the past years and thus didn't need extra funding. The mayor says that this a form of punishment for those municipalities who keep a tight fiscal ship, while municipalities who didn't have a balanced budget were given state aid.

Another reason for the higher budget are the increased salaries and higher insurance costs.

Kubala stressed they are all still working on the budget and if the state should restore some or all of South Plainfield's discretionary aid, the tax increase will be much lower or minimal.

## lis Williams Marks His 95th

On Aug. 24 Ellis Downing Williams, a well-known teacher in South Plainfield, celebrated his 95th birthday. Mr. Williams was chairman of the Math-Science area of South Plainfield High School from 1956 to 1973, until he retired.

He was born on the family farm located in Lathrop Township, Susquehanna County in Pennsylvania, to parents Dyer and Mary Will-

Williams attended the rural schools of Lathrop Township and graduated from Nicholson High School in 1923. He then matriculated at Mansfield State Normal School in Mansfield, Pa. His university majors included math-science, English and history. He was active in the symphony orchestra, playing the violin and the college band, playing bass horn. Williams earned his B.S. in Mansfield in 1930 and his masters in education from Duke University in

His first teaching position was as a seventh/eighth grade science and math teacher in Clark Summit School in Clark Green, Pa. He taught there for 16 years. After four years, Williams became the assistant principal and continued teaching part-time.

In 1935, he married Dorothy

Killian from Clark Summit, Pa. They had one daughter, Hazelmae Higgins. His wife passed away in 1992.

After teaching in Clark Summit, he taught college physics for 10 years. Williams accepted a position in North Plainfield in 1953 teaching science.

In 1956, he received an offer to become the chairman of the Math-Science Area of the then new South Plainfield High School. He finished his teaching career at SPHS when the newest high school opened in 1973, retiring after 47 years.

After his retirement, Williams became a professional photographer. For years, before and after his retirement, he took pictures for the year book and of school functions. Williams still takes pictures each year at the high school awards and scholarship evening in the high school.



The committee is in the process of deciding what electricity, wiring and communication is essential for any upgrade to be started. The public is invited to attend this meeting.






## South Plainfield Welcomes New Business
