

# Residents **Surprised by School Closing**

Many residents were more than little surprised to find out that South Plainfield schools would be closed last Tuesday morning. The South Plainfield school district was one of only three district closings in the entire state.

Mayor Dan Gallagher said that he was not contacted about the school closing nor any report of uncleared sidewalks or roads. He felt the decision to close the schools was made in haste. "It was their (the school district's) choice to make this decision. I heard about the closing when my wife, who is a duty-aide at the high school, received a call from the phone chain. She was told to no-tify several other school employces that the school would be closed because the borough had not cleared secondary roads and some sidewalks," he said.

Gallagher noted that he is never personally contacted by the BOE about school closings. He said that he spoke to Superintendent Guy Ferri on Tuesday afternoon regarding the school closing. "Ferri told me he had spoken with Code Enforcement Officer Mike Zushma about the condition of sidewalks. I spoke with Zushma later in the day and he said he had not been contacted by Ferri," Gallagher said.

The area of concern is the halfmile walkways surrounding the schools. Mike Zushma spent Tuesday canvassing those areas and locating impassible sidewalks. He either spoke to the residents or left a notice. They were given 24 hours to clear the walk or receive a summons. The snow removal law on the books states that "five hours after the snow has stopped falling borough sidewalks must be cleared.

Gallagher explained that he has never enforced the law, saying that most people must go to work or are senior citizens and that makes clearing the walks in a timely manner difficult. He said that in addition to the BOE complaint, which was not made directly to him, he only received two calls about borough streets during the aftermath of the storm. Those calls came from Foster Terrace and Meister Street. "Now that we have this complaint from the BOE, we will have to begin enforcing the snow removal law," he added.

Gallagher also pointed out a conflict with the BOB company, "I visited the Middle School and Continued on page 10



# Petronko, Cusick To be Sworn In

Along with the two councilmen, new and incumbent members of various boards and commissions will be also be sworn in. The meeting will take place at 1 p.m. in Borough Hall.

#### Petronko Starts 2nd Term **Cusick Joins Council**

Councilman Ray Petronko will begin his second term on Jan. 7. His first step into South Plainfield politics was his appointment to the Traffic Safety Advisory Committee, where he served for eight years. "This board was an opportunity for me to serve my community," Ray said.

After seven years on the com-mittee Petronko was approached by members of the Borough Council and asked to run for an open council seat. "It was an Continued on page 12

# **Buttiglieri Relinquishes Two-Term Council Seat**

Vinnie Buttiglieri is proud of his service to South Plainfield and he is enthusiastic about the future of our town and believes he is ready to move on with his own future.



independent contractors to help with snow removal. According to Joe Glowacki, Public Works superintendent, the department contracted outside help because some of their trucks were not in operating order and they felt they needed the additional help to remove the snow. The plows were on the streets starting early Sat-urday morning and continued throughout the day and into Sunday. They took a break on New Year's Day, but were back clean-ing the streets on Tuesday.

Police, fire and rescue squad personnel were able to get around town with little difficulty thanks to the road department, which kept the main roads clear. Fortunately, the storm arrived

on a Saturday. Most people re mained indoors, waiting until their streets were plowed

for them." When asked for some parting words on the mayor and council and South Plainfield in general, Buttiglieri enthusiastically replied, "I am in awe whenever I think of the many hours that the mayor and council have devoted to the citizens. I have been constantly amazed that the members of the governing body, all of whom come from such diverse backgrounds, can work so well together for the common good of the borough. Never once can I recall members thinking of themselves first. It was always, 'what's best for the citizens.' That really is a credit to all of them. In My Opinion

To The Editor:

I recently attended a special Board of Adjustment meeting at Borough Hall.

This meeting was to hear lawyers and their experts with plans from a billboard company who wants to install three signs along 1.8 miles of Rt. 287 in South Plainfield. The Department of Transportation (DOT) has already issued permits for these said signs.

For forty years Rt. 287 has been clear of signs and now they want to place billboards to ugly up our area and environment.

The mayor and council passed. an ordinance against billboards being erected in our community. Our records show that council-man Ed Kubala was the only member who voted against the billboard ordinance. He also stated that in the future, the Borough of South Plainfield will have a legal fight on its hands.

It appears that Mr. Kubala, a retired New Jersey State em-ployee, may have had some in-side information that the rest of us had no knowledge of.

As I quote the expert that testi-fied, one sign will be erected at the end of Easton Blvd., closest to Rt. 287, and will be 50 feet high. It will have five halogen lights on each side that will be well-lit from dusk to dawn, seven days a week. A driver will be able to see the sign from about 1,500 feet away, with no back drop to shield the sign from residents or businesses in the area.

One local resident stated that the back of the sign will be at his neighbor's front door and the other neighbor's house will be at the front of the sign. The expert stated that you will not be able to see the sign from Hamilton Blvd.

The State of New Jersey Advertising Act has a section on pro-tecting the environment, which the expert agreed (but never men-tioned) how they will maintain the environment in the area—nor did he mention how to protect the residents and businesses in the area. I heard no one speak about any maintenance procedures they plan to follow.

At this meeting, I did see a lot of money being spent on layouts, on plans, more lawyers and lots of experts. How can someone be an expert on billboards? They are all ugly and do nothing for envi-ronment or scenery. Does that

mean you're an expert on ugly? Being a lifelong resident of South Plainfield, it seems like another out-of-towner is going to tell us what they are going to do with our environment and there is nothing we can do about it. I have traveled this country from one side to the other and also been to Europe, where many countries don't allow billboards.

My observation on billboards is that they are ugly and unsightly obstacles. After a period of time, no one looks at them.

If the billboard company wants to spend money for lawyers and experts so they can erect three signs in South Plainfield, then in opinion South Plainfield should impose a city tax on all billboards on a monthly basis. If we have to look at ugly, then ugly should help us pay for education and other vital projects. God knows we can use the financial support-a city tax on all billboards! JAKE CATALDO

# Suburban Transit Vacates New Market Location

**Gets Preliminary Building Approval** 

At a special Planning Board meeting held last Thursday night, Commerce Bank was given pre-liminary approval to construct a new bank directly across from directly across from Borough Hall.

The property, about 1.27 acres, is located on the corner of Lane and Plainfield Avenues. Presently there are two houses on the lots, which will be demolished to make way for the new bank. The lots are in the OBC-1Zone, which is a permitted use for a bank.

Plans call for 31 parking places, a four-car drive-through and entrances on both Plainfield and Lane Avenues. A two-sided monu-ment sign, eight feet tall, will be placed in front of the bank.

Lighting the bank area was a concern to board members, because there are four houses located directly behind the bank. Commerce Bank plans to place shields on the lights in the rear of the property where the houses are located

A 29-foot buffer of trees, bushes and a wooden fence will also be placed at the rear of the property near the homes. A retention basin is also planned, but the board asked if the plans could be changed to have them placed underground for safety reasons.

Two driveways will be on Plainfield, one will be an exit only for cars leaving the drive-through, the other will be close to the cor ner. Left turns from Plainfield Ave. entering the bank will be prohibited, left turns exiting the bank will be allowed. Lane Ave. will be unrestricted and turns both left and right will be allowed.

The board issued only a preliminary approval. Commerce will have to return to the board with updated plans for several of the changes and permits that were not available at Thursday's meeting.

One of the residents located behind the bank asked that a study be done on the environmental impact of having 14 or more cars using the drive-thru, with motors running, near their houses. He also questions the lighting and the buffer. Planning Board Chairman Bob Ackerman said he would ask Alice Tempel to check on the environmental issues.



Only one bus remains on the lot where Suburban Transit formerly stored and maintained their buses. The company has relocated their buses to another site.

Suburban Transit, which has occupied space on New Market Ave. for decades, has moved out, leaving the bus depot vacant.

Disgruntled neighboring resi-dents attended at least six Board of Adjustment meetings since August of 1999, objecting to the bus company's request to expand their facilities. Suburban also requested a variance to construct a 10,000 diesel fuel tank, which they had already erected. One of the reasons they were before the board was because they had not applied for either a permit or a

variance for the tank. Neighbors also objected to Suburban running their bus engines all night, cutting down trees that were used as a buffer

between the company and residents and to the constant noise and emissions buses were making right behind their homes They also objected to buses park-ing on side streets and blocking the road. Suburban has occupied this space for decades, expanding several times, apparently without any permits.

The 20+ surrounding neighbors never missed a meeting, keeping the pressure on the board and the bus company

Finally, in June of 2000, the Board of Adjustment voted to

deny all of the variances requested by Suburban Transit. As of Dec. 31, the company moved all of their buses out of

the depot, leaving it vacant.

# St. Joseph HS Unveils Plans for the 21st Century

Brother Joseph Holthaus, president of St. Joseph High School in Metuchen, has announced plans for a comprehensive \$6.5 million building program that includes major improvements in the areas of academics, sports and extracurricular activities.

The ambitious plan to expand and enhance the physical plant represents the first major building project in the school's history. It is designed to position the school for a continuance of academic excellence well into the new century.

The project calls for the creation of three new science laboratories along with two new demonstration/lecture classrooms, each featuring state-of-the-art equipment, technology and facilities.

technology and facilities. In addition, the plan encompasses a new athletic center complex with a seating capacity of 1,000, along with a dedicated weight room and training room. The design is larger and more flexible than the current gymnasium, which will be re-configured for use as a multipurpose facility supporting drama productions, liturgies and a student gathering area.

Finally, a new library and media center will be created. It will have sufficient area to house additional books and reference materials, provide more study space, and offer the latest in sophisticated computer technology. The old library will yield additional classroom space.

Brother Joseph said the project addresses an aging physical plant and growing scarcity of space necessary to maintain and enhance the high educational, ex-

tracurricular and athletic standards that make St. Joseph High School unique.

"Completion of the project is essential to maintaining a school facility that meets our proven standards for current students while helping us to attract the best students in the future," said Brother Joseph. "It will guarantee students in the new century a physical environment where they can learn and grow to achieve to their fullest potential.

The project is the outgrowth of a Strategic Planning Study completed by the school, which was comprehensive in nature for building, academics and faculty/staff considerations.

Steven Pozycki, a 1969 graduate, Chief Executive Officer of SJP Properties, and Chairman of the school's Capital Campaign Planning Committee, said the project responds to a new era in education, and will make it possible for St. Joseph High School to build on its tradition of offering high quality instruction and training to thousands of young men from middle class families.

Brother Joseph said the school is currently presenting its plans to various state and municipal agencies in order to secure the necessary permits to begin construction. Contingent upon receiving the required approvals, he indicated that groundbreaking for the project would take place in late April 2001.

St. Joseph High School is operated by the Brothers of the Sacred Heart, a Catholic religious order of men with schools around the world. The brothers began their ministry in the Metuchen area in 1901 and founded St. Joseph High School at its current sight in 1961. The school provides college preparatory, value-based education in the Catholic tradition to young men in central New Jersey. It presently has a student body of 775.





As of Wednesday morning, the sidewalks right next to Roosevelt School on Hamilton Blvd. were still not cleared. Children cross-ing Belmont Ave. had no cleared path to walk unless they walked on Hamilton Blvd., which is a very heavily traveled road.

Residents are asked to clear their sidewalks as soon as possible after a snow storm so our children do not have to walk along the roadways. Drivers should also be aware that children may be walking along the edge of the roadways in South Plainfield until the snow is removed.

# **Police** Charge Suspect with **Three Counts**
