Skateboarders Look to Recreation Commission for Skate Park

Last week's Recreation meeting was attended by youths of all ages, asking for help in getting a place to skateboard in South Plainfield.

Last month Deanna Fredericks, the mother of some very enthusiastic skateboarders, had asked the council to consider building a skateboard rink in one of our parks. Fredericks said that she has to drive her children to nearby communities for them to skateboard and would like to see South Plainfield build a rink for its youth.

Councilman Ray Petronko told her he would look into it. The council expressed some concerns that insurance may not be available or that costs would be astronomical.

Petronko looked to Recreation Commissioner Mike English to determine the cost to install a rink, as well as insurance issues, they were well prepared to discuss the project and answer questions from those attending the meeting.

Drew Hines of Hot Rails in Orange, a builder of skating rinks, gave a presentation to the group. He discussed sizes, the various types of courses, costs and materials used. As far as insurance is concerned, insurance companies issue specs and they are built according to these standards to qualify for coverage. According to the children attending, there are hundreds of kids in South Plainfield that skateboard now and the sport is growing every day.

Mike English said there is property behind the Rescue Squad that could be converted to a skateboard area. He said he will look at nearby communities and explore costs of insurance and installation and report back to the Recreation Commission.

The plans are in the early stages, but most everyone who attended felt encouraged by what they heard. "This town has always supported

Apple Juice Spill Jams Hamilton Blvd.

On Dec. 6 at 4:52 p.m. a tractor trailer traveling westbound on Hamil-ton Blvd. near South Clinton Ave. overturned and struck a telephone pole

The truck was a 1995 Volvo and owned by the Nestle Corp. It was being operated by Clint Vanstone of Strausstown, Pa. The trailer contained approximately 44,000 lbs. of apple juice concentrate, most of which

spilled onto the roadway and the surrounding area. The tractor trailer flipped onto the

property owned by Binder Machine and damage was done to the landscape, signs, mailboxes and lighting fixtures

Mr. Vanstone was able to extricate himself from the tractor prior to the arrival of emergency units and was treated for a minor head injury.

Members of the South Plainfield Police and Fire Departments as well as the Rescue Squad and Office of Emergency Management responded. The roadway was closed from 4:52 p.m. until 7 a.m. the next morning, while the remaining contents of the trailer had to be pumped out and the truck uprighted.

The cause of the accident is still under investigation.
