



Cusick Promoted to Sergeant At Corrections Facility

South Plainfield Councilman Bob Cusick, who has worked at the Middlesex County Corrections Facility for 14 years, was promoted to sergeant at ceremonies held Tuesday morning.

Cusick took a civil service test to receive the promotion. He received the highest score among the 92 who took the test. Civil service employees are promoted by achieving top scores on the exams for the position for which they apply.

According to Warden Michael Abode, Cusick's promotion is a huge transition for him. He moves from supervising inmates to supervising fellow correction officers.

South Plainfield came out in force to support Cusick. Attending were his wife Monica and children Robert Jr., Shane, Garret and Gabriella, and many of his relatives. Mayor Dan Gallagher, Councilman Ed Kubala, State Assemblyman Patrick Diegnan, Police Chief Bob Merkler and a half dozen South Plainfield police officers also attended the ceremonies.

Cusick was sworn in by Middlesex County Clerk Elaine Flynn, who administered the oath to the eight officers being promoted. Also attending the ceremonies was Middlesex County Freeholder Chris Rafano.

The Middlesex County Correc-tional Facility houses 8,000 inmates, but they will soon be accepting federal prisoners and expect the number to increase to 10,000. According to Warden Abode, the facility capacity is about 12,000.

Continued from page 1 "Winston Man." Gurilitz described the tobacco company's goal of acquiring 3,000 new smokers every day to replace those who quit or died. The film stressed that ads often misled consumers by depicting glamorous people lounging in picture perfect settings, enjoying life with cigarettes in hand. Tobacco stained teeth and premature wrinkles are never shown. The threat of cancer is never mentioned and the ad often displays the life of a smoker as something to emulate.

Students were divided into groups They were given a cigarette ad and poster paper and asked to recreate an ad to represent real life. Toth said, "The kids never think of how smoking pumps chemicals into every part of your body. Smoking one pack of cigarettes a day for a year will leave a quart of tar in your lungs." She pointed out that the average age a child begins smoking is 10 or 11.

safety concerns.

"There is a 90% chance that a person who has not quit by age 20 will re-main a smoker for life. Nicotine is an addictive chemical just like a drug. It runs your life and uses up your money," Toth added.

Councilman Cerami, also a health educator, does legislative work. For the past two years he has worked with municipal governments to improve quality of life by helping them make ositive changes to local ordinances. Working to pass laws that forbid the sale of tobacco to minors, he also promotes the enforcement of smoke-free public environments.

One of his most successful projects s unveiled last summer when Alle Clark Sport Complex in South Amboy, which is used by little league teams, went completely smoke free.

Cerami notes that with South Amboy, Mayor Jack O'Leary and the council supporting the idea, other or-ganizations quickly joined the efforts.





Thank you Dr. May I'd just like to start out by saying good evening to everybody and Happy New Year! It's great to be here for a second time. I am going to give you an overview of what the freshman midterms will be like.

They start next Friday, Jan. 25 and take place on the following Monday, Tuesday, and Wednesday.

Next is Geometry. We've gone through four chapters and are midway through our fifth. However, the midterm only consists of Chapters 1-4, which will be mostly confusing long paragraph proofs, a lot of formulas and annoying equations. I think we'll be reviewing next week for that midterm

My last subject is Biology. We're on our 10th chapter. In Biology we copy a lot of notes and definitions, but once a week we have a lab, which is helpful in helping us better understand what were learning. We haven't begun reviewing yet, so I'm not sure exactly how many chapters will be on the midterm.

Good evening, citizens and members of the board. I would first like to

thank you for having me here tonight. As Dr. May has told you, my name is Christopher Baron and I'm here tonight representing the junior class, as the current vice-president of said class. First of all, I thought that it would be good to touch base on current happenings within the junior class.

Dr. May approached me concerning tonight's meeting and asked me if I could give everybody a brief synopsis of the material for this month's upcoming midterms, in order to give everybody an idea of the accumulative knowledge of the everyday high school junior within the first two marking periods.

In Chorus, under the guidance of Mr. Murray, we have been branching out into the musical world, studying and singing the works of great classi cal composers such as Rossini, while giving everybody a taste of holiday fun through things such as our long list of festive traveling choir selections. In doing this, we've also been covering the basic elements of music, such as dynamics and note duration. The midterms will consist of questions which will test our knowledge of the music we studied and sang and the fundamentals of music.

In Concert Band, under the guidance of Mr. Tweed, not only did we spend a large amount of time focus-ing on the key aspects of marching band, but we also spent time working on holiday-oriented music to provide entertainment to the people who came out to see our holiday concert. Also focusing on the fundamentals of music, next door, we've gone a little more in-depth, as we're also learning how to use a variety of musical instruments. We learn the ins and outs of our specific instruments in order to better ourselves as musicians. The midterm will be rather similar to the chorus midterm, in that it will test our knowledge of the music that we played, and the fundamentals of music

In U.S. History II, with Mr. Barca, we've covered a variety of different topics. Most recently we've moved through the Roaring Twenties and the depression, highlighting such presi-dents as Calvin Coolidge and Franklin D. Roosevelt. We are currently heading into the events surrounding World War II and we also studied the events surrounding World War I earlier in the year. Mr. Barca makes history make sense and come alive for students, as does the rest of our wonderful history department at the high school. Our midterm will probably revolve mostly around the first half of the 20th cen-

In English III, with Mrs. Pastula, we've had a well-rounded year so far. We've brushed up on a lot of grammar, done approximately six writing tasks and tackled some deep stories. These skills have provider for a wellbalanced experience, not only teaching us the curriculum, but also doing well to prepare us for future endeavors and testing such as the SAT's. Right now, we're tackling our first major work in MacBeth. My guess is that the midterm, like the course, will be very well-rounded.

Moving on to Pre-Calculus Honors, with Mrs. Kielblock, we've done a heavy review of Algebra II. in order to broaden our foundation for calculus. The midterm will most likely consist of much of the review, but we've also begun to investigate things such as the unit circle and basic trig identities. The thorough, yet time-efficient algebra review, consisted of mare concepts such as solvers equations' graphic in a variety of ways, and using the quadratic formula to solve equations.

In Acting and Theatre, an English elective taught by Mrs. Naso, we have been exploring the creative depths in-side ourselves. Whether it be staging an improvisational scene in front of the class, or studying the lost art forms of the renaissance age of theater, we get a real feel for how the dramatic world works in this class. In Physics honors, taught by Mr. Wendel, we've been tackling some interesting concepts involving motion. Motion and energy are astounding to me in the sense that they're the basis for all which happens in life. Without energy, nothing would occur. We've learned new ways to measure things such as velocity, acceleration, simple harmonic motion, and the list goes on. This midterm should be very well rounded, and include the concepts listed above, among several others.

Once again, I thank you for having me. I feel this is an enriching experience not only for the board and the people, but for myself, being able to speak publicly. Thank you.

said, I would like to talk about what my midterms will consist of and other Senior Midterms.

I take English IV with Miss Schoonover. This is a senior English class. Our mid-term will consist of vocabulary, roughly 100 words, grammar, short stories and questions on what we have read. Certain stories such as *Hamlet*, the Epic of Gilgamesh, Persian and Arabic Literature, Chinese Literature, and other forms of Cultural Reading.

I take Government Class, which is open to juniors and seniors. Our mid-

term will consist of the different forms of government, zoning and current events. We have had guest speakers come in and talk to us and the things that we learned from the speakers will be on the test.

One of my other classes is Office System. In this class, I work on the Yearbook and I am on the Yearbook Staff. We will also have a mid-term in the class and it will consist of using our imaginations. For everyone that thinks this might be an easy class, it can be hard for a lot of students that might not be as creative as others. On Jan. 11, they showed their competitiveness at the Ridgewood Games at FDU. Jeff Williams won the 600 in 1:29 and anchored a victorious 4*400 team. The Relay Team also consisted of Sean and Chris Grevious and Will Hamilton and ran 3:39. Chris Grevious took fifth in the 55 Dash as well. The 4*800 team of Tim Morgan, Kyle Kazmir, John Wiekowski and Rob Hoffman took fourth place.

On Jan. 15, the Tigers blew away rival Sayerville by a convincing score of 57-19. In the 55 Dash, Sean and Chris Grevious and T.K. Ahmed swept the event and Phil Thomas, Alan Dummett, and Chinny Okparakee and Ian Levine (tied for third) did the same for the 55 HH.

In the 1600, Tim Morgan took first and Galen Johnson third. In the 400, Jeff Williams took first as well with John Rayho, also at third.

In the 3200, Tim Morgan (clinch-ing a double victory), Galen Johnson and Calvin swept that event as well. In a fourth sweep, Kyle Kazmir, Ian Levine and John Wiekowski took all three places in the 800.

Then, the South Plainfield 4*400 team won their race. Lastly, in the high jump, Chris Grevious tied for first while Sean Grevious took third. Next, on Jan. 17, in a tri-meet, the
