escue Effort Saves Ducklings

South Plainfield Police Detectives Gary Kline and Jim Darby, and the Public Works Department, 10 ducklings and their mom were saved from

a tragic ending. Last Friday afternoon, Detective Darby was driving along Plainfield Ave. when he spotted a duck crossing the road. Fearing it would be run over, he stopped his car and tried to get the duck out of the roadway, but after several attempts at steering the duck to safety, he realized the duck would not cooperate!

South Plainfield resident Joan O'Brien happened to be walking by at that time and stopped to see what the commotion was all about. She heard a chirping sound coming out of the sewer and when she took a closer look into the sewer grate, she noticed several ducklings were swim-

mother-in-law, Jenny O'Brien, who had been walking ahead of her daughter-in-law, also came to the aid of the fledglings

Meanwhile, Detective Kline, who was now joined by Detective Darby, was desperately trying to keep the mother duck from being run over by the traffic on Plainfield Ave. He finally managed to get the duck off the road and onto a lawn of a nearby house. However, the mother duck was not at all complaisant and kept attempting to return to her stranded ducklings in the sewer.

A quick count from the gathering crowd established that at least eight ducklings were in the sewer pipes swimming back and forth on either side of the entrance of Lane Ave. A call for help to the Human Society was rejected. They would not get involved

with the rescue attempt.
Public Works was called in to help, and a crew arrived with a bar to open the sewer lid. Leon Mielnikiewicz and Victor Kurilew opened the sewer grill, crawled down into the sewer, lifted out the stranded ducklings and carefully placed them in an empty pail. They

High School 'Hall of Fame' Candidates Announced

Three former South Plainfield High School students have been named as this years candidates to the "Hall of Fame." They are Assemblyman Patrick Diegnan, Middlesex County Prosecutor Thomas J. Kapsak and Dr. Richard F. Veit, Jr.

The inductees will be honored on Tuesday, June 4 with a luncheon at the Holiday Inn, induction ceremonies take place at 7 p.m. that evening in South Plainfield High School's Jo-seph A. Mondoro Auditorium preceding the annual academic awards.

Assemblyman Patrick Diegnan is lifelong resident of South Plainfield. He attended Sacred Heart School, graduated South Plainfield High School in 1966 and attended Seton Hall University, majoring in Political Science/Government. He continued on with graduate studies, earning his Juris Doctorate in 1973.

Diegnan, a practicing attorney in the private sector for 28 years, is also Municipal Attorney for both South Plainfield and Milltown and serves as Labor Council to Middlesex County Vocational and Technical Institute. He also served as member of the South Plainfield Board of Adjustment, the Environmental Commission, the Senior Citizens Advisory Commission and the Sacred Heart Parish Council.

Diegnan has been active in many area organizations, serving as Democratic Municipal Chairman in South Plainfield and Council to the Middlesex County Democratic Organization. He taught law and accounting at Middlesex County College, served as Grievance Chairman for the Ameri-

Volunteer Litter Clean-up Bags Seven Tons of Borough Trash

The threat of rain did not deter nearly 100 Borough residents from turning out in force for the big spring cleanup on Saturday, April 20. Mayor Gallagher had proclaimed the week of April 20-27 as "Volunteer Litter Cleanup Week."

Saturday saw fifteen sites cleaned by service groups and individual residents. The Sacred Heart CCD class worked in vacant lots on Plainfield Ave. and Tompkins Ave. Twenty-two students from the High School cleaned up Spring Lake Park. Friends of the Woods cleaned the Cedar Brook streambed in Veterans Park. Boy Scout Troop 309 was scheduled to work with Eagle Scout Andrew Falocco on his Adopt-A-Spot on Lakeview Ave.

Two Elsie Ave. residents pulled litter and old bicycles from the Nature Reserve at the end of their street.

Councilman Cusick brought a crew from the County Work House to clean Metuchen Rd. and Garfield Ave. Six volunteers bagged shopping center litter that had blown onto the Borough's adjacent Oak Tree Open Space reforestation site on Park Ave.

Boy Scout Troop 124 cleaned up South Clinton Ave., as they do every year. Residents on Carmine Ave. cleaned a vacant lot there and both sides of New Market Ave.

Three residents attacked the plastic bottles and soda cans accumulating in the streambed crossing under Baker Ave. near Franklin School. Cub Scout Pack 324 returned to Putnam Park and filled four bags with litter there. And the Mayor and Council did their yearly cleanup of Belmont Ave.

Additional sites were cleaned during the week. Cub Scout Pack 202 could not make it on the 20th and scheduled their cleanup of the Community Pool parking lot for the 29th.

Daisy Troop 530 was scheduled to clean the Veterans Park Nature Trail on April 19.

The Home Depot was scheduled to work on the Adopt-A-Spot on Hamilton Blvd. on April 23. A group of eleven people from the Wesley Methodist Church came out on April 27 to pull litter and trash out of Willow Ave Park.

On April 26, the Keystone Community Residence worked on Kenneth Ave. and Duke Energy fielded thirty-four employees to tackle the illegal dumping on Coolidge Street. They filled 40 bags with litter and piled up 15 cubic yards of construction debris, car parts and other illegally dumped

The Road Department picked up the bagged trash during the week. Recyclable litter that the volunteers had separated from the trash was collected separately by Recycling Program employees. All told, volunteers removed an estimated seven tons of litter and trash.

Most of Saturday's workers returned to Borough Hall at noon for the annual 'Pickup Picnic.' The rain, which had held off until then, also showed up, so the Picnic moved indoors to the Court Room. Domino's Pizza donated discounted pies, A&P donated soda and Angelo's Ice Company donated ice for the tired, hungry and thirsty workers. A free raffle distributed environmentally friendly door prizes, such as canvas shopping bags, Clean Communities T-shirts, plants and tree saplings. Volunteers traded war stories. In addition to the construction debris, shopping carts and tires, one resident found a wallet, complete with credit cards and a driver's license intact, so she would be able to return it. Continued from page 1 rescued five ducklings rather quickly, but it took a little longer and some ingenuity to retrieve the last three.

South Plainfield Police Captain

South Plainfield Police Captain John Ferraro arrived to help out, as well as Officer Michael Redden, who directed traffic away from both the mother duck and the open sewers, while the rescue was taking place.

While the men were in the sewer making their rescue, a car pulled up and an unidentified man dropped off a duckling found a few blocks away. Shortly after that, Risoli Terrace resident Donna Alfono brought a duckling she too found in her backyard. In all, 10 ducklings were successfully rescued.

According to Alfono, the mother duck had emerged from the wooded area behind her house a few days earlier with 11 ducklings. She noticed that morning that the mother ducklings started to stray. She found two ducklings left behind and was caring for them, unfortunately one died. When a neighbor told her about the about the duckling rescue taking place, she immediately took the remaining duckling to reunite him with the mother duck.

The entire time the rescue was going on Detectives Kline, Darby and Officer Redden were kept busy try-

ing to corral the mother duck, which was flying back and forth across Plainfield Ave., still fretting about her ducklings.

When the ducklings were all safely recovered, the focus was put on apprehending the mother duck, who had no intention of cooperating. Each time anyone got close to her, she would fly or scuttle away. Eventually two employees from the Middlesex County Parks Department arrived with a cage and a net. After a few missed attempts they managed to each her.

The ducklings, along with their mother, were taken to Spring Lake Park where they were reunited, much to the delight of everyone involved, especially the mother duck.

No one could figure out how the ducklings got into the sewer or how long they were there down there before Det. Kline arrived on the scene.

Because Det. Kline decided to stop when he noticed the distressed duck, along with the assistance from the police, fire and public works employees and a group of caring residents, the ducklings were saved and reunited with their mom. Everyone involved in the rescue was delighted with the happy ending of the rescue efforts.
