Students Jump for Joy

Franklin School students are jumping for joy. Their recent Jump Rope For Heart' raised \$10,173 for the American Heart Association (AMA).

One hundred eighty students in kindergarten through fifth grade gathered pledges. On a warm sunny day after school they began to collect on those pledges by jumping rope. They jumped alone, in pairs and in long lines. They jumped fast and slow. Some were experts, while others struggled to complete two consecutive jumps.

Despite their different skill levels, the students all had the same goal, to help the AMA. Assisting them was gym teacher Bill Pavlak. Pavlak encouraged the jumpers, reminding them when to switch partners, as music blared from speakers. Fifteen teachers and 30 parents were on hand to assist and cheer on the youths. The PTA provided refreshments.

Former Franklin gym teacher Drew Smith got the school involved in this national program in 1994. Since then, Franklin students have raised over \$50,000. This year's contributions ranged from \$1 to \$1000 with the average contribution being \$15-\$35.

Borough **Hires CEO**

Borough resident Glenn Cullen has been hired as South Plainfield's new Chief Executive Officer (CEO). Cullen starts his job on May 24 at a salary of \$84.000.


Former Borough Administrator Frank DeRosa, also served as the Borough CEO. He resigned suddenly in March, but only recently resigned as CEO as of May 24.

Cullen comes to South Plainfield after serving as the director of Patient Finance at Hackettstown Community Hospital. He has spent the last seven years in the health care system, both managing and directing at hospitals ealth care facilities

Cullen graduated Middlesex County College in 1988 with a A.A.S. in Accounting, with honors. He attended Kean College and earned a B.S. in accounting and graduated Summa Cum Laude and he also attended Fairleigh Dickinson University earning his Masters in Business Administration in 1995.

According to Councilman Ed Kubala, Cullen will be coming on board just in time. The South Plainfield 2003 budget process is about to begin.

Kubala added that plans are on hold to hire a new borough administrator. He said that the workload can be handled between the new CEO and the Borough Clerk. If so, the Borough will not need to hire a new Borough Administrator. The Council will take a wait and see attitude for a while

It is the law in New Jersey that any contractor who is doing ANY electrical work must be licensed and have a business permit issued from the State of New Jersey. Municipalities in which the work is performed must also inspect the work. Any contractor who does electrical work and is not licensed, is doing so illegally and is violating the law. Violating this law is a felony crime of the fourth degree and may be punishable by a fine and/or imprisonment.



Continued from page 1 hound Friends, K-9 Care, TheraPet Inc. and Central Jersey Holistic Health Care. Inside the hospital Avian Wildlife Center and Snakes-n-Scales and Turtle Tails featured creatures that slither, crawl, swim and fly. Among them were an albino python, an alli gator, a milk snake and an owl. Sponsors for the event were Pharmacia,

Pfizer, Merial, Fort Dodge and Bayer. Dr. Richard Lunna opened the Plainfield Animal Hospital in 1952. He purchased the land for \$100 in 1951 and built the hospital for \$28,000. Dr. Leroy Roemer became his partner in the 60's. When Dr. Lunna left the practice in the early 70's, Dr. Andrew Major became partners with Dr. Roemer.

Dr. Scott Linick joined the staff in 1982 and when Dr. Roemer left, he became partners with Dr. Major. He bought Dr. Major's share in 1989 and is now the sole owner of the hospital. Dr. Linick recalls when Dr. Lunna used to describe the early days of the hospital.

In the 50's, South Plainfield was largely a farming community and most families owned goats. Most of the hospital's clients came from Plainfield and North Plainfield, which were considered wealthy communities at that time. On weekends, families from New York would travel to the Plainfield area to 'get away from the city' bringing their dogs and cats with them. Also helping to build clientele were the stay-at-home women of the era who bred dogs, creating a serious need for a veterinarian. Dr. Lunna spent many hours traveling to homes to whelp pups.

For the past 50 years the Plainfield Animal Hospital has been steadily growing. They are always striving to keep up with modern medical techniques, equipment and procedures and working to keep pets happy and






