I take this opportunity to share with you my beliefs in the role of school board members. We have an obligation to pursue, explore and exhaust all means to obtain our fair share of school aid to provide local taxpayers relief. Over a period of time working with our board I have suggested that we develop resolutions on certain issues and forward them to State and Federal legislatures requesting such

tricts, such as ours, eligible for state aid for construction projects was passed. When you voted for the referendum, you noted that we will receive approximately 6.6 million dollars as a result; (b) legislation we supported has been approved to provide additional state aid for special education costs over \$40,000; (c) worked with Congressman Ferguson, who sponsored legislation that increases IDEA fund-ing (Individual Disability Education Act) and additional federal dollars are included in the projected budget; (d) appealed to Commissioner of Education to release funds for new track at Jost Field-completed. We will pursue implementation of "State Mandate-State Pay" law. If legislature mandates additional educational programs, they must provide funding. We should and will continue to work with the legislature to get our fair share of state aid. The obligation of board members goes beyond attending two meetings a month. We have standing commit-

tees for curriculum-technology, personnel, policy, public relations, transportation, finance and negotiations. Board members assigned to these committees should take an active role by regular attendance and active participation. Some examples of issues they work on are to insure that curricula have been approved, investments made in technology and in-service training expenditures for teacher training are implemented in the class-room to produce desired results and are applied as approved and intended. We have administrators to manage these programs, but there should be vehicles in place to insure progress, accountability, consistent and continuing implementation, review and measured results commensurate with investments made by you, the taxpayer. An ad-hoc committee monitors our construction projects which are ahead of schedule and below estimates.

Board members, in my opinion, should not seek or accept endorsements of special interest groups. Individuals should be free to make judgment and decisions without pressure from such groups, but be free to act in the best interest of students and tax-

These are the issues that guide me as I seek your support and to vote Line 4. I pledge that I will work in the best interest of students (customers) and you the taxpayer, together with our superintendent, administrators and staff to produce the best educational results possible.

I also ask you to support Jeff Seider, Line 1. He previously served as a board member, but more impressively he served as chair of personnel, buildings and grounds, curriculum, transportation, special education and construction. He performed these responsibilities objectively and in the best interest of students and taxpayers. The time and effort he devoted should serve as an inspiration to others.

There are three other candidates One person is presently a board member seeking re-election. The other two are running for the first time. When they attended board meetings and spoke on issues, whose interest did they represent? Was it the students and taxpayers or their own personal self

A lone desk clerk was approached by two men, one brandishing a black revolver, who vaulted the counter and demanded money from the desk clerk. 

WHEREAS, in accordance with PL. 1991, c. 229, the Borough of South Plainfield, in the County of Middlesex, State of New Jersey (the TBorough') adopted an early retirement incentive program for eligible employees covered by the Public Employees' Retirement System ("PERS"), as applicable; and





session and discuss personnel, negotiations and any legal matters which must by law be discussed in private. No action is taken at this meeting unless the public is notified by newspaper, radio and building posting. Usually the public does not attend this meeting as much of the meeting is held in executive session and when we return to public we simply accept the agenda for the next week.

The regular public meetings are held the third Tuesday of each month. I have been a member of this board for five years. If an executive session is necessary it is held at the end of the meeting with only two exceptions that I can recall in which the board had to meet for no more than 15 minutes because it was an action item on our agenda and a member of the board requested clarification before voting. Mr. English implies that we go into executive session and leave the public waiting for hours. How he can write this while not attending meetings is beyond my understanding. Usually before any business takes place we hear from our student representatives and use a portion of the beginning of the meeting to recognize staff. The public is invited to discuss any agenda item prior to our vote. At the end of the meeting the public is invited to discuss any concern. Unlike other board's of education, we do not impose time restraints on how long we will listen to one subject. We have been criticized for allowing members of the public to spend a good portion of time on one subject, but the board has always allowed all who wish to speak to speak freely. Some may feel frustrated that individual board members do not respond to public comment, but any one familiar with Robert's Rules of Order (as Mr. English is, a former council member and mayor), would realize all comments to and from the board are through the chair.

The reason I am so upset by this arbitrary comment is that I know the members of the board are very conscious about the public's opportunity to be participants of the process. In fact, this is why our curriculum committee meetings are committee of the whole meetings open and attended by many parents and staff members in the district. It is also interesting that Mike mentioned the grading procedure. For three years this has come up in the curriculum committee at least once a year. There has been resistance at both the high school administration and staff levels, and we have been unable to move this forward. There was a ray of hope last week when it was reported that this is now in policy; hopefully we will see this moved in a way that helps our students positively. Mr. English's views would have been welcomed during the many discussions. As a former member of the staff I am sure his views would be welcomed in other areas of curriculum and instruction. For example, despite over one hundred thousand dollars of staff development costs last year and thousands of dollars spent in programs and curriculum, how do we translate this to student performance? Perhaps Mr. English, as a former member of our staff, could help the board understand despite the resources and the lack of

micromanagement and staff mentoring programs, our students still score w overall in standardized tests-ESPA, GEPA, HSPT(A) or SAT, etc.

The accusation of micromanagement is also amusing as all administrators in this district know that board members are not in and out of the buildings without invitation. I know of no board member who has directed any person other than the superinten-

A board member has a responsibility to the community to represent the interests of all, not just a special interest group. Our most important constituency is the 3,800 students and the taxpayers. It is the responsibility of each member to attend all meetings, not just public meetings. I and other members of the board are currently juggling up to five committee meetings because Mrs. Peck and Mr. Bohn attend none. It is unfair to the other members of the board who carry the additional load of extra committee meetings, and it is unfair to those we represent to not fulfill our obligations as elected officials.

I will close by asking you to support those who would take that responsibility seriously. They will represent the interests of children and taxpayers first, and they will, as they have in the past, attend the meetings and participate fully. Do not allow special interest groups to control your tax dollars or your child's education. Support Jeff Seider, Line 1 and Frank Mikorski, Line 4. Each has a proven record of putting children and taxpayers first. Remember, "birds of a feather flock together."


Now, let's clear up a common myth. And, unlike videotapes, the discs can't simply be repaired; usually, an unplayable disc must be discarded. While the demand for these discs, particularly DVDs, is high, we just don't have the cash to replace every disc that gets broken. So, if you want us to be able to afford to purchase new DVDs, treat them with care and don't abuse them (like using them as coasters, for example).
