Tigers' Hopes Squashed Gulf Station Robbed

Fans rally, but team falls hard to North Plainfield rivals

Not since the Capulets and Montagues has there been such a bloodfeud as when the South Plainfield High School Tigers and the North Plainfield High School Canucks took to the field on Thanksgiving Day. The old-new Thanksgiving football tradition did indeed continue. The second annual return of this Thanksgiving rivalry is a sorely missed SPHS favor-ite for alumni and a new experience for others. The decades-old tradition came to an end in the eighties.

The festivities began on Wednesday evening with the prerequisite pep rally. The gym was transformed into a shrine for the Tigers. Green and white streamers and balloons filled the air; colorful banners and post-ers covered a portion of the upper bleachers. Enthusiastic cheerleaders, football players, color guard and the Tiger Marching Band were joined by a crowd of boisterous spectators, students, teachers, parents and diehard Tiger fans from years gone by.

School spirit seemed to become a living

The SPHS color guard strutted their stuff, expertly tossing and twirling flags and rifles in time to the upbeat rhythm. Cheerleaders' en-

ergetic chants, second only to the applause, filled the room. Football players, color guard and cheerleaders were introduced with kudos going to senior members. When the energy and decibel level reached a near frenzy, the crowd was led outside for

Thanksgiving morning dawned bright and sunny. Unlike last year's frigid temperatures, it was a perfect day for a football game. Follow-ing the tradition to alternate home fields, the game was played at North Plainfield's Kraus field. The coin toss was performed by the school's respective homecoming Royalty.

The Tigers roared up and down the field, fighting and charging with the tenacity of their ferocious feline namesake. Despite their tremendous efforts, the game went to the Canucks. With a casual bravado, Tiger fans describe the game as a "close one," with a final score of 14-44.

The return of the South versus North tradition was not without a glitch or two. It also brought the return of a negative tradition, pranks against the opposing school. During the game, North Plainfield cheerleaders reportedly tore the tiger mascot's costume, bent several color guard flag poles and removed several cheerleader megaphones and pom poms.

Athletic Director Mike Buggey noted while the pranks were minor, they took away from the spirit of the day. Pranks such as these are the only thing that mar the rivalry.



To the Editor,

In the Nov. 14, 2003 "In your Opinion" column of the Observer, the author of the letter wrote: "The Board of Education is made up of people who spend long hours doing the more or less thankless job of trying to make sure that the children of South Plainfield receive the best education possible."

On Oct. 3, 2003 the School Board Briefs column of the Observer announced that the Board of Education approved appointments. The only requirement for one of the positions, it appears, was to be the wife of a Board of Education member. Was this Board decision made because it was in the best interest of the children?

The majority of the current Board consists of people supported by the South Plainfield Education Association (SPEA).

For this support, the union expects to get more money for less work. And the Board delivers, giving away raises of 4.9%, 4.5% and 4.45% for the next three years. On top of that, the teachers will continue to receive free

medical, dental and prescription care. The current USA yearly inflation rate is 2.1%. The average USA salary raise for the last 12 months is 3.8%, with even lower raises contained in contracts recently signed. Seventyeight percent of people employed in the U.S. are lucky enough to participate in their employer's sponsored health insurance plan contribute to their health care cost on average \$2,676 yearly for family coverage.

After approving the above-mentioned unjustified raises, a Board member exclaimed that the raises are average for Middlesex County, "not above it or below it. I believe that this contract is an agreement of mutual respect, between Board of Education and South Plainfield Education Association.

This is an astonishing statement. Let's look at it closely.

If the whole justification of South

Plainfield teacher's raises is the Middlesex County average raise, then the question is: what is the Middlesex County teacher's role on the South Plainfield Board?

The second part of the statement talks about mutual respect.

The Board member did not disclose on what this mutual respect is based. Usually respect has to be earned. Cer-

tainly the results of SPEA work are anything but respectable

These results, for school year 2001-2002, are below.

In the South Plainfield School District the average SAT result was 973, while the median teacher's salary was \$63,978.

In comparison, New Jersey districts with population of the same socioeconomic status as South Plainfield averaged 1,030 in SAT scores.

Statewide averages were 1,009 in SAT scores and median teacher's salary was \$50,147.

By applying the irresistible logic of averages as expressed by the Board member, it is clear how ridiculously overpaid South Plainfield teachers are. It is even more glaring when the results of their efforts are taken into

Senate Committee Advances Bill Making Video Voyeurism a Crime

Legislation sponsored by Senator Barbara Buono and John H. Adler that would make video voyeurism a crime in New Jersey was unanimously approved today by the Senate Judiciary Committee.

"This issue is about a person's fundamental right to privacy," said Senator Barbara Buono, D-Middlesex. "I can think of few crimes which violate this right more than the crime of video voyeurism. This growing national crime represents an instance in which current law hasn't kept pace with advances in technology. We need to change that in New Jersey."

Video voyeurism is the practice of filming or photographing someone without their knowledge for the pur-pose of sexual gratification, when the person being filmed has a reasonable expectation of privacy. The senators' measure, S-2366, seeks to address the growing national problem of video voyeurism by bringing antiquated state voveurism laws into line with modern technology.

Currently, it is not illegal in New Iersey to film others without their knowledge. The bill would make video voyeurism a crime of the third degree in New Jersey, punishable by three to five years imprisonment and up to \$15,000 in fines.
"Video voyeurs rob their victims

of privacy, security and human dignity and yet we can only prosecute them for trespassing," said Senator Buono. "These voyeurs don't just strike once-their video recordings can be watched over and over again and disseminated worldwide via the Internet.'

The bill now awaits consideration by the full Senate.



Be Prepared, Part II...

Advance Directives in Health Care

Durable Power of Attorney, a legal document that deals with control over financial and legal matters. But how can you plan for and help others plan for your life, healthcare matters and destiny? What happens if serious illness or permanent loss of mental capacity leaves you incapable of talking with you doctor and deciding what medical treatment you want? For these vital life decisions, it is important that you create "Advance Directives in Health Care," namely, a Living Will and a Health Care Proxy or Medical Power of Attorney. These documents let you give instructions about the medical care you want to receive in the event that you become incapacitated. A properly prepared Advance Directives permits you to plan ahead so you can both make your wishes known and select someone who will see to it that your wishes are followed.

A Living Will is used to spell out how you feel about your medical destiny. The Living Will is a declaration giving specific instructions regarding the provision, withholding or withdrawal of treatment to keep you alive as well as the provision of pain relief. It also lets you express your intention to donate bodily organs and tissue following your death.

Your Living Will should be signed by you and two witnesses (who may be family members). You should chose as your witnesses two people who are aware of your wishes and the quality of life issues that are important to you. Several people should be given copies of your Living Will, your spouse and/ or your children and your physician. Be aware that your wishes may not necessarily be the same as family members-you should try to avoid disagreements among your children by carefully spelling out your wishes in a Living Will. In the case of your physician, have an original copy of your Living Will made a part of your medical record so that it is clear to your

health care providers what your wishes are.

Others types of medical issues may arise which are outside the area of life support and organ donations, but would require the designation of an "agent" to oversee medical decisions for you. Who will step in in those cases if you become incapacitated? A Health Care Proxy or Medical Power of Attorney is a way to delegate your health care decision-making to another person in the event you become unable to make those decisions yourself. A Health Care Proxy covers all types of medical decisions, including changing medications, experimental treatments, surgical procedures, changing physicians and transferring between facilities.

You should choose someone who you trust, someone who knows your wishes with regard to medical treatment and concerns and understands what is important to you. Your proxy, or "agent" should live close by or be able to travel to be by your side. He or she should be someone who can handle the responsibility involved in acting as your agent and be able to handle possible conflicting opinions between family members, friends and medical personnel. Your proxy must be a strong advocate for your wishes. Keep in mind that as long as you are able to understand and communicate your own wishes, your agent cannot override what you want. Your agent steps in only if you can no longer manage on your own.

Advance preparation and recording your decisions regarding your health care are an important part of Estate Planning. Ultimately, the decisions come down to you. Take good care of yourself.
