
5 alumni Remember When

Join us for a flashback when ice skating was part of winter recreation at Spring Lake in South Plainfield.

The "Spring Lake" referred to in the following collection of stories no longer exists. In its place is Spring Lake Park, which was renovated in the 1980's. The original lake was larger and very shallow. The present firehouse did not exist; instead the fire department was housed next door to South Plainfield Liquors. The White Star Diner was a small store called Stella and Tom's, a favorite stop for youths. The overpass had not yet been built, and Lakeview Ave. dead ended not far from the railroad tracks.

When we asked people about South Plainfield winters of long ago, many SPHS graduates volunteered a myriad of memories. Just about everyone remembered the mountain of shoes that could be found near the fenced-in water company property. Most nights a bonfire lit the area, warming the chilled skaters. Just a few yards away the land sloped downward to the lake's edge. There was no gazebo, no flag pole, no sidewalks nor grass. This area was once part of the

Council Considers Parking Bans during Snowstorms Councilman Bob Cusick is asking the council to consider two proposed

ordinances which will ban parking on designated streets in the Borough during snowstorms.

Cusick said it will help plows to clear streets more quickly, and leave the roads cleaner. He said that many times a plow will go down a street, clear it and then residents come out to shovel out their cars only to call the Department of Public Works and say the street hasn't been plowed.

Mayor Gallagher said that a complete ban on parking would not be a viable since there are many areas in the borough where the only parking available is on the street.

Members were asked to offer their input on the proposed ban on parking and to give their suggestions to Councilman Cusick.

Many towns in the area ban parking on all streets during snowstorms, and institute penalties, including be fines and, in some cases, towing.

I thank God everyday that she has the ability to run, jump and walk straight without severe pain or even collapsing and I will continue to pray everyday that she does not get the same crippling disease that I have.

I will be showing your article to everyone I know to remind them of how some people see a picture and paint it differently. As the saying goes, "Don't judge a book from it's cover." THANK YOU.

A CHEERLEADER'S MOM WHO IS A LEGITIMATE HC TAG/PLATE OWNER

Dear Representative Ferguson,

I was annoyed by your recent mailing celebrating the addition of prescription drug benefits to the Medicare program. I am retired with a modest pension and my wife is a part time social worker. I calculate that we pay about \$1 out of every \$40 million that the federal government spends (about typical for those in our circumstances), so since this program's estimated cost is at least \$400 billion over the next 10 years, it will cost us \$1,000 or more every year, even if we don't participate. If we do, we'll each pay an additional \$420 in fees, plus a \$250 deductible for limited coverage. My present Medicare supplemental policy only costs me \$62 per month for everything Medicare doesn't cover, with my prescription drug costs limited to a \$28 or \$56 annual co-pay per item. I have active lung cancer; one of my drugs covered by this plan costs \$1,800 per month, so under the 75% Medicare plan, this one prescription would cost me \$450 per month!

Even worse, after surgery, radiation and three courses of chemotherapy, my disease was continuing to progress and my oncologists had nothing else promising to offer. Therefore, over two years ago I started with an alternative medicine doctor whose non-prescription program has substantially reduced

further tumor progression. The bad news is that this costs us about \$2,000 per month, which is not covered by either my Medicare supplement or the new Medicare addition, so we have to consume savings and investments to pay for it.

Therefore, from my perspective, the Medicare drug coverage addition does absolutely nothing for us, but yet costs us at least \$1,000 per year. It seems to be most beneficial to the drug and insurance companies instead of to seniors, so I wonder why you were so enthusiastic about it.

Notes From The Senior Center Identity Theft Not Just Internet Issue

We are hearing more and more these days about Identity Theft. There's a TV commercial airing in which an elderly lady is speaking in a biker's voice and talking about all the great things he bought using the lady's stolen credit card number. I thought the commercial was funny until last week, when I got a call from my credit card company checking on a number of suspicious charges made in one day. Turned out that someone got a hold of my credit card number and charged over \$12,000 in goods and services. The Fraud Dept. representative asked if I had my credit card in my possession (which I did). She reviewed all the purchases made the past few weeks and we were able to pinpoint when the fraudulent purchases started. A full investigation is in progress and fortunately, my credit card company is not holding me responsible for the charges.

The point of my story is that no matter how careful you think you are with your confidential information, there are people out there who are so skilled at identity theft that you don't know they even hit you. These thieves use a variety of methods, both low and high tech, to gain access to your personal data. Here are a few of the methods they use: stealing bank and credit card statements and pre-approved

credit offers from your mailbox, rummaging through trash for improperly discarded bills and other personal information and completing a change of address form to have your mail sent to another location.

With this stolen financial knowledge, thieves can open bank accounts in your name and write bad checks; call your bank pretending to be you and ask to change the mailing address on your account and open a new credit card account or take out loans using your name, date of birth, social security number, etc.

So what can you do to protect yourself from these unscrupulous thieves? Here are a few suggestions: Order a copy of your credit report once a year and review it for incorrect or false information; purchase an inexpensive shredder to destroy documents before you put them in the trash; don't leave outgoing mail with paid bills and checks in your mailbox for the mailman to pick up-always use the post office or postal mailbox; do not give out any personal information over the phone or internet unless you have initiated contact or you know who you are dealing with; call the bank or credit card company if you notice a missing bill or bank statement; pay attention to your regular statement and billing cycles and consider Direct Deposit.

Jo Anne Kaschak-Catelli, Toms River, NJ, class of 1972 remembers her aunt, Diane Pellegrino-Heaslip, taking her skating at night. She said, "I was the 'end of the whip.' A whole gang of skaters would build up speed and then let go of my hand. I had quite a bunch of black and blue marks!"

Linda (McAllister) Gimnich SPHS class of 1966 has a lot of memories. Reminiscing she said, "Growing up across the street on Lane Ave., we always thought Spring Lake belonged to us personally! It was basically a swamp with a lot of reeds sticking out. These were real 'skate stoppers' especially when you were skating in the evening with no lights." Her brother Joe, SPHS class of 1967 and his friends loved the lake all year long and always found something to do there. Linda, remembers, "Their passion was playing ice hockey. They regularly fell through when the ice got too thin. Joe was always coming home with his pants wet up to the knees. My brother died last year, but my mom and I still remember two of the youths he played

She said "There were bonfires at night and it seemed like the lake was frozen all winter. I also used to ice skate on the pond next to the Conroy's Funeral Home, where Borough Hall is now located. It was a perfect place to ice skate." She recalls that as a kid, her husband Bobby class of 1971, used to skate through the channels to Cedarbrook Park. She says that learned how to skate by putting a chair on the lake and pushing it.

Lyn (Loveland) Carlton, class of 1966 remembers that the Plainfield Country Club was a friendlier place — no fences, no trespassing signs. Since we lived on West Golf, parking wasn't a problem, but by the time we walked the three blocks to the golf course with our wooden sleds, we didn't have a whole lot of energy for too many rides down the hill."

Joanne (D'Alessio) Otlowski class of 1968 said, "I loved to watch people skating. The fire department use to light up the area at night. I remember using the frozen lake as a short cut to the high school during the winter. I also remember people falling in and having to call home for dry clothes! When we first moved to Joan St., Cotton Street Park wasn't there. It was a wooded/swamp area. There was a large pond and the neighborhood kids would go there and slide around since most of us couldn't afford ice skates."

Sandy Spisso 1969 remembers going to the Plainfield Country Club and sleigh riding right onto the street. If you weren't lucky you would veer off to the left into a big ditch. I remember meeting all my friends and sitting around bon fires to keep warm."

Emergency Respondents Brave Elements in Ice Rescue Exercise

Residents driving by Spring Lake Park on Sunday, Jan. 25 may have noticed the fire department on the ice hauling people out of a huge hole in the lake, but it wasn't an actual emergency, rather a practice.

A total of 38 members of the South Plainfield Fire Department, Rescue Squad and Police Department participated in the ice rescue exercise. This was the first ice rescue class held in South Plainfield, but Fire Chief Larry Del Negro hopes it will become an annual event. Those who participated in the class received certification in one of three categories: operations, awareness or technical. The fire department has acquired new equipment for ice rescue and this training is necessary for the volunteers.

The training began on Saturday with an eight-hour class at the Senior Center, and continued with the five-hour training session on Spring Lake. The temperature was 20° with a wind chill factor of zero.

Due to the extremely cold weather, the lake was frozen solid, which doesn't happen very often. It took while for a chainsaw to cut away the ice because it was so thick. A good size hole had to be cut so the class could perform several types of rescue. Some of the class members wore special suits and actually got into the water to simulate
