Boyles Named Citizens of Year

Elks Honor Couple for Longtime Volunteerism

South Plainfield residents Bob and Debbie Boyle were recently named Elks Citizens of the Year by Lodge #2298. The Boyles, along with winners from seven other area Elks lodges, were honored in a ceremony which took place at the Edison Elks. The awards were presented by South Plainfield Elks member Pete Smith.

Bob was raised in South Plainfield

and attended Sacred Heart School and St. Pius High School. His parents, James and Doris Boyle, were life-long residents of town. He graduated from Kean College with a BA in business and is vice president at Roma Food, located on St. Nicholas Ave. Debbie attended school in Colts Neck and graduated from Brookdale College with a degree in computer/engineering. The Boyles lived in Howell before moving back

to South Plainfield six years ago.

The Boyles are well known for their support of many local youth organizations, generously donating both their time and money. Debbie chairs numerous committees at the Ponytail Parents Association and at Riley School. Bob coaches at the Jr. Baseball Complex and they both volunteer with the Pop Warner Football, Jr. Baseball and South Plainfield High School Boosters Clubs.

Five years ago they formed the Boyle Memorial Foundation to honor Bob's parents, who were involved in many youth activities. Through the foundation they have made donations to Riley School to purchase books for their library, donated a batting cage to the Jr. Baseball Club and donated the first electric score board and sound system to the Ponytail Parents Association at the Pitt Street complex.

Every year the Boyles donate \$10,000 in scholarships to South Plainfield High School and Sacred Heart Elementary School. They also purchased signs in the name of the Boyle Memorial and Roma Food which can be found at the Jr. Baseball complex, Ponytail fields and the Kenneth Ave. football and soccer complex.

Their names are consistently found in add booklets for youth organizations throughout town. Bob has also donated food to help many organization fundraisers. For example, just recently he made a food donation towards the Boy Scout Troop 207 Chili Fest. Debbie has chaired the Ponytail Association Art Auction for the past two years and will chair the upcoming art auction for the Jr. Baseball Club. Each year Bob sponsors a golf outing to help raise funds for the Boyle Foundation.

Debbie said, "We were honored and privileged to receive the Citizens of the Year Award from a prestigious organization like the Elks. We are proud to be able to volunteer and donate to worthy causes to benefit the people of South Plainfield."

SINDOOR Products May Contain Lead

Information has been received from The New Jersey Poison Information & Education System (NJPIES) that a 13 month old child from Woodbridge, was diagnosed with lead poisoning. It was determined that a product called "SINDOOR" was being added to their food as a food coloring. Analysis of this product revealed that it was nearly pure lead.

Based on these findings, Freeholder John Pulomena, Chairman of the Public Health and Education Committee of the Middlesex County Board of Chosen Freeholders, along with NJPIES, and the Woodbridge Health

Department Nursing and Environmental Divisions are urging that this product and similar products NOT be added to food.

Pulomena stated, "Children under the age of six, especially infants are most affected by lead poisoning. If you think or know that you or someone in your family has used SINDOOR in food please contact your doctor."

Dear Editor:

We were greatly disappointed when the Middlesex Water Company announced last week at a public hearing that it had petitioned the state Board of Public Utilities for permission to raise its water rates by 17 percent for residential consumers. Even more disturbing, it asked for a 31 percent increase on municipalities.

The company claimed that rate hikes were necessary to cover its recent capital investment project and other expenses. We think otherwise. Raising water rates this high merely shifts the financial losses of their company onto our already weary citizens. To make them bear the burden of the water company's new \$10 million facility is both unreasonable and unfair.

The Ratepayer Advocate, a state agency mandated to represent ratepayers in cases where a utility seeks to change their rates or services, was also concerned about the requested increase. Debra Robinson, assistant deputy ratepayer advocate, expressed serious concern whether the data supporting this proposed rate increase is complete, consistent and accurate. In other words, is it necessary to raise the rates this much? The answer is a resounding "no".

Sadly, the water company's plan will inflict financial harm on nearly 59,000 residents from Metuchen, Woodbridge, Carteret and parts of Edison, South Plainfield and Clark.

Consumers are not the only ones that will struggle if this proposed increase is adopted. Municipalities, already struggling to offer property tax relief, will be forced to find additional revenue to pay for the increased water costs that will be accrued by its hard working fire departments. In turn, they will have only one recourse to cover these costs — the taxpayers.

If the Middlesex Water Company is worried about its rising costs, then it should start by making the appropriate cuts to its own budget, not gouging Middlesex county residents with unnecessary costs.

To the Editor,

Mayor Gallagher's complaints to the *New York Times* stating that "our old Victorians on large lots are being torn down and replaced by six large new homes" and "traffic is increasing" prompted me to write this letter and give Mayor Gallagher an opportunity to prevent exactly that from happening again.

I have a copy of a letter from Eastern States Environmental Associates, Inc., written on behalf of their client, Northeast Developers, Inc., 727 New Durham Road, Edison, NJ 08817 (many of you know the officers/owners of this corporation) and mailed to all homeowners within 150 feet of the property at 419 and 501 Sampton Avenue. This contractor (Northeast Developers) hired the environmental company to submit an "application for a permit of approval to the New Jersey Department of Environmental Protection (NJDEP) for the purpose of establishing the boundary of freshwater wetlands" on the above mentioned properties. This contractor is anticipating approval to build 16 new homes on this land that is currently occupied by only TWO homes. For the purpose of the readers' point of reference, 491 and 501 Sampton Avenue are set back a considerable distance from the road and located between Fred Allen Drive and Martin Drive. This property goes all the way back to Green Acres land near the railroad tracks and runs along the backyards of homes on Schillaci Lane, which is the "left half of the Fred Allen Drive circle."

If this site is developed as planned, our community will have to tolerate an increase of traffic by at least 32 more vehicles and in all probability, a minimum of 16 more students in our schools. Calculated using the national average of 2.5 children per family, the student population will increase by 40. That will mean two more classrooms.

My neighbors on Schillaci Lane enjoy wooded privacy and the pleasure of watching deer, rabbits, chip monks and a variety of birds go about their

daily activities. Some neighbors also enjoy feeding these animals, all of which will have to find somewhere to go if bulldozers destroy their natural environment. Included in this menagerie are "not so cute rodents" that will be looking for new places to reside too. Also, Schillaci Lane and Fred Allen Drive are designated flood zones; can environmental engineers accurately predict the result of disturbing the underground water tables?

A copy of the application made by Eastern States Environmental for Northeast Developers is on file at our municipal clerk's office for anyone who would like to inspect it. I'm hoping that Northeast Developers won't get the approval they're looking for, but as a precaution this letter is to serve notice to our community that more construction is in the early planning stages. I'm also asking and expecting Mayor Gallagher and our "single party governing body" to do whatever it takes to prevent more traffic on our roads, more students entering our schools and the destruction of what little wooded land and natural habitat we have left in this town.

If you are interested in joining the South Plainfield Community Pool this year, the last day to take advantage of the Early Bird Discount and save up to \$30 is Friday, April 16.

This year the pool will have a state-of-the-art liner installed. According to Councilman Raymond Petronko, with the new liner in place, the pool water will be much warmer. As the

pool has aged, a few leaks have been formed, making it necessary to frequently add water. The water comes from a well and is very cold.

The installation of the new liner should alleviate these problems, and the pool will be warmer. Additional shade will be provided in the sunny area of the pool through the use of umbrellas.

As has been the policy in the past, photo identification cards must be presented at the desk when entering the pool. Fees are not refundable. Guest pass books contain 10 daily passes and may be purchased by members for a fee of \$50. There is a limit

of one book per month. Swimming lessons for all ages are available. They are 30-minutes long and run for two weeks. Fees for lessons are \$10 for members and \$60 for non-members. Swim lessons are non-refundable.

From June 5 until June 20 the pool will be open on Saturdays from 10 a.m. to 8 p.m., Sundays noon to 8 p.m. and Monday through Friday from 4 p.m. to 8 p.m. Beginning on June 21 the pool will be open Monday through Friday noon to 8:30 p.m., Saturdays 10 a.m. to 8 p.m. and Sunday noon to 8 p.m. The pool will close on Sept. 6.

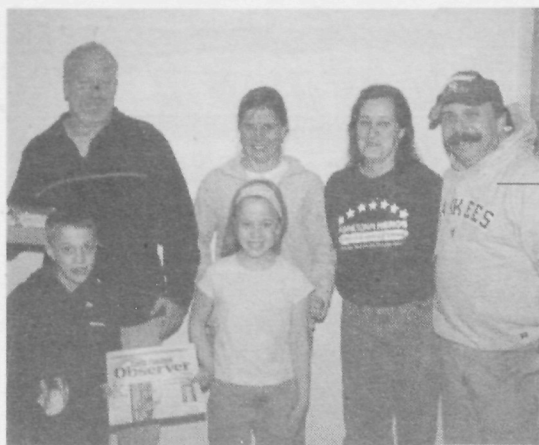

In the Junior division we had Ryan Sacco (75), John Wylam (85), Mike Wagner (105) and Nick Vallone (112). Intermediate qualifiers were Nick Veruschi (95), Nick Pauls (85) and Danny Pompillio (112). High School Cadet was Robert Gentile (94).
