The Summer Drama Workshop cast has been hard at work for many weeks perfecting the well-known musical. The show would not be complete without the work of many behind-the-scenes people who see to details such as props, sets, costumes and much more.

The cast's performance is enhanced by the educational theater workshops held by the staff throughout the summer.

The 33rd annual South Plainfield Summer Drama Workshop's production is a must see for anyone who loves theater. The story opens aboard the vessel of the famous, or is that infamous... *Pirates of Penzance*. Pirate apprentice Frederic is about to come of age. He has been mistakenly apprenticed as a pirate instead of a pilot by his nursemaid Ruth. On the hour of his twenty-first birthday he informs the

Pirate King that he will take leave of the pirates to become a law abiding citizen. He warns them that he plans to bring them to justice. When he leaves the ship with Ruth he finds a bevy of beautiful women on shore. It is his first glimpse of a female other than Ruth and he discovers that Ruth is not as beautiful as she has led him believe, instead she is plain and old.

In his quest to find a woman, Frederic meets Mabel, one of Major-General Stanley's many daughters. The Major arrives in time to find pirates ready to abscond with his daughters. Frederic plans to lead a band of Keystone Cop-type police officers and their sergeant to the pirates. But before he carries out his plan, Ruth and the Pirate King seek out Frederic to inform him that due to his leap year birthday he is not 21 but a boy of five, thereby keeping him a pirate apprentice until his actual twenty-first birthday.

Dear Editor,

Once again we must read the "so called" research of Mr. Fryszczyn concerning the teachers of South Plainfield. As a teacher of 35 years in Plainfield, I can honestly say that the SAT scores of 17- or 18-year-olds have no effect on the teaching abilities of the same people years later. I believe this holds true for many other professions as well. Incoming freshmen at the College of New Jersey (formerly Trenton State College) average 1200 on their SAT scores. My research is what I have observed over the last 35 years. Some of our greatest teachers in the state of New Jersey fall into this category. All teachers in New Jersey must complete 100 hours every five years in professional development and continuing education. Very few other professions put this time limit and hour requirement on their members.

To be a teacher is to love the art of teaching and getting your ideas across. That is the problem today with the writers of the "No Child Left Behind Act." Instead of teaching children, these "experts" prefer you to teach to the test. Also to equate data "of mostly tenured staff of economic departments of major universities" to public school teachers is mixing apples and oranges. All teachers in this country as per NCLB must be highly qualified either by course work, experience or passing rigorous tests.

If Mr. Fryszczyn is so "disgusted" with the South Plainfield teaching staff, then I challenge him. Call Dr. Rosado and ask if you could volunteer your time for a week or two in one of the classes, perhaps one of the more challenging classes, where your "expertise" could be used to motivate and bring up test results. At the end of the week(s), let's look at the test results of the students you taught.

By the way, I don't understand the concerns of Mr. Fryszczyn when his children don't attend the South Plainfield Public Schools.

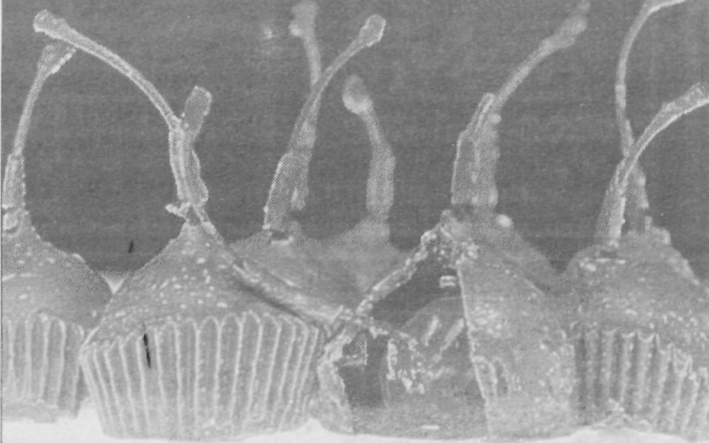
If you are interested in assisting your neighbors by responding to fires, offering mental health coun-

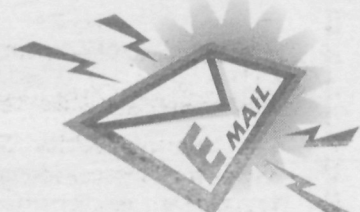

History Program of Lenape Indians at Library

The "Lenape (len-AH-pay) Lifeways" program presented at South Plainfield Library on July 19 gave audience members a close up look at the Native Americans who lived in the region long before the first European settlers arrived. The program focused on the Lenape lifestyle.

John Kraft, director of Lenape Lifeways Inc., began by explaining the vast area that was Lenape. They lived in "Lenapehoking", which translates to "Land of the Lenape." This encompassed all of what is now New Jersey, eastern Pennsylvania, southeastern New York state, northern Delaware and a small part of southeastern Connecticut.

Kraft started off the evening by allowing youths to examine the handmade items used by Lenape in their daily lives. The formal presentation took the form of a slide show that Kraft said was geared for the adults

but captured the attention of all attending. When the lights came up Kraft expanded on much of the information covered. He stressed the importance of the family unit to the youths and explained the three clans of the Lenape, the wolf, turtle and turkey, traced through the female line.

Kraft explained the importance and duties of each member of the family. The youths were amazed to find that these people created almost everything they needed from the resources surrounding them. From clay cookware, to woven mats, baskets, masks, dolls and even a version of today's baby slings to clothing for the entire family.

John Kraft, Director of Lenape Lifeways, Inc. is an archaeologist/educator. He has presented many programs on the Lenape Indians of New Jersey. The program was presented in conjunction with the Library's Summer Reading Program, "Exploring New Frontiers at Your Library."

Sign Language Interpreters at Two Performances of Pirates of Penzance

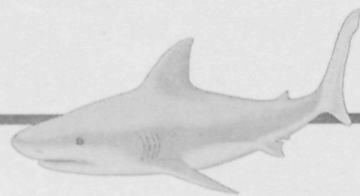
The South Plainfield Summer Drama Workshop (SDW) will offer sign language interpreters for deaf and hearing impaired patrons at their July 30 and Aug. 1 performances of *Pirates of Penzance*. This is the first show in the theater's history to be sign interpreted. Suzanne Baker of East Hanover and Joanne Murphy of Cranford will interpret the show. Suzanne specializes in signing for theater. Last summer she was accepted into the Julliard School for theatrical interpreting. She had a week of intense training to further perfect her skills. Suzanne is a nationally, RID and state certified Sign Language Interpreter. Joanne is also state certified and has signed fifteen shows with Suzanne. American Sign Language is not a word for word interpretation of spoken language but a translation. They will bring in a deaf consultant to ensure the accuracy of their translation.



Suzanne and Joanne work with novice interpreters in a mentor/apprentice relationship. This allows the novices to learn a new skill while saving the theater the funds they would require to hire additional interpreters. Signing a large musical such as *Pirates of Penzance* can be a difficult task. The speaking roles are broken down with each interpreter signing for several performers. The interpreters were made possible in part by a grant from the Middlesex County Cultural and Heritage Commission.

About Computers and Electronics Disposal?

With newer and more advanced computer technologies available about every 18-months, consumers often have no choice but to purchase new ones in order to keep up in this high-tech informational era. Meanwhile, what exactly do they do with their old computers? If they are like most Americans, they probably throw them in the trash, which means that their old computer and its many toxic materials end up in a local landfill, threatening the environment, including the water they drink.

The accelerated growth of electronic technology in the past decade has resulted in an improved quality of life for millions of Americans, but at the same time, it has had some unexpected consequences — namely it has left the U.S. with a glut of electronic products that require disposal. Just how much needs to be disposed? According to the National Safety Council, by 2007, more than 500 million computers will need to be discarded, resulting in the disposal of 6.3 billion pounds of plastic and 1.6 billion pounds of lead. In the near future, this problem will only worsen. When you factor in

the additional burden of discarding older televisions, cellular telephones, printers, fax machines, microwave ovens and other electronic products that contain toxic materials, it becomes clear why 26 states in the country are currently considering legislation that would address their electronic waste problems.

So what is New Jersey doing to solve its electronic waste problem? Not much. Some New Jersey counties have implemented a program allowing residents to drop-off their electronic equipment on several specified days a year, where a contracted company disposes of the materials, but the problem here is twofold. First, the consumer or taxpayer still picks up the expense and second, hiring one company to properly dispose of harmful products that they are unfamiliar with is inefficient at best.

Therefore, with an overabundance

of electronic waste piling up in New Jersey landfills and posing serious environmental hazards, we introduced legislation (A-3057) that would shift the responsibility for collection, recycling and storage of discarded electronic waste from the taxpayers of New Jersey and place it firmly on the producers of electronic equipment.

Under this bill, electronic waste materials would be required to be phased out and replaced with electronic equipment containing less harmful alternatives.

Assembly Bill 3057 would also require every producer of electronic equipment to implement an environmentally-sound management program for disposal. Manufacturers would be required to submit their proposals to the DEP for review and any producer that failed would be prohibited from selling their products in the State of New Jersey.

SCHOOL BOARD Briefs

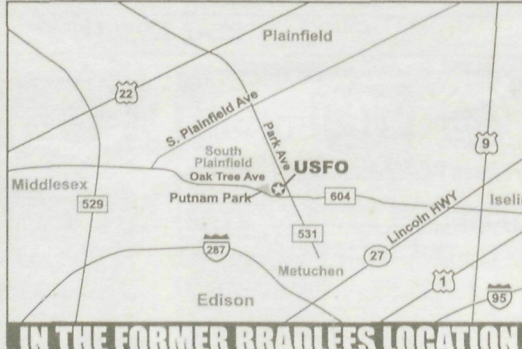
