More than 50 members of the South Plainfield Business Association attended last week's meeting at Sherban's Diner to hear special guest Bob Russo, engineer from CME, speak about the plans for the upcoming construction on Hamilton Blvd.

Plans call for the project to be

completed in two phases. The first the first phase entails. The first thing phase covers New Market Ave. to Durham Ave. During the construction phase motorists will encounter detours and delays at various sections depending on where construction is

Russo explained what the plan for

on the schedule will be the installation of lights at Ryan St. and St. Nicholas Ave., a section that always endures heavy truck traffic. These lights will be synchronized to help truck traffic enter and leave both Ryan St. and St.

Will He Stay Or Will He Go?

Rosado Waits for Word on New Job

Is Superintendent of Schools Dr. Robert Rosado about to hand in his resignation? The question has been floating all over town during the past week and no one will give us a definite answer at this time.

Last week, just prior to presstime, the Observer received several phone calls saying that Dr. Rosado had already resigned. As is our policy, we made several inquires in an attempt to confirm or contradict the rumor. School Board President Pio Pennisi was contacted and told us that in fact, Dr. Rosado had not resigned, but would not deny that he was being interviewed by another district and may be leaving.

On Monday, the Rockaway Township Board of Education website posted an announcement that Dr. Rosado was one of two final candidates in their search for a new superintendent. According to their website, he has been invited to meet the public at a special meeting next Thursday and they will be asked to give their feedback. A final decision will be made on Feb. 9

Once again we reached out to Board President Pennisi who repeated that Dr.. Rosado is still South Plainfield's superintendent and continues to work with the board on next year's budget and all other school related matters.

Rosado was hired in February of 2003 at a salary of \$140,000. Previously he served as superintendent in Verona. Last January the board rescinded his contract after one year and gave him a new contract which was supposed to expire in 2008. The new contract also included raises in January and July of 2004, bringing his salary up to the present \$154,350. The board also added that they were very pleased with his performance his first year.

Shortly afterward, Rosado received a lot of criticism from residents on quotes attributed to him in a New York Times article about South Plainfield. He weathered that crisis only to be followed with the discovery of budget shortfalls in this year's school budget, which left the district \$1.8M in the red. The shortfalls were followed by the resignation of Board Administrator Dr.. Edward Isbicki on Sept.. 15. Dr. Rosado has been forced to deal with these shortfalls by making hard decisions on what to cut and how to save money. Schools are no longer open on weekends, the janitorial staff has been cut as well as several programs throughout the district. On Oct. 6 the board hired Robert Davis as an interim business administrator at a cost of \$500 per day.

Under Dr. Rosado, the district test scores have been on the rise and an extensive SAT program has been put in effect this past year.

CVS Robbed At Gunpoint

The CVS Store on Oak Tree Rd. was robbed last Saturday evening during the blizzard.

The suspect, described as a white male, approximately 18 years of age, wearing a dark fluffy coat and gloves, entered the store wearing a triangle shaped mask over the lower half of his face. When the employee told the suspect she could not open the safe, he showed her what appeared to be the handle of a handgun in his waistband, then grabbed two prescriptions which had been previously filled and were waiting for pick-up. He then fled from the store.

Footprints in the snow determined that the suspect ran across Oak Tree Rd. behind the office buildings at the 900 Oak Tree Rd. complex, then along the railroad tracks and onto Park Ave. The footprints ended on the roadway and the suspect may have been picked up by a vehicle.

Mikorski Continues to Ask Tough Questions

Former BOE member Frank Mikorski once again took the podium during last week's Board of Education meeting to ask pointed questions on the school budget. He was asking questions about the 2003-2004 budgeted amounts presented to the voters and questioned the fact that those were not the amounts actually spent after the auditor's report was completed.

Mikorski further questioned the legality of spending a substantially higher amount of money than what the voters were asked to approve. The budgeted amount on the ballot was \$42.771M. However, when the audit report was completed last month, the actual total expenditures was over

Acting Business Administrator Robert Davis explained that, in fact, voters actually vote on the school tax rate and not the budgeted amount. He added that as long as the tax rate doesn't change, the budget is legal. He explained that during the year things happen that are unexpected, such as budgeting for heat and then having an especially cold

winter, or someone who leaves in the middle of the year and then are due by contract, terminal pay. "The budget changes. The budget is a guideline and not cast in stone," Davis said.

Mikorski disagreed saying, "I think it is wrong to go to the public with a budget which the public thinks is the budget you are going to live by; it is wrong not to follow that budget."

Mikorski said underfunding also took place in this year's budget in many accounts. For example, industrial aids was budgeted at \$290,000 is now adjusted to \$892,956. Last year, social security was budgeted at \$395,628; this year it was budgeted at \$273,000.

Mikorski also asked about the transfer of \$300,000 from the adult school surplus fund to help put money into the debt service fund. Davis explained that debt service was funded for \$500,000, but apparently there was not enough in that fund, so the surplus was moved to cover the debt fund.

During the past year, line item transfers have appeared on the agenda almost every month, some months hundreds of transfers were made. Transfers refer to moving money from one account which is short to another account to fill in the gap. During the course of the past year it has been revealed that many departments were grossly under funded.

The essay were based on articles they red in newspapers delivered to their classrooms through the Newspaper in Education program.

The contest, which was sponsored by the William G. and Helen C. Hoffman Foundation, will award US savings bonds to the eight students.

School Board to Ask State To Investigate for Any **Criminal Activities**

In December, the board asked the State Department of Education to audit their books for the past 10 years to review past financial operations in the district.

The board has been trying to find the root of their fiscal woes and they have found that there was not just one problem, but a number of things that have happened over the past 10 years that all came to a head during this fiscal year.

Richard Rosenberg, assistant commissioner from the Division of School Finance, has written a letter stating that after his meeting with the BOE, the state is satisfied that the board is sufficiently undertaking corrective actions and that the current financial operations are improving and the state will not be taking further action at this time.

They did say that they understand the serious concerns the board discussed regarding the alleged past financial management, especially the \$410,000 worth of unrecorded expenditures in the 2001-2002 budget. These undiscovered expenditures

caused an overstatement of fund balance, including a surplus of \$332,644.94. He suggested that the board should request that the Office of Compliance Investigations be contacted and to forward that information for their review.

Board member Sue Peck said the Finance committee will be putting a list together of their concerns and ask for an investigation of any possible criminal wrongdoings by anyone on the BOE or administration, past or present.

Peck said, "We are not letting this go and will be pursuing any wrongdoing. We have uncovered a lot of things that don't make sense and we will pursue them."

Board member Steve Bohn said he has also been studying the 2003-2004 budget, as well as this year's budget, and has found a \$1.1M difference in the amounts budgeted. One example was gas and electric, "Last year 1.3M was budgeted; this year it was \$100,000. We all know the price of gas and electric does not go down," said Bohn.



Good Dental Care is Key To Your Pet's Health

February is National Pet Dental Health Month

You brush your pet, you feed it ward at the end. properly and you make regular visits to the veterinarian. But if you aren't caring for your pet's teeth, you are ignoring a key factor in its overall health, happiness and well-being, warns the New Jersey Veterinary Medical Association. New Jersey's veterinarians are urging pet owners to respond to National Pet Dental Health Month this February by beginning a regimen of oral hygiene that will help keep your cat or dog smiling.

Oral disease is the most frequently diagnosed health problem for pets. By age three, an amazing 80 percent of dogs and 70 percent of cats show signs of oral disease. Symptoms of gum disease in both cats and dogs include yellow and brown build up of tartar along the gum line, inflamed gums and persistent bad breath.

Just as in humans, oral disease in pets begins with a build up of bacteria in the mouth. Those bacteria combined with saliva and food particles cause the formation of plaque, which can eventually turn to tartar and invade the gum line, setting the stage for infection and periodontal disease.

And just like humans, the first line of defense against gum disease in your pet is regular tooth brushing and visits to the dentist; in this case, your veterinarian.

If you have never brushed your pet's teeth before, following these few simple rules:

Start young. Get your puppy or kitten accustomed to regular brushing by beginning with short, gentle sessions. Make the brushing part of play with your pet and give it a re-

Be sure to use a soft brush designed for pets and toothpaste specifically formulated for pet use. Don't use toothpaste intended for humans. Too much fluoride can be toxic and the formula could upset your pet's stomach.

If your pet is already grown, introduce tooth brushing by first dipping your finger in beef broth for dogs or tuna water for cats and gently rubbing your pet's teeth and gums. Next, wrap a little gauze around your finger before dipping to introduce the feeling of a brush. Keep it brief, gentle and make it fun. When you finally begin to use a toothbrush, your pet should be ready to enjoy the session.

Brush daily if possible or at least two to three times a week to keep your pet's teeth and gums healthy.

Pet owners should keep alert for the signs of oral disease. A change in mouth odor, difficulty eating or a reluctance to eat, swelling or redness of the gums, tipping or tilting the head while eating, or even the refusal to eat hard foods, should all be warning signs. If your pet shows signs of oral disease, your veterinarian may recommend a cleaning and even extraction of badly infected teeth.

Failure to maintain your pet's oral health can lead to serious consequences. Infections that begin in the gums can spread to major organs, including the heart, lungs, kidneys and liver. So begin teaching your pet today that tooth brushing is fun. It will lead to a longer, happier and healthier life together.

Another major intersection to be completely revamped is Hamilton and New Market avenues. A house will be demolished on that corner to widen the intersection and new lights installed.



The project will be going out for bid the end of January or the beginng of February. Work is expected to begin some time in April.



Art Teacher Attends NY Art Lecture

Barbara Harris, art teacher at John E. Riley and John F. Kennedy Schools, recently attended a lecture at the City University of New York featuring contemporary artist Chuck Close and New York Times Art critic Michael Kimmelman. Harris's students have recently been studying the work of Close, who became famous in the 1970's for his huge paintings and prints of portraits, which he calls "heads."

"Although I already know a lot about Chuck Close, I learned so much more about his work, process, theories and philosophy by listening to him in person. I will be discussing the new information with my students. This lecture was definitely money well spent," Harris said.

Beginning with the last school year, Harris has been teaching her students about American art, starting with Native American cultures and continuing with the Colonial Period, the 18th and 19th Centuries and the early 20th Century, ending with American art of the 1950's. In September her students continued their study of the 1950's (realism and abstract expressionism) and have been learning about the art movements and many artists of each subsequent decade. This American Art Unit encompasses all the usual and performing art standards established by the State of New Jersey. These standards include the understanding of aesthetics, creation and performance (art production), the elements and principles of art design, critique and the study of history and culture

The movements or art styles and philosophies which were studied include op and pop art, earth art, conceptualism, color field painting, neon art and minimalism, kinetic art, photorealism (with which Chuck Close is associated), staged or manipulated photography, neo-expressionism and computer art. The American Art Unit will conclude with the art of the 1990's and 21st Century plus a look at the emergence of the Crafts Movement and American/Folk/Outside art.

Just this school, in addition to chuck Close, Harris's classes have studied the work of Andrew Wyeth, Jackson Pollack, Louise Nevelson, David Smith, Georgia O'Keeffe, Andy Warhol, Robert Indiana, Roy Lichtenstein, James Dine, Robert Rauchenberg, Jasper Johns, Claes Oldenburg, George Segal, Victor Vasareley, Bridget Riley, Frank Stella, Morris Lewis, Duane Hansen,

Keith Haring, Julian Schnabel and Grandma Moses, as well as others.


"Art class is so much more than just creating art work. One of the main objectives of this long range unit has been to trace the development of contemporary American art and to understand how the definition of art, i.e. "What is art?" and the appearance of art, i.e., its aesthetic qualities, change over time. The children have been learning how each movement or style is a reaction against previous art philosophies and reflects the historical events and popular culture of each decade.
