State Gives \$220K **Back to District**

With the help of Assemblyman Pat Diegnan, the Board of Education has recovered \$220,000 in reimbursement funds from the State of New Jersey.

"It was a remarkable accomplishment, because I don't think that a year ago anyone had any hope of recovering this money," said Superintendent Robert Rosado.

The \$220,000 amount comes from the employer's portion of the social security payments. There are two sections of Social Security, with payments made by the employees and employer. The employees' portion is withheld by the district for payroll taxes and that check is forwarded to the state department of taxation. The employer-the BOE-also sends a check to the state

and when an application is made, that amount is reimbursed to the district.

"The board in 2002 didn't file for reimbursement and the state department told us that in 2003 it would be impossible to give us the money back because their books were closed and it would be next to impossible to get the funds back to us," said Rosado.

Assemblyman Pat Diegnan was called on for his help. "It was something I've been working on for a while," said Diegnan.

"What I had to do was to intercede with the State Treasurer John McCormac and explain the circumstances. It took a little bit of work but I am happy to say that McCormac and Acting Governor Richard Codey were good listeners and sympathetic to South Plainfield's situation and they realized that this was a unique situation, because it was money that the Board would have received if they had applied for it," said Diegnan.

"That's the nice part of the job: to do things for your hometown. If you aren't there, you are not aware of these things and therefore the municipality doesn't get what it otherwise would have gotten," Diegnan added. Diegnan with the help of State Senator Barbara Buono were also instrumental in obtaining a grant for the district's World Language program.

"The \$200,000 will go to our fund balance," said Rosado. "It helps tremendously for emergencies - if anything breaks down," he added.





During his five-year career, Conklin received numerous commendations and had earned the respect of his fellow officers, his superiors and the citizens of South Plainfield. On January 21, 1972, while escorting a mentally ill patient to the hospital, Conklin make the ultimate sacrifice, when he was shot and killed with his own service weapon by that patient. Scotchbrook Gets Parking Variance OK

For almost a year of making appearances before the Planning Board, Scotchbrook Associates received what it asked for - a parking variance to have 30 parking spaces on its site and preliminary and final approval with conditions to use its existing building for restaurant, commercial office and

Built in the 1950's on the corner of Park and West Golf Ave., the building was purchased by Bill Gazi's father for his business, Graphic Printing, in 1970 from Toll Brother's cabinet business.-For a time, Lean Line (before they moved to New World Way) was a tenant that used space on the second floor. Currently the tenants are on the first floor and include a Chinese takeout restaurant, an auto parts store, a kitchen cabinet store and a periodical distributor.

As one of the conditions for approval the Board is restricting the 1800 sq. ft. of space on the second floor to storage for tenants only.

Initially, Scotchbrook's site plan use included using the 1800 sq. ft. on the second floor for office space.

Zoning officer John Pabst noted that there weren't enough parking spaces planned for additional tenants, saving that in his opinion, only three tenants should be accommodated at this site. At earlier Planning Board sessions, Pabst had made a determination that 70 parking spaces should be on the site and when Scotchbrook appealed to the Board of Adjustment to lower the number of spaces, the Board backed Pabst.

Stating that there were only seven employees in the building, some employees didn't own cars and that most of the existing spaces weren't used, traffic engineer Harvey Yesowitz initially

requested a variance for 24 parking spaces at the June 8, 2004 hearing. The May 10, 2005 revised plan called for Scotchbrook to tear down a garage and use the area to add seven additional parking spaces with one space not used for parking but to allow for turning in a driveway that only permits large trucks to enter then back out. The new plans also call for the paved areas to be stripped, with wheel stops facing into the building and being signed and dedicated to the user, curbing the parking areas and replacing the wooden railroad tie on the western end of the property with a concrete curb all the way to the end of the pavement. Three additional 14-16 ft. high shoebox fixtures will be installed for lighting in the parking lot. Also, the broken drain pipes and roof drains will be replaced so rain water will go to the sanitary sewer lat-

Jersey Oil, a gas station on Park Ave., adjoins the Scotchbrook building and its tenant, a takeout Chinese restaurant. Jersey Oil owner Alex Stasenko stated that the drivers for the restaurant will often use his driveway, making it difficult for his customers to see the road if exiting. Stasenko also noted that although there is no parking on Park Avenue, cars will park on the street in front of the restaurant. To prevent this in the future, the Board will have Scotchbrook place barriers in front of their building to prevent parking on the sidewalk.

Resident Barbara Morris of West Golf Avenue stated that she had been blocked from her driveway and called police because a customer who had purchased windshield wipers at the auto supply store and was parked in front of her house installing them.

They see that we are a dead end street and somehow that makes it ok for them to work on their cars here. I've even seen a car left here for a few days," said Morris.

Morris also noted that after making their car repair, the customers would leave boxes, batteries, oil containersall manner of debris-on the street and on lawns.

Kevin Keane, another West Golf Ave. resident, brought in pictures showing tractor trailers in the middle of West Golf Ave. blocking driveways. To reduce the problem, the Board is imposing the requirement that delivery trucks be no larger than step vans.

The vote for the variance and site plan approval was close, with Mayor Daniel Gallagher voting against while a slim majority voted for ap-

"I appreciate the problems in the neighborhood," said member Charlie Butrico, "but (by voting to approve) we have an opportunity to make improvements in the neigh-







Construction & Utility Improvements

From the Borough Administrator - Glen Cullen

This past week utility infrastructure repairs have been quite numerous throughout the Borough. In virtually every part of town repairs have taken place. Some of these repairs have been completed, while others are on-going. Listed below is the description and status of the utility improvements that are taking place:

- · New Brunswick Ave.-The road and railroad track repairs are complete. The emergency water repair between South 9th and Foster is also
- · Clinton Ave.-Gas lines are being installed on Clinton Ave. Installation of the gas lines should be completed by May 30.
- · Woodland/Dolores Ave.-Emergency watermain repairs are complete.
- Park Ave.-PSE&G is having 2.4 miles of gas lines installed from Sprague Ave. to Oak Tree Ave. The line will cross Maple and continue to Oak Tree. Work is taking place during the day, but there should be minimal traffic impact because the lines are largely between the curb and sidewalk.
- · Hamilton Blvd.—Water-main installation on Hamilton Blvd is continuing on schedule. An eight inch water line is being installed to replace the existing six inch line. As of May 20, American Water has laid pipe from Ryan St. to Smith St. Construction will continue at night. Once the line is completely installed, connection will need to take place with all of the existing homes and businesses along Hamilton Blvd. The total project is expected to last an additional 21/2 months.
- Hamilton Blvd.-Phase 1 construction is set to take place in late June. The total reconstruction of Hamilton Blvd. will begin as the watermain installation is winding down. Hamilton Blvd. Phase 1 consists of a total reconstruction of Hamilton Blvd. from Durham Ave. to New Market Ave., installation of storm sewers and sewer lines, installation of a new traffic light at St. Nicholas. Students Create Butterfly Garden in Middle School Courtyard

Butterflies will soon abound in the newly planted gardens in the courtyard at the South Plainfield Middle School with the help of students studying at Rutgers University.

Shannon Galbraith-Kent, a PhD candidate in Ecology and Evolution, and Grant Kolmer, a graduating senior in Mathematics, have been working all year with seventh grade science teachers Jennifer Checchio and Dana Marotto through a K-12 program funded by the National Science Foundation through Rutgers University. The goal of the program is for resources and ideas from the university be integrated into a science curriculum. They have been alternating between the two classrooms once a week. According to Galbraith-Kent, "It is our hope, when we do an activity, that we're doing something fun and educational that they (students) wouldn't otherwise be exposed to with the typical curriculum."

Leading up to the actual planting of many variety of butterfly attracting plants last week, the students researched information on the biology of butterflies and did a plant inventory of the courtyard area to get ready for the project. The plants that are in the habitat are all native to New Jersey and are known for attracting butterflies. Each class planted an area of the habitat and will be responsible for watering and recording plant height growth until the end of June. "We're

Elderly Granted Extra Time for Property-Tax Rebate

Elderly and disabled homeowners in New Jersey have been granted extra time to file applications for propertytax rebates under two state programs.

State officials recently announced the deadlines for the 2004 FAIR homeowner and Senior Freeze rebate programs were extended to Aug. 15. Both programs had filing deadlines of

Gov. Richard J. Codey's proposed budget for Fiscal Year 2006, only senior citizens and disabled residents are eligible for the FAIR program. The program was suspended for all other residents as a cost-cutting move. Last week it was announced that state revenues were estimated to be \$1B higher than forecast.

Eligible homeowners who have not received FAIR applications may file by calling (877) 658-2972 or can access applications at www.state.nj.us/ treasury/taxation. The state has set up a hotline, (888) 238-1233, to field questions from senior and disabled residents who have not received applications but believe they are eligible. A hotline, (800) 882-6597, has been set up to answer questions about the Senior Freeze program.





(Continued from page 1) reporting the discovery of a suicide note, left by a resident's son, police arrived to find a distraught person in the basement, holding a rifle, with his finger on the trigger and the muzzle of the gun pointed at the base of his chin. Officers immediately took cover and waited for Lt. Siedenburg, who is a certified hostage negotiator. Officer Diana, who knew the subject, began to develop a rapport and conduct faceto-face negotiations. After the 90minute ordeal, the man gave up his loaded weapon and was taken into custody. Because of the officers involved, the incident led to a peaceful conclusion and a potential tragic ending was avoided.

The second incident occurred in February of 2004 when police received information from the Plainfield Narcotics Squad about the transportation of a large quantity of illegal drugs. Officer Mahoney observed the vehicle, occupied by three male suspects, as it was about to enter Rt. 287

and initiated a motor vehicle stop. Sgt. Parker and Officers Diana and Clifford supplied backup. When officers spotted the narcotics in plain view, the three suspects were removed from their car. A search of the suspects found a loaded 357-magnum handgun, stolen from North Carolina and a loaded 9mm on another person. Police also found four kilos of cocaine. Because of the actions of these officers, three narcotic dealers and a substantial amount of drugs were taken off the streets.

The 200 Club is made up of business, industry, labor, public service and other professionals whose goal is to provide financial assistance and comfort to families of law enforcement and public safety officials who are killed or disabled in the line of duty.

In addition, the 200 Club awards thousands of dollars each year in scholarships to the children of these families.


