After receiving an anonymous email on the South Plainfield Police Department's tip website and numerous complaints from neighbors, technician Shun D. Zhang of Flushing, NY was arrested for prostitution last Thursday at Hamilton Skin Care located at 1110 Hamilton Blvd.

The establishment has been under surveillance by police for the past month. According to police, individuals were observed entering through the back door of the business at various times of the day and night. An undercover officer posing as a client was sent in and was propositioned by Zhang. She is currently being

In separate incidents last Thurday, held at the Middlesex County Correctional Facility, unable to post the \$2,500 bail. According to the owner of Graphix One, located downstairs from the business, he witnessed two men in handcuffs with hoods over their heads and two women crying, also in handcuffs, being removed from the building at the time the arrest was being made.

South Plainfield High School Students **Investigate Criminal Outbreak**

Note: The crimes described in this article are entirely fictitious. Any similarities to any real persons or events are entirely coincidental.

The South Plainfield Police Department has called upon the efforts of South Plainfield High School students to investigate and prosecute two recent crimes in the area.

Patricia Porzio and Shane Kagan, science and history teachers at SPHS, have recruited students enrolled in Forensic Science and Government and Law classes, respectively, to handle a recent kidnapping and a murder case. On April 12, a Chambers St. residence was broken into and a resident was abducted. Christina McGuff, 17, was reported missing by her mother. Her body was later found near Jost Field, a result of what has been ruled as "an accidental killing." Students from Porzio's class were dispatched to investigate; their collections helped convict the victim's ex-boyfriend, Freddy "Big Wheel" Simone, and her best friend,

Shortly thereafter, a murder was reported in a residence on Garden Dr. The victim, coincidentally also named Patricia Porzio, was fatally stabbed in her home by an assailant brandishing a large sword. Investigation led to the

arrests of the victim's husband, Patrick Porzio, as well as a possible accomplice, Angela Green.

Kagan's Government and Law students have been cleared by the police department to proceed with trials for both cases, which will take place in early June.



Survivor of Cambodian Genocide Visits SPHS

On May 25, students at South Plainfield High School had the privilege of meeting Dith Pran, a humanitarian and survivor of the Cambodian genocide of the 1970s. Dith spoke about the history of the notorious

genocide committed under Pol Pot's Khmer Rouge regime, his amazing story of survival, which was recounted in the award-winning 1984 film The Killing Fields, and his feelings on peace and its place in the world today.

The genocide, Dith explained, was a consequence of the Communist influence of North Vietnam on the neutral country of Cambodia. As the Vietnam War worsened, more Cambodians decided to adhere to Communist doctrines under the Khmer Rouge (meaning "Cambodian Reds") – but a vast majority of Cambodians, believing in the ideals of freedom and democracy, chose to side with the Americans during the war.

Then on April 17, 1975, disaster struck. The Khmer Rouge invaded the

Cambodian capital of Phnom Penh and overthrew the government, proclaiming the "Year Zero" and beginning to exert forceful control over Cambodia. For four years, the Khmer Rouge sent Cambodians to serve the state in the infamous "killing fields," resulting in over two million casualties. Dith, an assistant to former New York Times correspondent Sydney H. Schanberg, was among those sent to work. Fortunately, Dith managed to escape to freedom in October 1979, crossing the border to Thailand and ultimately reuniting with his wife and children in America.

Since his harrowing journey, Dith has worked as a photojournalist for the New York Times since 1980, saw his story become an acclaimed film, received several honorary doctorates, compiled and published a book, Children of Cambodia's Killing Fields: Memoirs by Survivors (1997), and founded the Dith Pran Holocaust Awareness Project. The project, according to its official website (www.dithpran.org), is "to teach students about the Cambodian genocide/holocaust, its mass destruction and wholesale senseless loss of life."

Dith, now 62 and living in Woodbridge, engaged students with his tale of survival and his utter humility with regards to his captors and his loss. When asked his feelings on the Khmer Rouge, who still exist but no longer have power, he responded, "I feel that what they did is wrong, but I didn't think anyone should kill them. The past is the past; let's make the future better." He also stated his advice for survival: "When you are indentured you have to look around and find a way to survive. Go with the flow that's the way to survive." These are no small words from a man who ate whatever he could find while serving the cruel regime - he told students that what animals eat without harm are obviously edible for all life.

Dith also commented on the possibilities of peace today, even with world affairs depicting a world in which injustice is stronger than ever. "The world is getting more sensitive," Dith stated, "[there is] more talk, more support, more sense of doing something." He encourages the support of movements for peace and justice, notably commenting on the possibility of bringing the perpetrators of the Cambodian genocide – minus Pol Pot, who died in 1998.

In spite of his survival and accomplishments to aid world peace, Dith Pran refuses to consider himself a hero; rather, he considers himself just an observer of history with a story to tell. He admits, "I cannot understand why I survived," but does not dwell upon the intervention of fate and instead continues to lecture and promote his message. During his time at South Plainfield High School, he proclaimed his biggest motive behind his crusade, which have certainly become a new philosophy to all who had the pleasure of meeting the great Dith Pran: "I never give up, and I believe evil can never live forever."






The SPFD's 2005 oldies concert



The establishment is continuing to do business, however it is still under investigation by local police.

Go Go Bar Stripped of License

Numerous arrests were made last Thursday night by the Middlesex County Prosecutors Office and the South Plainfield Police Department at the Gentlemen's Club Liquid Assets on New Market Ave. after a two month investigation into illegal drug and prostitution operations. It was also closed down by the Borough and the NJ Division of Alcoholic Beverage Control (ABC) due to the investigation of administrative violations of the bar's license.

Investigators from the Middlesex County Prosecutor's Office Narcotics Task Force received information that employees of the club were allegedly involved in narcotics distribution and prostitution. Surveillance operations and undercover police officers were able to purchase cocaine and marijuana from employees and patrons.

Nearly 50 police officers with search and arrest warrants, including the Piscataway Police Department and agents from the ABC and Division of Criminal Justice, raided the club and seized small amounts of cocaine, marijuana and methamphetamine along with \$1,730 in cash from alleged prostitution profits.

Two South Plainfield residents, John Johnson, 24, and Kevin Turner, 31, were arrested and charged with possession of marijuana with bail set at \$1,000 each. Abdusha A. Muhammad, 25, of Plainfield and Doudou Diallo, 21, of Piscataway were charged with distribution of marijuana. Richard Rodriguez, 32, of Perth Amboy was charged with distribution of cocaine with bail ranging on all from \$1,000 to \$7,500.

Club owner John Colasanti, 57, of Old Bridge was charged with prostitution with bail set at \$25,000. Manager James Veniteli, 53, of North Plainfield was also arrested and charged with promoting prostitution with bail set at \$5,000.

Middlesex County Prosecutor Bruce Kaplan stated that additional arrests are pending. According to Colasanti, as of presstime the club is open and officials from the ABC were bringing back his liquor license Tuesday night. "Owning a gentlemen's club may seem glamourous to some people, but it doesn't come without it's heartache and problems," lamented Colasanti.

Jimmy's story

In the spring of 2004, 15-year-old Jimmy Cox of South Plainfield was hospitalized due to an AVM (Arteriovenous Malformation), a defect in which masses of abnormal blood vessels grow in the brain. Jimmy was diagnosed with an AVM at the age of nine. Over the years it shrank through various treatments, but the end result, unfortunately, didn't go the expected route. On April 21, 2004, the AVM ruptured and Jimmy was rushed to pediatric intensive care at Robert

Wood Johnson University Hospital, where he was placed in a medically induced coma throughout his stay.

When the Cox family found out Jimmy needed intense rehabilitative care, they toured Children's Specialized Hospital and decided it was the right place for Jimmy to get better. Jimmy's road to recovery was quite extensive when he first arrived at Children's Specialized Hospital in Mountainside. Because of the ruptured AVM, he lost the use of the entire right side of his body and couldn't speak or eat. Through speech, physical, and occupational therapy at Children's Specialized, Jimmy's progress was so good that within a two-month time period, he was able to move from inpatient to outpatient status and able to walk, eat and speak again. Currently he comes to the Mountainside facility on an outpatient basis three times a week and attends the Children's Specialized Neuro-Rehabilitation Program in Fanwood, an intensive treatment program for children who have sustained a brain injury and are experiencing cognitive dysfunction, four days a week.

The Coxes are grateful for the care team at Children's Specialized and want to see the services of this rehabilitation hospital extended to as many children and their families as possible. They are encouraging everyone to support Children's Specialized Hospital and invite all South Plainfield and area residents to come out and enjoy a great night at the ballpark on June 9.
