## Billboard Approved For Carole Media

Carole Media will join Matrix Outdoor Media and Klein Outdoor Advertising in putting up a billboard on private property that can be seen by travelers on Rt. 287. The Planning Board unanimously approved the Carole Media's application to install a 14 ft. by 48 ft. double sided billboard on a 3.91 acre site with frontage along Durham Ave, Hadley Rd. and 287 at its May 24 meeting.

Last year's billboard application by Carole Media was denied because Board member Charles Butrico found that the location of the billboard at the intersection of Hadley Rd. and Durham Ave. would be unsafe for traffic, noting that many accidents have occurred at that intersection and more may result as drivers read the billboard when they approach the intersection. Butrico also noted that the billboard was visually obtrusive to at least one

of the eleven homes on adjacent Hogan Dr., which would have a side angle, while other homes would be looking at the back of the billboard. The Board also found that the plan had inadequate landscaping.

The case was appealed and Judge Hurley remanded the case back to the Planning Board for final site plan improvement, limited to conditions related to the landscaping plan and the angle of the proposed billboard.

Robert Mannix, the site engineer, explained that both sides of the billboard can be adjusted and that would allow the side that affected Hogan Dr. homes to be angled so that the homes would not be affected in anyway. The proposed landscaping would provide extra trees that would fill in while the larger trees filled out.

Another case that was appealed to Judge Hurley and sent back to the Planning Board was that of Northeast

## Gov't. And Law Classes Bring Justice To South Plainfield

*Note: The events contained in this article are entirely fictitious. Any similarities to real people or events are entirely coincidental - with the exception of the teachers, anyway.*

Two murder cases that shocked South Plainfield were tried last week in the capable hands of South Plainfield High School's Government and Law classes.

The *Observer* reported last week the Police Department's passing of two separate murder cases to Shane Kagan's Government and Law classes, following authorized investigations by Patricia Porzio's Forensic Science students at SPSHS. Both trials were conducted on Thursday, starting with the case of *State v. Porzio and Green*. In this case, residents Patrick Porzio and Angela Green were charged with

respective conspiracy and first-degree murder in the killing of Mr. Porzio's wife.

The prosecution questioned investigators and forensic specialists who studied the case, as well as key witness Alexandra Decker, the best friend of the victim who placed a call to authorities following the murder. The defense portrayed Mr. Porzio as a man who loved his wife dearly and made attempts to solve his marital problems through counseling. Mrs. Green - who, as it turned out, was having an affair with her co-defendant - was depicted as a victim of Mrs. Porzio's rage when she heard of the affair, and

claimed to have acted only in self-defense which resulted in a misplaced stab wound that killed Mrs. Porzio. Ultimately, the jury ruled that Mr. Porzio was not guilty of conspiracy, but Mrs. Green was proven guilty of second-degree murder and awaits sentencing, of which she could receive up to thirty years in prison.

The second case, *State v. Peterson and Simone*, found a pair of high-school students, Julia Peterson and Frederick Simone, facing felony murder charges in the kidnapping and killing of Christina McGuff, Simone's ex-girlfriend. The prosecution wasted

# IN YOUR OPINION

To the Editor,

It has recently come to my attention that the future of the South Plainfield Music Program is in jeopardy. Many of the music programs are to be modified or eliminated from the elementary level up to the high school level. My understanding is that: 1) The elementary schools will provide general music for the students only once a week instead of twice. 2) The Middle School will be forced to hold concert band 10th period instead of first thing in the morning. While this may sound trivial, keeping a large group of students at the middle school level focused on performing 10th period will be a difficult job at best. 3) All private/group lessons are to be eliminated for chorus, band and orchestra. That means that any student whose parents can not afford private lessons, will no longer be given lessons. This would be a major detriment to the chorus, band and orchestra.

If all this takes place, the result will probably be more jobs lost for the music department, district wide. The SPSHS Marching Band is currently in jeopardy as Mr. Tweed's job has been posted. Without anyone in the position of Marching Band Director, the students will not be able to go to band camp in August to prepare their show for the season. To the best of my knowledge, the Board of Ed told the president of the Music Boosters to send in the deposit needed for band camp and that the program would continue. Without a director, how are the students going to go to band camp? The music program is an integral part of our community. At the middle school level, students are afforded the opportunity to audition for regional bands, orchestras and choruses. At the high school level, the music programs look good on college applications and afford some students scholarships. The marching band leads our Labor Day Parade, Little League Baseball Parade and performs at Borough Hall on Columbus Day, Along with the chorus, they also perform Christmas Carols in the park and entertain the seniors at the Senior Center.

If you are complacent with living in a town that does not offer a music program, then you need do nothing. If you feel that this is not what you want for your community, the time to speak is now! Let our superintendent and Board of Ed know that South Plainfield will not tolerate the elimination and/or destruction of our music program!






Goalie Nick Jeglinski was strong in goal and played a big part in the victory.

no time in showing their collection of implicating evidence, notably a false runaway note and a confiscated online conversation between the defendants.

The defense's case tried to convince jurors that the troubles between Simone and McGuff were exaggerated. It might have worked but for the testimony by Simone, who under relentless cross-examination essentially confessed his guilt regarding the death of Miss McGuff. Despite a hasty attempt by the defense team to utilize the principle of reasonable

doubt as a means of exoneration, the jury was unconvinced. Peterson, who never took the stand, was cleared; Simone, however, was convicted of felony murder and now faces up to life in prison or, under New Jersey state law, the death penalty.

The talented students of both Mrs. Porzio's and Mr. Kagan's classes are to be commended for bringing justice to our borough. These potential future criminal investigators or lawyers, as a result of their work, are certainly off to a good start!

Ordinance #1705 entitled: AN ORDINANCE ESTABLISHING PROCEDURES REGARDING THE PLACEMENT, REPLACEMENT OR REMOVAL OF PUBLIC UTILITY POLES OR UNDERGROUND FACILITIES was adopted on first reading and advertised in The Observer on Friday, June 10, 2005 and that a public hearing be scheduled for Tuesday, June 21, 2005 at 8:00 p.m. in the Municipal Building, 2480 Plainfield Avenue, South Plainfield, NJ 07080.

ORDINANCE #1705

AN ORDINANCE OF THE BOROUGH OF SOUTH PLAINFIELD ESTABLISHING PROCEDURES REGARDING THE PLACEMENT, REPLACEMENT OR REMOVAL OF PUBLIC UTILITY POLES OR UNDERGROUND FACILITIES PURSUANT TO THE AUTHORITY PROVIDED IN N.J.S.A. 48:3-17a1

Be it Ordained by the Mayor and Council of the Borough of South Plainfield, as follows:

Section 1. The Borough of South Plainfield Code is hereby amended by adding Chapter 100, to read as follows:

CHAPTER 100 Public Utility Pole or Underground Facility Placement; Notice to Municipal Code Official Required

100-1 Before a public utility places, replaces or removes a pole or an underground facility located in the Borough of South Plainfield, the public utility shall notify both the municipal Engineer and the Municipal Code Official in writing, which may be by Fax or e-Mail, at least, but not less than 24 hours before undertaking any excavation related to the replacement or removal of the utility pole or underground facility, which pole or underground facility is used for the supplying and distribution of electricity for light, heat or power, or for the furnishing of water service or telephone or other telecommunications service on or below a public right of way in the Borough. The Borough Council of the Borough of South Plainfield shall notify any public utility that provides service in the Borough of the application of the provisions of this ordinance.

For the purposes of this section, "underground facility" means one or more underground pipes, cables, wires, lines or other structures used for the supplying and distribution of electricity for light, heat or power or for the providing of water service, or for the furnishing of telephone or other telecommunications service.

100-2 After completing the placement, replacement or removal of a pole or an underground facility pursuant to this ordinance, the public utility shall remove from such right of way any pole or underground facility no longer in use as well as any other debris created from such placement, replacement or removal and restore the property including, but not limited to, the installation of a hot patch as needed to restore the property within the right of way to its previous condition as much as possible. As used in this section, "hot patch" means the installation of a mixture of asphalt to restore property within the right of way to its previous condition subsequent to the construction or excavation of a site required for the placement, replacement of a pole or an underground facility pursuant to this section.

100-3 For the purposes of this section, "pole" means, in addition to its commonly accepted meaning, any wires or cable connected thereto, and any

replacements therefor which are similar in construction and use.

100-4 In the event a public utility does not meet the requirements of subsection 100-2 of this section concerning the removal of debris and the restoring of property including, but not limited to, the installation of a hot patch, within a right of way to its previous condition within 90 days of placement, replacement or removal of a pole or an underground facility, said public utility will be fined up to an amount not to exceed \$100 each day until the requirements of subsection 100-2 are met, except that if the public utility is unable to complete the installation of a hot patch due to the unavailability of asphalt material during the period of time from November through April, the public utility shall not be required to complete the hot patch installation until 60 days immediately following the end of the November through April period. At least five business days prior to the end of the 90-day period established by this subsection, the municipality shall notify the public utility that the penalties authorized by this subsection shall begin to be assessed against the utility after the end of the 90-day period unless the utility complies with the requirements of subsection 100-2 of this section. Any penalty imposed shall be collected or enforced in a summary manner, without a jury, in any court of competent jurisdiction according to the procedure provided by "The Penalty Enforcement Law of 1999," N.J.S.A. 2A:58-10 et seq.). The Superior Court and municipal court shall have jurisdiction to enforce the provisions of this section. In the case of removal or replacement of a pole or an underground facility utilized by two or more public utilities, the public utility last removing its pipes, cables, wires, lines or other structures shall be liable for the removal and restoration required under subsection 100-2 of this section, unless a written agreement between the public utilities provides otherwise.

100-5 Under emergency conditions which significantly impact the placement of a pole or underground facility resulting from natural forces or human activities beyond the control of the public utility, or which pose an imminent or existing threat of loss of electrical, water, power, telephone, or other telecommunication service, or which pose an imminent or existing threat to the safety and security of persons or property, or both, or which require immediate action by a public utility to prevent bodily harm or substantial property damage from occurring, the provisions of subsection 100-1 of this section shall not apply when a public utility undertakes any construction or excavation related to the placement, replacement or removal of a pole or an underground facility in response to such an emergency, provided that the public utility undertaking such construction or excavation notifies the Municipal Engineer and the Municipal Code Official of the Borough of South Plainfield at the earliest reasonable opportunity and that all reasonable efforts are taken by the public utility to comply with the removal and restoration requirements of subsection 100-2 of this section after responding to the emergency.

Section 2. If a court of competent jurisdiction shall declare any section, paragraph, subsection, clause or provision of this Ordinance invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Borough of South Plainfield heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect after final passage and publication as provided by law.



Developers whose application to build a three story office building at 201 Shevencho Ave. was originally denied on a split vote with three members for the application and four opposed based on the site plan for the building. According to Judge Hurley, the size of the property couldn't be corrected because the the applicants couldn't acquire any adjoining property.

Preliminary and final approval was granted unanimously by the board with the following conditions: screening and relocation of the dumpster and recycle bins; landscaping and providing emergency access and a Knox box to the fire department and producing proof that Piscataway will allow the

applicants to connect to their sanitary sewer system.

In another case, the board's decision to grant the application of Benderson Development Company to build a new five-story 106 room Hampton Inn on the site of the former Lean Line on New World Way was upheld in New Jersey Superior Court recently. Since June of 2002, attorney Daniel Bernstein has been in court appealing the application on behalf of Days Inn adjacent to the proposed hotel. John Pabst, zoning officer, confirmed that Benderson has taken out the permits and begun construction on the new hotel. The new Hampton Inn will also be in the vicinity of the Holiday Inn and Motel 6 on Stelton Road.
