The SPHS Girl's Softball team are winners, big winners! On Saturday, June 11 the Lady Tigers claimed the State Championship, beating Northern Burlington 3-0. Captain Lacey Santone summed up their win with a few words, "Hate it or love it, underdogs on top!" The unranked team beat the four ranked team in the state. Teammate Megan Boyle said, "It feels so good when you are doubted all season long and you come in a state championship game, and at that last out in the seventh inning, you prove everyone wrong by taking it all home!"

The Lady Tigers won in the semifinals without getting a single hit in the game. In the championship game played at Toms River High School East, they didn't waste any time. They scored two runs on four hits in the first inning and went on to win by a score of 3-0. Pitcher Jessica Senz struck out six and retired the last 16 batters to earn her 79th career victory. After their victory, Coach Don Panzarella was drenched in Gatorade by the team.

As the cuphoric team stepped off the bus at SPHS, they were surrounded by equally excited parents. Cameras flashed and friends and family offered the girls cheers and applause, Megan's mom Debbie Boyle said, "The team played the way they know how in the end, and the coaching was due solely to the high school coaches and not because of any other coach. Coach Panzarella said, "A job well done! A total team effort was needed to win a state championship. Each and every player stepped up and did a tremendous job. Congratulations to the Lady Tigers."

# Hamilton Blvd. Construction Update Travelers to face upcoming delays, detours

According to the latest available information on the Hamilton Blvd. reconstruction project, not only will Elizabethtown Water be working along the road, but Public Service Electric & Gas (PSE&G) will also working along Hamilton Blvd. All of the work will be taking place before the actual reconstruction work by Middlesex County, which is slated to begin on July 5.

Work on Hamilton Blvd. by Elizabethtown Water is still ongoing. They are replacing the water lines along the road from Ryan St. to New Market. So far they have been doing most of their work during overnight hours. In the area they are working, the traffic pattern will allow only one lane of traffic at a time. Police are on hand handle the traffic.

PSE&G, which has been working on Park Ave., will divert there crews immediately to Hamilton Blvd. to replace the gas lines. They plan to do their work during the day, but discussions are underway to change their hours to overnight. Most of the gas line digging will be near the curb and sidewalk areas. Residents should be alert that some sidewalks may be closed while they are working. PSE&G will also be moving some of the telephone lines along Hamilton Blvd. Both the water and gas line work should completed as far as Elliott St. by July 5, which is the date the reconstruction of Hamilton Blvd. will actually begin. Elliott St. is located between Montrose and Belmont avenues on the boulevard. The Hamilton Blvd. reconstruction will be take place in several phases. The first phase will be in the area of St. Nicholas. A new traffic light will be installed which will be coordinated with another light installed on Ryan St. Work crews will shortly begin to install storm sewers along the boulevard. Right now there are very few storm sewers along the boulevard, but when installation is completed Hamilton Blvd. will have 130 new storm sewers.

# **Accident Closes Hamilton Bouelvard**; Two Injured

At about 1:15 p.m. on Tuesday a four-car crash on Hamilton Blvd. in front of Roosevelt School closed the road for several hours which sent two to the hospital.

Howard Flower, 50, of South Bound Brook was driving a 1997 Mack Dump Truck, owned by Contryview Inc. of Somerset, northbound on Hamilton Blvd. He claimed that when the traffic in front of him stopped, he applied his brakes and they failed. He swerved to the left into the southbound lane and struck a 1992 Dodge Ram Van, operated by Robert Watson, 61, of Plainfield, which was stopped in front of him. The Dodge van then struck a 2004 Dodge Caravan, operated by Joseph DiPalo, 56, of Edison, which was also stopped in traffic. When the dump truck

swerved to the left, it side swiped a 1994 Toyota driven by Sharon Moultrie, 30, of Plainfield.

Moultrie had to be extricated from her car by the South Plainfield Volunteer Fire Department and was transported to Robert Wood Johnson University Hospital for injuries to her head and eyes. Joseph DiPalo was transported to Muhlenberg Hospital when he complained of pain.

The dump truck, which was carrying a full load of screened topsoil and registered at a gross vehicle weight of 80,000 lbs., was impounded for further investigation by the New Jersey State Commercial Vehicle Unit.





(Continued from page 1) had happened. The youngster was about to go into shock when Officers Brad Bullard and Michael Molinaro arrived and tended to the wounds until the South Plainfield Rescue Squad arrived. She was transported to St. Peter's Medical Center.

According to Yarussi, her daughter sustained claw marks to her back and puncture wounds on her shoulder and

arm. She received eight stitches, was released and returned to school June 6. Brianna is a top ranking gymnast, and because of her injuries, is unable to perform.

According to police, the dog owner said that the animal was left unleased in their open garage as "the dog was only 11-months-old and he didn't feel that the dog was vicious in any way."

The Middlesex County Heath Depart. was notified and concluded that the dog is not currently licensed and the owner could not provide proof of a rabies shot. The dog was quarantined for 10 days and then examined by a veterinarian. Police issued a vicious animal summons to the owner.

The same day, police responded to the area of Plainfield Ave. and Madison Dr. on a report of a loose pitbull. When Officers Peter Papa and Anthony. Grasso arrived, they found a loose pitbull in the side vard. The officers made several attempts to gate the dog in the rear yard of the property, but the animal became aggressive and charged at one of the officers.

The dog's owner was contacted and stated that he did not want the dog anymore. A neighbor came out of her home and said she knew the dog and

tried to help. She yelled for the dog to go back in the yard when it lunged at her, biting her left arm. The Plainfield Humane Society was called, however the owner was able to secure the dog in the rear of the property. According to the owner this has been an ongoing problem with the dog and they have tried numerous times to give it away, but no one was willing to take it.

The rescue squad arrived to treat the injured neighbor who denied medical attention. The dog was unlicensed and had no proof of a rabies shot. The dog was ordered quarantined for 10 days. The owner stated that they plan to have the dog euthanized. Police issued an unleashed dog summons.
