# **BOE** President Calls It Quits

School Board President Mike English has resigned his position on the South Plainfield School Board. In a letter submitted to Superintendent of Schools Robert Rosado last week, English explained that family obligations were the reason for leaving, and he wanted to spend more time with his grandchildren.

English was elected to the board in April of 2003, the top vote getter in that election. He was elected as board president last year. During his three years on the board he has served on several committees and was chairman of the Curriculum Committee.

English had taught at both St. Joseph's in Metuchen and South Plainfield High School before accepting the position of director of recreation for South Plainfield.

His resignation letter will be read and voted on at the next Board meeting, scheduled for Tuesday, Sept. 20.

English's seat on the board will be filled by appointment and the term will run until next year's school board elections. Board Vice President Steven Bohn will become acting board

What follows is English's letter of resignation addressed to Dr. Rosado.

# **School Board Asks for Audit** On 2001 Transfer of Funds

Interim Business Administrator Robert Davis was asked to make a detailed list of expenditures and monies received concerning the bond referendum for school construction and upgrades approved in April of 2001 and found that \$850,000 of bond money was put in the general fund and never properly accounted for.

According to Davis, he found that a check written in 2001 for \$850,000 from the referendum fund was deposited into the general fund. One possibility for the transfer, Davis said,

the computer program that processed payments from that fund. Apparently that money was never put back into the referendum fund and stayed in the general fund until the end of the fiscal year, when surplus money was used to avoid a tax increase in the budget.

According to board attorney Dr. Nicholas Celso, nothing illegal took place with this transfer, but members of the board do want answers on why it was done. In short, the \$850,000 was borrowed money (part of the bond referendum). The \$850,000 was that there were problems with ended up in the general fund, then

was returned to the voters by way of a surplus, thus reducing the school board's tax rate that year. However, that same \$850,000 was borrowed money and interest is presently still being paid on it.

The board has asked their auditors to do a thorough search of the records to find out exactly why the money was transferred and what it was used for. This could prove to be extremely difficult to investigate, due to the fact that since 2001 we have had two different business administrators as well as two superintendents.

# New Textbooks, Classes In Schools

Returning to school in September, students throughout the district will find changes in their science classes with each school getting new textbooks and, in the high school, new courses being introduced. The new courses are a result of a year of studying the science curriculum.

Every five years the district has to go through each of the curriculum areas as part of the curriculum review cycle. After a year of studying the science curriculum, we are upgrading the science curriculum from K-12," said Kay Crown, director of curriculum. Students K-6 in the elementary schools will be using the basic text of Scott Foresman Science, the 2006 edition, whose content includes life science, earth science and physical

Each of these areas is expected to be covered each year as students develop problem solving capabilities and connections between technology and society. First grade classes begin with 115 minutes of instruction a week, extending through fifth and sixth grades with five 40-minute periods a week.

Middle school students will have five 45-minute periods a week and use the text Holt Science and Technology: Life Science and Holt Science and Technology: Physical Science

published by Holt, Rinehart and Winston in 2005.

The same basic text will be used by both those in the AE (Academically Enriched) classes and those with learning difficulties.



To the Editor,

Recently Acting Governor Richard Codey signed Executive Order No. 48 which is aimed at assisting the passage of the federal bill pending in the House of Representatives, H.R. 87. This bill, sponsored by Reps. Frelinghuysen and Holt, and co-sponsored by all of our other Representatives, would establish a National Heritage Area in New Jersey focusing on historic Revolutionary War sites in New Jersey. An identical bill, S. 825 sponsored by Senators Corzine and Lautenberg, passed

What is at stake is as much as \$10M in federal funds to help restore and preserve these sites, as well as create educational programs associated with the sites. Although the areas to receive funding do not include every possible revolutionary site, and sites in the south and northwest portions of the state have largely been left out, the current proposal includes 14 counties and more than 200 municipalities.

New Jersey was vital to the revolutionary cause. Washington had headquarters in New Jersey for three winters. More battles and skirmishes were fought in New Jersey than any other state, including the battles of Trenton, Princeton, Red Bank, Monmouth and Springfield. Space does not allow to recount the almost 300 other documented battles and skirmishes or retell the heroics and bravery of our great patriot ancestors. As it stands, small towns, private donors and patriotic organizations like the Sons of the Revolution are left with the task of preserving our State's grand Revolutionary War history.

While the actions of Governor Codey and our State Representatives and Senators are highly commendable, Congress must act fast before these precious sites are gone forever. Next year will mark the 225th anniversary of the march of Washington and French General Jean B. de Rochambeau through New Jersey to Yorktown. Time is of the essence.

Unfortunately, Representative Frelinghuysen had proposed similar bills in the past two congressional sessions. The Senate's recent passage of the bill and Governor Codey's Executive Order may help finally pass this legislation. But the House bill had been referred to a subcommittee on Feb. 3 and six months later it remains there today.

In July, the township of Belleville petitioned Congress to support H.R. 87 and S. 825. It would be wonderful if all other towns, whether earmarked for funds or not - as well as private organizations, followed Belleville's lead and petitioned Congress for the speedy passage of the "Crossroads of the American Revolution National Heritage Area Act." The New Jersey Society, Sons of the Revolution is attempting to contact as many town councils as possible to urge petitions similar to Belleville's. Let's show our gratitude to our brave ancestors who fought for our liberty. It is time for the local government, private organizations and the citizens to put the pressure on Congress to help us save these sites which were so instrumental to establishing our great country.

You received your tax bill and Allen Levine in his letter to the Observer refers to the enclosed letter with your tax bill which was an attempt to explain the reason for the tax increase. It is true that a significant portion of your property tax increase was due to the school budget, but it is equally true that there was an increase in the municipal tax due to tax appeals and this was not mentioned in the letter.

In today's real estate market, everyone talks about the escalating prices of real estate. However in South Plainfield the opposite is true because of the tax appeals by commercial and industrial property owners. In this past fiscal year there was a reduction in assessed value due to these tax appeals. The gross reduction was reported as approximately \$27M, however, because other ratables were added, the impact was \$17,339,280.

The tax rate is based on the assessed value of properties. When there is a reduction in ratables, the result is a tax increase on both the municipal and school tax rates. This reduction in ratables is the highest amount since the reduction due to the sewer moratorium going back to 1994-1995.

When the question regarding these reductions was raised at several municipal council meetings as to why the reduction in ratables, the answer given was that there were appeals for reduction primarily by commercial and industrial property owners. It was also said these appeals were granted because their buildings were not fully occupied or that the anticipated income based on investment did not or was not materialized. Are we, the residential tax payers, expected to subsidize the difference in our tax bill? If one makes an investment in commercial or industrial properties the risk is theirs, not ours.

It is time for the public to be informed who these companies are and why in view of real estate values increasing, how their assessments were reduced. Also tell us if these reductions were part of an adjudicated process or mediated by lawyer and the tax assessor.

A number of people have asked when we're going to repair our water fountain. Unfortunately, due to several circumstances, we will be unable to do so. However, we have added cup dispensers in both of our rest rooms. (Okay, it ain't Poland Springs, but it'll do for now.)

Here's a tip for computer users: When you print out a document, either from disc or from a website, please keep an eye on how many pages your document runs. This is particularly true for the Net; sometimes you can mistakenly print out a document with 30+ pages when you only need one paragraph. We suggest you use the 'print preview" feature to determine how many pages are involved, as well as which particular pages you're looking for. You should also make certain whether you need color or b/w printouts, since color pages cost more, and adjust the system accordingly. In the end, it'll save time, money, paper, print toner and aggravation.

We have room this week to review a regrettable but necessary area of Library policy: overdue fines. Our normal charges are 10 cents per day for books, 25 cents per day for cassettes and CDs, and \$2 per day for videos and DVDs. All of these charges are on a per title basis. We also assess a postage/handling charge of 50 cents for every overdue notice we mail out and there's a \$15 processing charge for large debts (\$50 or more) that are submitted to a collection agency. We accept payment via cash, checks or money orders (no plastic, as yet). And we are always willing to take certain special circumstances into account (death in the family, illness, etc.) when assessing charges. If you have questions, please don't hesitate to ask.

## Edison Valley Playhouse Plans Open House

Edison Valley Playhouse will hold an open house on Sunday, Aug. 28 from 4 to 8 p.m. Bill Seeselberg vice president of Valley Playhouse Productions wants everyone to check out the renovations made on the historic I10 year old building, originally The Marconnier Union Chapel, on Oak

"Visitors will see that the backstage is finished. It might not all be painted, but they will see the new walls, the new roof and what we've done with the space. We won't have all of the seats in yet, but people can see a few of the seats we will putting in," said Seeselberg. All the seats will be regular theatre chairs. The seats have been donated by Bob Bengivenga, who is keeping them in storage at another facility. The seats will be installed for the gala reopening performance of Barrymore, starring David Christopher, director of Aida for Plays in the Park, on Saturday, Oct. 1 and Sunday, Oct.2.

"We are also leaving space in front of the stage so the area can be used to accommodate wheelchairs or temporary chairs," added Seeselberg. "The backstage area was broken out all the way to the walls, which we didn't have before. The actual footprint of the building is the same, but we are making better use of the space. In the stage reconstruction, we put the storage area under the stage and a prop area. We are getting all the stuff we need in there and there will be some space left over," said Seeselberg.

Ten 20 x 30 foot dumpsters were

filled with construction debris, sections of the back wall and roof materials which were replaced as well as unwanted items from the basement. Making the renovation possible was the help of Assemblymen Pat Diegnan and Peter Barnes of the 18th District, who found available funding with a State Grant of \$25,000, as well as donations of materials and labor from friends of Edison Valley Playhouse.

Seeselberg stressed that Edison Valley Playhouse is "just a building." The group who owns it is Valley Playhouse Productions, a community theatre group incorporated 40 years ago on Sept. 15, 1965. Officers are President Rich Monteiro, Trustees Bob Bengivenga and Bill Seeselberg. "In the future, we will expand the board and

there will be many more committees as more people getting involved," he

"We realize it was an ambitious project, but it is one of those situations where people remember what it once was and now we have the resources to bring it back as an asset to the community and to be able to serve a large audience with the things that we will present here," he added.

Future productions this fall include the British musical Blood Brothers, about two brothers separated in childhood. Seeselberg also will make the theatre available for rentals for poetry readings and parties. "We are looking to have the theatre open 25-30 weekends a year," he said.

## Ban On Smoking In Dorms Signed into Law

Legislation sponsored by Senators Barbara Buono and Fred H. Madden that would require students at New Jersey's colleges and universities to go outside to light up their cigarettes has been signed into law by Governor Richard J. Codey.

"College students will be able to breathe easier this fall, both from the cleaner air in their rooms and the knowledge that one more safety hazard has been reduced," said Senator Barbara Buono, D-Middlesex. "Students at our public colleges and universities should realize that while they have the right to choose to smoke and chance the risks that come along with it, they don't have the right to make those choices for their neighbors. This law will drastically reducing the chance of a dorm fire and diminish exposure to second-hand smoke."

"When it comes to college dormitories, health and safety must be the top priorities of school officials," said Sen. Madden. "This bill strikes a balance by recognizing that many college students are adults who can buy cigarettes, but it preserves the safety of dormitories where large numbers of students live, study and sleep. This measure shows New Jersey's commitment to the safety and well-being of its students.

The bill will amend current law to prohibit smoking in any building used as a student dormitory that is owned and operated by an institution of higher education. Many institutions in the state and across the country already have bans in place on smoking in all buildings on campus, including private rooms in residence halls.

Several states have enacted legislation similar to what Sen. Buono has proposed. The administrations at these schools claim that a prohibition on smoking in residence halls reduces cleaning fees, maintenance fees and the risk of fire.

Even though the harmful effects of cigarette smoke are widely known and taught in our schools, smoking is on the rise among college students. It's a behavior that has an impact on all students living in our dormitories, whether they smoke or not. College students may be miffed that they have to leave their rooms in order to smoke, but other students shouldn't have to deal with the harmful consequences of those who decide to ignore the dangers of smoking," added Buono.

The new law will go into affect on Oct. 21, 2005.










Pool Patrons Party at Hawaiian Night



ence course being introduced this year for high school freshmen to learn physical science concepts and enable them to understand earth and space science topics. Chemistry and physics will be introduced in the first two semesters to apply to future classes in meteorology, geology and astronomy and ecology.

A Practical Physics class (547) is being introduced to students, mostly seniors who are not taking calculus.

Those interested in taking calculus, but who don't want to take it as an honors or Advanced Placement class, will be able to take academic calculus (483), which will cover fewer chapters. It is for students who may be taking AP English, AP History and those who might not want AP calculus.

There will be new textbook Biology: *Exploring Life* by Prentice Hall for the Honors Biology class.

To meet high school graduation requirements of a full year course in visual or performing arts where student have to take an art class music or drama class, two additional music classes are being offered. The new classes include Music Appreciation (704) and Music Theory (727). There will also be a new 10-week cycle class in music for the eighth graders, which will cover basic music theory, instruments, composition with computer software, history of music singing, jazz, the musical and music of today.

After school at the high school, an academic coach will keep track of the

academics of athletes to alert a student if he/she doesn't bring up their grades they will be benched. An academic coach was brought in because a teacher can't tell a student they aren't playing on the team if they don't do their homework. The teacher doesn't have that power. Only the academic coach working with the athletic director has that authority.

At the Middle School, Jim Patti of Patti Construction in North Plainfield has been repairing the outside concrete wall which surrounds the cafeteria. The labor and materials are valued at \$2,000 and the work is being done as a gift to the district.

High school students will be find a new science scene on the second floor in the science hallway as a result of the efforts of members of the incoming senior class.




