Holocaust Exhibit Draws 8 Survivors

An exhibit of pictures taken by photographer Jerry Casciano of scenes of Auschwitz where hundreds of thousands of Jews were killed is currently on view at the South Plainfield High School Information Center, where it will be on exhibit through the month of February. The exhibit, called Places of Death-Faces of Life, besides scenes of Auschwitz, also includes 16 portraits of living Holocaust survivors.

Social Studies teacher Fran Flanery and students in her Holocaust and

Genocide class at SPHS hosted a reception and program on Thursday, Feb. 2 at the Information Center, introducing photographer, Jerry Casciano and eight of the survivors whose pictures are also on display. They were invited to attend the reception by the students.

Casciano, a free lance photographer who was the State photographer for McGreevey and Codey, spoke to the students about his need to go to Poland to take the photos. "I'm not Jewish, I'm Italian. But while grow-

Hamilton Detour Angers Residents

Residents residing along the Hamilton Blvd. detour route attended Tuesday evening's Council meeting to express concerns and complaints about the traffic pattern which is bringing hundreds of cars, as well as numerous wayward trucks, through their neighborhood. Trucks have been banned from Hamilton Blvd. between Durham and New Marker. Local traffic only is allowed on Hamilton Blvd.

The section where Hamilton Blvd. was reduced to one lane diverted traffic onto Hopkinson, Jackson and Smith streets. Residents have had to put up with increased traffic, noise, speeders

and trucks that have ignored the detour signs and ended up in their neighborhood. Several lawns were damaged and at least one tree was mowed down. They were also upset about temporary no parking signs put up along the detour route and that they were never notified.

Since the temporary detour began, residents made numerous calls to the police chief as well as to traffic safety, but in the past few days have noticed some improvement. Mayor Dan Gallagher said he was sorry the residents were not notified about the parking, but added that the Hamilton Blvd. reconstruction

is needed. He added that 124 summons were issued; 111 of them were to commercial vehicles. Chief John Ferraro told the residents he was available for comments and suggestions and will continue to post officers where needed. Lt. Kevin Murtagh said that notices were given to radio, television and media, and every trucking company received notification about the detour. Despite that, many truck drivers chose to ignore the detour.

The best news the residents heard was that starting this week, traffic won't be detoured through their neighborhood as work will begin on the other side of the road.

Heroes, Cool Kids Visit Grant

South Plainfield High School athletes were recently transformed into "Heroes and Cool Kids" as part of a new mentoring program for Grant Elementary sixth grade students.

The Heroes and Cool Kids program began in 1998 in three counties and has now been implemented in over 20 districts throughout the state. In 2000 the New York Jets became the official sponsor. The program uses student athletes as mentors and role models, along with current and former professional and Olympic athletes as trainers. The goal of Heroes and Cool

Kids is to promote positive student behavior and create a supportive, caring and disciplined school climate.

Selected sophomores, juniors and seniors spent the day in training sessions at Bergen Community College on Dec. 7. Former New York Jet Bruce Harper was the keynote speaker and facilitator. After the training, the athletes were divided into teams of three, with each team adopting a sixth grade class for three presentations throughout the school year.

The first session was held at Grant School on Jan. 27. NJ Metro Stars soccer player Tim Regan conducted a program with the high school athletes prior to their first presentation. He also accompanied the athletes and watched as they interacted with the students. During this first session, the athletes had classes play "name games" where certain students were selected and had to pick one word to describe themselves using the initial of their first name. Each person in line had to repeat the other students' names and chosen words. The athletes spoke about themselves and their experiences in sports, their lives and involvement with their peers. Question boxes were placed on desks where the youngsters could ask questions of the athletes about high school, growing up or anything they could think of. Questions ranged from what sports do

they play to how is the lunch food at the high school. The boxes were left for students to ask further questions.

On Jan. 31 the Heroes and Cool Kids received another training session at Monmouth University in West Long Branch. They will visit Grant School again in the near future.

SPHS Director of Athletics Mike Buggey said, "We see this program as an opportunity to change and influence student behavior in positive ways. It provides elementary school students with positive role models and high school athletes with an opportunity to positively influence their younger counterparts. The structured interaction will have a positive impact on both groups."

In the Jan. 27 edition of the Observer, Mr. Douglas was the editor of an article regarding the South Plainfield

High School wrestling match and the fire alarm incident. The fire alarm sounded in the middle of a match, which stunned everyone in attendance. People began to move down from the bleachers in an orderly manner. Bill Cochran, the MC for the meet, announced on the microphone that the fire alarm had to be treated as a real fire alarm warning and that everyone needed to exit the building at the nearest exit door. People began filing out the exit doors. Mrs. Hunter, one of the wrestlers moms and myself, helped her mother, who needed a

Dear Editor,

I would like to comment on Mrs. Benak's letter published on Jan. 27. Let me begin by saying that you can hold your head up higher than any of our administrators. Not only were you a great secretary to a great administrator, Mr. Young, you were also a ray of sunshine to everyone who came into your office. You knew everything that was going on in Grant School. You knew every child, what their problems or questions were. You greeted them with a smile and always tried to make them feel comfortable. You also knew which children belonged to which parents. You went out of your way and above your job description.

What a crude, rude and cowardly way for Dr. Rosado to let you know you were being laid off! His actions do not surprise me. It seems these actions are now the norm instead of the exception. The question still remains; where did you and the other two secretaries \$10,000 per year go? Last year there was no money for paper, pencils, copies, Kleenex, etc. There is still no money for those things this year! We are given a list every year of things our children must have for school because nothing will be supplied. Even if you shop wisely it ends up costing at least \$20-\$25 per child!

The money didn't go to hire extra teachers. The money didn't go to hire the aides we need so desperately in our classrooms. The money is going toward administrative costs! When is our board going to wake up and see that cuts need to be taken from the top. We are hurting our children the most when we cut back on secretaries, teachers and aides. These are the people that help our children the most!

During last year's budget problem, I was told during my son's annual review by his case manager, Mr. Rotunda, to just let my 10 year-old child

fail. This was his answer to my questions of why there was no aide in my son's classroom. Even though the district was violating my son's IEP, which stated there be an aide in his classroom, they also were not in compliance with the State of New Jersey. The fifth grade classes had eleven classified students in them, when they were only supposed to have six unless an aide was placed in the classroom.

I told Mr. Rotunda I would not let my son fail and I wanted an aide put in his classroom. He then started yelling that the aide was not going to happen in any of the classrooms. Apparently I did not understand we were in a budget crisis and people were going to get laid off and no one was getting an aide. Also, it didn't matter who I called, the answer would be no.

I called Dr. Rosado and told him what had transpired. He assured me, promised me, that he would look into my problem. He also told me he would find the money somewhere and an aide would be put into the classroom and to just sign my son's IEP and he would take care of it.

Of course I never heard again from Dr. Rosado despite numerous phone calls. What I found out later was that within a week of talking to me, Dr. Rosado called a meeting, made up a corrective action plan which he sent into the State to apply for a waiver to exempt the fifth grade classes from having aides. Within that week, our State signed the waiver and our children and teachers were stuck for the year without the resources they were entitled to!

No matter who I called or talked to the deal was done. Nobody cared that these children were being made

the scapegoats because of mismanagement of money by our administration.

It was also very evident that our Board of Education didn't want to hear what I had to say at the Dec. 20 meeting. I knew from past experience that Board members don't know everything that goes on in the district, so I thought I would go before them.

After about 10 minutes of speaking, appointed President Dan Smith interrupted me, asking where I was going with my speech. I told him I wanted the board to be aware of not only what was going on with my own child, but also to make them aware of what was going on with the special education program in our district. Mr. Smith kept telling me to make an appointment with Dr. Rosado. I informed him that I've already had meetings with Dr. Rosado, which got me no where and that I felt the Board members needed to know what was going on.

I spoke for a couple of more minutes and again was interrupted by Mr. Smith and Dr. Rosado. It was very apparent that nobody on the Board wanted to hear what I had to say, except for Jeff Seider. I was able to speak for a couple of more minutes and then asked to stop, even though I wasn't finished with what I had to say.

I am a taxpayer in this town and my taxes go to pay the administrators. I should have the right to have my say, especially after this last tax increase! Apparently the Board doesn't care that not only are we becoming the \$500 per day school district, we are also being known as the waiver district.

When your child sits through two math periods a day, has at least two pages of math homework a night, has a weekly math sheet that has to be done and counts toward a grade, has to master 20 math objectives per marking period on the computer through accelerated math and still has to go in for extra help (and is not the only child going in for extra help), what does that tell you? It tells you there needs to be more help in the classrooms. The teachers are doing without the resources they need to help all the children.

Put the secretaries, aides and the teachers back where they belong in the schools where our children will benefit the most.

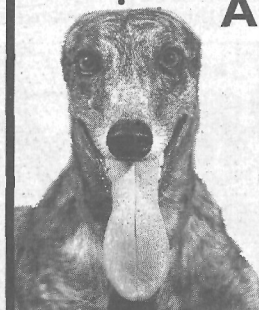

2005 Property Tax Relief Program Information

Applications for the Property Tax Reimbursement program (PTR1 and PTR2) are now available at the South Plainfield Office on Aging. If you do not receive an application in the mail, please stop by the Senior Center for an application.

The Property Tax Reimbursement program reimburses eligible senior citizens and disabled persons for property tax increases. The amount of the reimbursement is the difference between the amount of property taxes that were due and paid in the "base year" (the first year that you met all the eligibility requirements) and the amount due and paid in the current year for which you are claiming the reimbursement, provided the amount paid in the current year was greater. You must meet all the eligibility requirements for the base year and for each succeeding year, up to and including the current year to qualify for the reimbursement.

Income eligibility limits for the Property Tax Reimbursement program have been increased for tax year 2005. As a result, you may be eligible for a reimbursement for 2005 even if you were not eligible in prior years because your income was above the previous limits.

1.) You are age 65 or older or receiving Federal Social Security disability benefits; and 2.) You have lived in New Jersey continuously for at least the last 10 years, as either a homeowner or a renter; and 3.) You have owned and lived in your home (or have leased a site in a mobile home park on which you have placed a manufactured or mobile home that you own) for at least the last three years; and 4.) You have paid the full amount of property taxes (or site fees if you are a mobile home owner) that were due on your home for the base year and for

each succeeding year, up to and including the year for which you are claiming the reimbursement; and 5.) You meet the income limits for the base year and for each succeeding year up to and including the year for which you are claiming the reimbursement.

Residents applying for the 2005 reimbursement must have total income for 2004 that is less than \$40,869 for single applicants and \$50,113 (combined income for married couples) and total income for 2005 that is less than \$41,072 for single applicants and \$51,466 (combined income) for married couples.

Eligible applicants must file the 2005 Property Tax Reimbursement application on or before June 1, 2006. For more information, please contact the South Plainfield Office on Aging at the Senior Center (908) 754-1047.

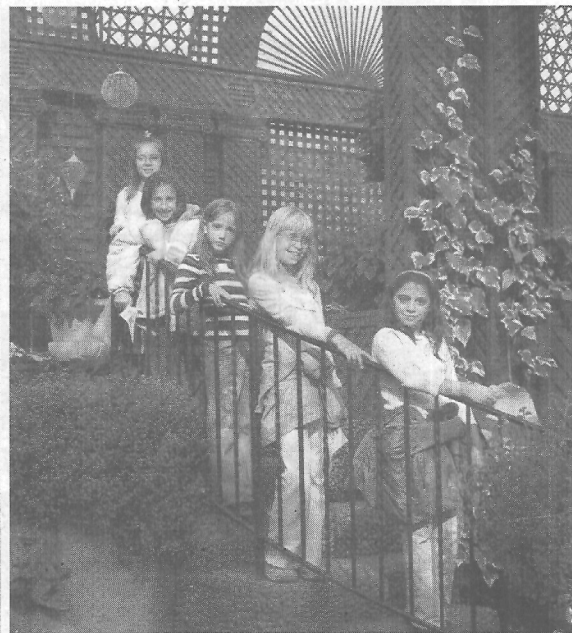

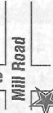

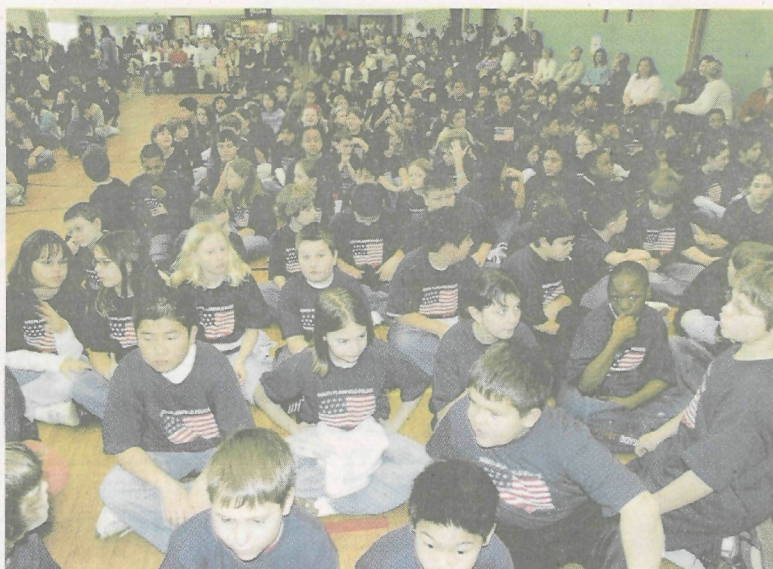

Tigers Rule GMC Tournament Crown Seven Champions

The SPHS Varsity Wrestling Team, the winners of the last two Greater Middlesex Conference Wrestling Tournaments, did it again in dominating fashion by crowning seven individual champions and two runner-ups and swept the 22-team field with a score of 283.5 points. Old Bridge was a distant second with 152, followed by JFK Iselin with 116.5, Edison with 114 and Perth Amboy with 111 securing the fifth place spot. The Tigers have now won 11 titles in the past 14 years.

The Tigers had 13 of 14 wrestlers place in the top eight and sent a school record of nine wrestlers into the final round, matching the 2000 team with seven champions. The Tigers advanced all but one wrestler to the quarter final round held on Saturday

morning. In the finals it looked like a dual meet with South Plainfield against the rest of Middlesex County.

The final round, a much anticipated match between two unbeaten wrestlers, South Plainfield's Patrick Hunter-103 (27-0) and Edison's Mikey FranoBandiero (27-1), was not as close as most expected when Hunter took early control and cruised to a 7-0 decision for the first Tiger championship. Hunter had three pins to get to the finals. Next up for the Tigers was Billy Ashnault-119 (26-1) and a 2005 state runner-up, who faced Steve Fallon (22-2) of Old Bridge, a state runner-up at 103 last year. It was one of the highlight matches of the evening. Ashnault took an early 4-1 lead at the end of the first period and took bottom at the start of the second period. After making several attempts to gain a neutral, Ashnault started to scramble

out and Fallon caught a near side cradle. It appeared Ashnault would roll out of it, but the referee hit the mat for the fall.

Jimmy Conroy-125 (26-1) won his fourth GMC tournament title by a tech fall over Gary Griffin of Woodbridge. Conroy had two pins and two tech-falls in the tournament. Conroy is now the school career leader in wins with a record of 129-6 with plenty of wrestling to go. Mike Jakubik-135 (24-3) was the next Tiger finalist and took it right to Hector Gonzalez of Bishop Ahr, taking an early 6-1 lead into the final period. When Gonzalez scored a reversal making it 6-3, Jakubik quickly escaped and got another takedown to win his first tournament title 9-3. Nick Dorey-140 (25-3) and the number one seed, claimed his title the hard way in triple overtime. With the score even at 2-2 at the end of regulation, Brandon Swift of Edison and Dorey were scoreless at the end of the first sudden death overtime period. Swift allowed Dorey to escape in the first period of the second overtime, then score his own escape in the second period of OT to tie the score 3-3. For the final OT period, Dorey won the toss and took down and scored the escape with one second left on the clock to claim his first GMC title.

Eddie McCray-145 (22-0) won his second GMC title with a tech-fall over Mike Dessino of Middlesex 19-2. Overall, McCray had two falls, a major decision and a tech-fall, which won him the Outstanding Wrestler for the upper weights. Sam Martin-152 (22-6) had three pins in the tournament to reach the finals, but came up short in his bid for a title when he dropped a 3-1 decision to Greg Batista of

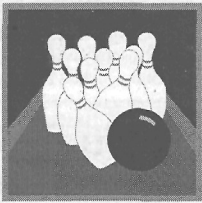

ing up I learned about the death camps from my father. He was a soldier in WW II and had been there as a liberator. He talked to my uncles about Auschwitz. I always wanted to see what was in Poland. I wanted to be there in winter conditions. I went in January 2004 and the day I took pictures the temperature was seven degrees and there was two feet of snow on the ground and the sun trying to break through. "Photographically it was perfect for what I wanted," said Casciano. "When I saw it, I wondered how any one could have survived. They fired a stove once a day with a handful of coal and no more. All the prisoners were getting was a bread made of sawdust and chestnut flour, river water, potatoes and some sort of spoiled meat. Using the latrine three times a day for three minutes on benches (in the pictures) with holes."

Casciano selected 25 pictures from the 500 he took, printed, mounted and framed them. When he brought his work to Dr. Paul Winkler, executive director, NJ Commission on Holocaust Education, they decided to add the portraits of 15 survivors living in New Jersey.

In each portrait the survivor is holding something they had longed for at the time. The portrait of Gina Hofburg, who in May of 1943 at the urging of her parents, jumped off the cattle car transporting them to the camp, is holding three potatoes and a page of her diary. "One of my dreams was to be able to have lots of potatoes, a pot full all for me and be warm in the winter and to survive and to tell what had happened to my family."

Another picture Clara Kramer of Springfield with a shoe. Hidden by non-Jews during the war, her words tell of her shoes falling apart. "After liberation I found half of a pair of my aunt's shoe and had a shoe maker make the mate.

No matter how much I polished the two halves, they never matched."

Holding a newspaper picture of himself in the uniform of a US soldier is David Wisna. "Feb. 12 will mark 61 years to the day that I escaped from a train going to Dachow to Mildorf after being incarcerated in Auschwitz for three years where I survived by singing for the German guards. I glimpsed the star on the tank of the 506th infantry of the 101st Airborne division. I was adopted by the outfit, became their mascot and took part in active combat with them. I never left until I came to the US."

All personal statements are next to each portrait. They were mounted by teacher Richard D'Urso with the help of his students. "For us at the commission, our goal is to bring survivors, teachers and students together...and the students to carry on the legacy," said Dr. Winkler. "I think that the most important lesson to learn from our experiences is that not only do you remember the past, but don't dwell on the past and look for revenge. The main thing is to go on with your life. You build a better future," said Luna

Kaufman.

Clara Kramer said, "I was saved by neighbors, righteous Christians. Remember that everyone who saved a Jewish life risked their own. My message to all is that one person can make a difference. Always know that you can make a difference," said Cecilia Sciden.

"Everyone has a choice—to be a perpetrator or someone who cares and stands up and does something to make a difference, but not to be a bystander. The exhibit is what brought us together," explained Dr. Winkler. "Many of you saw two or three students sitting with survivors talking and learning about each other. Please continue to tell the story. That is why they are willing to go through anything to be with you—this is not a one shot deal. Our survivors and students in this area communicate through e-mail and even had lunch together. They will continue meeting together and talking. The story of the holocaust its a story about bias, prejudice and bigotry and what can happen if we're not careful. Our task is to get the world to understand it. What this school has done - that is what we need for all people," he concluded.
