## Police Raid Green Day Spa Massage Parlor

South Plainfield Police, responding to several complaints by area business and residents about illegal activities, and after undercover surveillance, raided the Green Day Spa, located at 2013 Park Ave. on Monday at 4:30 p.m. Li Ping Feng, 42, of 144-5 38th Ave., Flushing, NY was arrested and charged with prostitution.

Bail was set at \$2,500, with no 10%. At presstime, bail had not been posted.

Green Day Spa was closed following the arrest of Feng and police are continuing their investigation.

## **Hamilton Blvd. Closure Causes Maior** Traffic Backups, Angers Businesses

The latest Hamilton Blvd. closure, which began earlier this week, has caused major headaches to drivers and the businesses located between Belmont and New Market avenues. Traffic all over town was been affected by the detours now that the roadwork has reached the intersection of New Market Ave. and Hamilton Blvd.; a major crossroads being closed down. This new traffic pattern is

expected to continue until the end of the month.

The closure of the intersection also means rerouting truck traf-fic, which used the New Market intersection to turn onto Spicer and then Belmont Ave. It also means that the Lakeview overpass is closed. During this phase, trucks will be allowed back onto Ham-

ilton Blvd. as far as Belmont Ave. The businesses beyond Belmont

Ave. have all felt the impact of these detours. Several business owners attended this weeks council meeting to express their displeasure with the detours which directs traffic away from their businesses. They say they are suffering financial losses because of this and with the road now completely closed, some may have to close completely. They were also upset that (Continued on page 15)

## Police Athletic League Rallies for Alyssa at Charity Softball Game

On July 29 the South Plainfield Police Athletic League (PAL) held their annual Charity Softball Tournament. This year's event was a Rally for Alyssa. In October of 2005, two-anda-half year old Alyssa Riccardi was diagnosed with Stage 4 Neuroblastoma, a pediatric cancer that attacks the nervous system.

The tournaments consisted of a double elimination men's tournament with 14 teams and a co-ed tournament with six teams. The co-ed teams played at the high school's varsity and junior varsity softball fields and the men's teams played at the PAL, middle school, high school and Veteran's Park fields. Each team donated \$250 to participate in the games. The purse was \$500 for first place and \$250 for second place. Food and drinks were sold at the middle school early in the day and at Veterans' Park in the afternoon. The winner of the Co-Ed Division was Team SPGOP.

The final round of mens games were played between Smith Home Improvement and Universal Nutrition-last year's winner. The teams displayed highly competitive spirit, each determined to win, but the victory went to Smith Home Improvement. Both teams generously donated their winnings back to the PAL for Alyssa. Donations were also received from the Old Timers Motorcycle Club, South Plainfield Chapter of Open Your Heart Foundation, South Plainfield Knights of Columbus, Ellery's and the Middlesex and South Plainfield Elks. The tournament raised approximately \$6,500

The Rally for Alyssa was the PAL's fifth annual tournament. Previous rally's were held for Riley Hubner in 2002, David Kyle in 2003, Gary Muccigrossi in 2004 and Kevin Conroy in 2005. The event was organized by Chris Colucci, PAL president; Gary Cassio, PAL vice president and Kevin Hughes, director of the Recreation Department.

Alyssa's mother Dana explained she would liked to have spent more of the day watching all the games. "We

wish we could have spent the entire day at the field watching the games." Unfortunately Alyssa is not allowed around people right now. She has to wear a mask as a precaution, due to the full body radiation and chemo that she had during her second stem cell transplant. Since October Alyssa has not been able to go to the grocery store, church, or any public place. That will stay in effect for at least another two months until her blood counts can fight off infections and

viruses on their own.

Dana added, "We are so grateful that the PAL sponsored the softball tournament and the community of South Plainfield came together to support her. All the donations will help defer the medical costs for her treatments. We appreciate all the support we received from our family and friends from the beginning. We know we can continue to count on them."

Alyssa has a 10-year-old brother,

Christopher who has been a big part of her life and her recovery. When she feels down, he knows just what to do to make her laugh. Christopher explained "I love my sister so much and I can't wait until she is better so

we can go to the park and play." Chris Colucci said, "On behalf of the Police Athletic League, we wish to thank this year's participants for making the day a great success. We were honored that Alyssa was able to join us and we wish her a speedy recovery.



The most rewarding aspect of serving as a member of the New Jersey General Assembly is the ability to assist my hometown of South Plainfield. Over the last five years, my office has been able to resolve hundreds of problems for residents of our borough from passport issues to property tax re-bates to dealing with the myriad of state agencies. I am proud of the millions of dollars in state aid that Assemblyman Barnes and Senator Buono and I have obtained for the Borough and our Board of Education. However nothing that I have experienced during my time in Trenton is as meaningful to me as the legislation that is known as "Abigail's

Law." The best thing about South Plainfield is the people who live here. We are a small town in every sense of the word. We look out for each other and care about each other. No family better embodies that spirit than the Kuberiet family. Chris Kuberiet is recognized throughout the state as an outstanding member of the Middlesex County Prosecutor's Office. I have had the honor of knowing him for twenty years. Although I do not personally know her as well as Chris, I do know that Chris's wife Lisa is a loving and caring mother to whom her children are the center of her life. Three years ago, the Kuberiet's suffered an incomprehensible tragedy when they lost their beautiful two year old daughter, Abigail, in a school bus accident. Abigail was so small that the driver could not see her standing in front of the bus. Due to her size, the mechanical arm, which extends from the bus's bumper, did not prevent her from walking in front of the bus. Shortly after this tragedy I was backing up my car and the sensor in my car's bumper starting beeping when someone walked behind it. I immediately asked 'why don't we use that technology in school buses?' As a result I sponsored legislation, which is officially known as "Abigail's Law." This is a very straightforward law which will require that all newly manufactured school buses must be equipped with sensors to determine objects in the front and the back of the bus. This is not pie in the sky technology. Most SUVs already have these sensors. The cost should be minimal to require this technology in newly manufactured vehicles. Regardless of the cost, the need speaks for itself. Abigail's Law passed the Assembly on July 8 without one dissenting vote. My friend, Senator Buono, is sponsoring companion legislation in the State Senate. With everyone working together it should be signed by Governor Corzine by the end of the year. I must thank Chris and Lisa Kuberiet for working with me on this law. I only hope that it can give them some





## **School Storage Containers Are Becoming an Eyesore**



She assured Barrett that they will be removed when the project is complete.

Barrett said he did not want to complain and would accept Tolley's ex-planation as long as he received a promise that they will be removed. He added that the containers seem to be muliplying by most of the area schools and they are unsightly.

## In Search of Local History

## Where the Lenape Once Walked

By Dorothy Miele

Highland Woods Reserve is nestled between residential neighborhoods and light industries in the geographic center of South Plainfield. It is designated as open space for its passive recreational opportunities and educational resources.

Long before the European fur traders descended upon North American shores, Native American Indians were hunting, fishing and camping in the Reserve. Three thousand year old arrowheads and fire-cracked rock pro vide evidence of their presence. By 500 A.D. a permanent population of Lenape lived on the banks of local streams, cleared the forest and planted gardens.

It is not known when the first white man set foot in South Plainfield. The land that the town now occupies was part of the Elizabethtown Purchase of 1664 and, in 1666, became part of historic Piscataway Township. The early settlers were Scottish Quakers. Some were farmers, and others were loggers. Logging began along the Cedar Brook, northeast of the Reserve, by the mid-1680s. A saw mill and grist mill were built near today's town center and not far from the Reserve.

In the mid-1700s, two hamlets developed: Samptown and Brooklyn. Surrounding farms were generally less than 200 acres. Part of the Reserve's uplands were probably farmed or logged until World War I; others into the 1950s. Tree stands in the Reserve range from 40 to 90 years old.

The agrarian way of life did not last long in this north-eastern section of Piscataway. The arrival of the Lehigh Valley Railroad in 1875 expanded job opportunities, not only with the railroad, but incoming industries. A blue collar workforce replaced the farmers and loggers. Agriculture was all but abandoned here in the early 1900s.

Large parcels of farmland were sold to industry and developers. One of the early large land acquisitions was by Elk Realty (around 1906/07)

which purchased the Col. John Holly farm off Park Avenue. The 100 acre property was subdivided for summer cottages. This was followed a few years later by the purchase of the Elliott Farm by Spicer Manufacturing, and contin-ued with Harris Steel's acquisition of the Blackford farm in 1913.

Farms were subdivided and houses sprang up throughout the new Borough, which separated from Piscataway in 1926. The big boom in population and residential housing occurred after World War II with the development of the John Geary farm on Plainfield Avenue. Years later housing reached Pitt Street, Frederick, Carmine, Highland, Moose and Elsie avenues, and light industry sprung up along South Clinton Ave. and Sylvania Pl., all of them bordering the Reserve. A developer cleared some of the Reserve's dry uplands in the 1980s, but luckily nothing was ever constructed except for a hunter's tree In 1991, the South Plainfield Envi-

ronmental Commission recommended that the original 26 acres of the Reserve between Highland Avenue and Sylva-

Council approved the request the following year and added over nine scattered acres, with Green Acres Street Park. In 1993, the Board of Education leased it for \$1 per year for use in environmental education studies. The Reserve was formally dedicated by Mayor Michael Woskey on June 11, 1994.

The public is encouraged to visit Highland Woods and walk the trails where the spirit of the Lenape lives. The Reserve is open from sunrise to sunset seven days a week and is located on Sylvania Pl. off South Clinton Ave.

## **New Report Cards Slated for Students In Elementary Grades 1-2**

**By Libby Barsky** 

When students start school in September, there will be changes in the manner elementary first and second graders will be evaluated in their academic progress

Students in these grades will start receiving letter grades of A, B, C and I (for needs improvement) for their academic work. The following areasreading, language arts, spelling and mathematics-will use this letter grade. The report card divides each academic area into subheadings. For instance reading subheads will include phonics, vocabulary, comprehension and reading fluency. The subheads will be graded with a check mark indicating additional emphasis needed or NAnot applicable at this time. The absence of the check mark means satisfactory progress.

The previous report cards registered only a "P" for progressing successfully or "T" which indicated a need for improvement for these subjects.

Now in grades one and two, the "P" and "I" will be only used to grade the following: writing process, handwriting, social studies, science, health, art, music and physical education.

Homework will not be graded by itself, but included in the assessment given for work habits and social development where the only rating given is "N" for needs improvement.

The new letter grades for students in grade one and two is in preparation for students when they enter third and fourth grades, where the students will letter grades of A (90-100%), B (80-89%), C (70-79%), D (6569%) and F (64% and below).

If a child is having difficulty in a subject, a report alerting the parent will be sent with suggestions on how to improve the performance or attitude of the child before the marking period ends.

Since April 21, 1997, teachers have suggested changes in the grading standards and procedures and in May 2006 they were revised:



## Bill To Crack Down On Violators of Megan's Law Passes Senate

Violating the address registration provisions in Megan's Law will soon lead to stricter penalties under a bill sponsored by Senator Barbara Buono and approved by the Senate

unanimously.

"Megan's Law needs to be its strongest so that every community and each child can be safe from sexual predators," said Senator Buono, D-Middlesex

The bill, S-716/832, would amend the registration requirements of "Megan's Law" making it a crime of the third degree for a registrant to provide false information concerning their residence and making the failure to verify one's address a crime of the fourth degree. In addition, the bill would upgrade the crime of failing to register as required under "Megan's Law" to a third degree

A crime of the fourth degree is punishable by a term of imprisonment not to exceed 18 months, a fine not to exceed \$10,000 or both. A crime of the third degree is punishable by a term of imprisonment between three to five years, a fine not to exceed \$15,000 or both.

"By increasing the penalties associated with violating the provisions of the law, we are sending a clear message to sex offenders that they will face severe consequences," added Senator Buono. "It is our obligation to use every possible tool to keep our communities safe from these predators."

The bill would supplement "Megan's Law" and require that the

address a registrant reports on his form of registration as his proposed place of residence be verified by the appropriate authority before he is released from either confinement or supervision. Under the provisions of the bill, persons required to register as sex offenders with the Department of Corrections, the Department of Human Services or the Juvenile Justice Commission would also be required to register, within 48 hours of their release, with the chief law enforcement officer of the municipality where they reside.

Under current law, sex offenders who have been characterized as repetitive and compulsive are required to verify their address every 90 days; other sex offenders are required to verify their address annually.



Last week a Democratic candidate went to great lengths to attack me in this paper. While his statements were personally offensive, I have no plans to respond in kind. Rather, I call upon Democratic mayoral candidate Butrico to stop these attacks. Instead, let's talk about controlling spending and taxes, getting a handle on overdevelopment and traffic, and bringing back open government. These are the issues.

I do want to respond factually, Scrudato criticized my voting "no" on borrowing \$1.6 million. I voted "no" for several reasons. Before borrowing a huge sum of money a council member should know all the facts. Because of this, I requested a copy of the New Market extension feasibility study before the meeting where the borrowing was raised. I did not re-ceive it. I asked for it again at the meeting, and I also asked for the appraisals of the houses to be purchased. Councilman Butrico said he would supply them. He did not. I asked for them again after the meeting, and for a third time I did not get them.

When the issue came up two weeks later. I still had not received the information. I wanted the feasibility study because I could not understand why we needed to purchase all three buildings along Hamilton Boulevard, and I simply wanted to see the maps and understand why. As a council member I had a duty to review this information and make sure our tax dollars

were not being misspent.

The appraisals are another story. As

someone with a real estate license, it seemed to me the buildings were not worth an average of nearly \$500,000 each. Just drive by. They are the run-down little apartments on Hamilton Blvd. near the intersection of New Market (next to the tub place).

In addition to wanting to know why we were spending so much money for these buildings, I had also been informed that relatives of Democratic mega-contributor Jack Morris owned two of the three Thus I wanted to make extra sure everything was above board.

When at the second meeting I still did not have the information, I could not in good conscience vote to borrow the money. Even after asking for these documents again at the second meeting, it still took another week to get them. In fact, one of the appraisals is still missing.

Dealing with the school budget was similarly frustrating. Councilman Butrico ran the process and purposely kept Councilman Anesh and me in the dark. He set the meeting dates without informing us; we only found out about them through members of the public. In addition, despite repeated requests, he did not supply us with the auditor's proposed budget reduc-tions until 26 hours before we had to

Because I wanted to take part in the process, and was prevented from doing so, I expressed my disappointment when it came time to vote. Obviously this is very different from how Mr. Scrudato described my vote in his letter.

Taxes are out of control, and residents need relief. Families should not have to choose between paying their property taxes and saving for retirement or to send the kids to college, and seniors should not be forced to move out of their hometown.

I take my responsibilities as a councilman seriously, and I spend hours each week attending meetings, researching issues, and talking to residents. When the majority party tries to withhold information, it does a disservice not just to me, but also to the voters. This needs to end.

As a candidate for mayor, I promise these types of shenanigans will stop if I am elected. Council members, regardless party, will be treated with respect.






