# EPA Starts Cleanup...Finally Seven to Run for 3 BOE Seats



On Wednesday morning, the EPA began the demolition of the first of 18 buildings at the Cornell-Dublier Superfund Site at 333 Hamilton Blvd. EPA Region 2 Administrator Alan Steinberg addressed newspaper and television media at a press conference saying, "The cleanup work at this site is another example of how successful the Superfund program has been in New Jersey. This multi-phase cleanup will help the community turn this problem property back into a local asset."

# **School Budget Workshop Maps Contingency Plans**

Since 2001, the State of New Jersey has frozen state school aid each year leaving fewer resources for district programs. In South Plainfield it has meant elimination of staff and consolidation of

Donna Tolley explained.

However, new regulations might diminish these gains. The amount of \$765,214 is being charged to a capital outlay amount in the 2006-2007 budget. Tolley has contacted the Middlesex County superintendent with a financial method of closing the \$765,214 with the banked Cap amount. The 2007-2008 budget is set now at \$48,386,415. If Tolley's method is accepted, the budget will be \$49,151,629 and under cap by \$56,000.

# **Sweet Potato Pie Makes Magical Fare for Elementary Children**

Sweet Potato Pie and Such, an interactive story telling performance with music, was served up to all elementary students (and their teachers) in the district in February. The program was made possible through the South Plainfield Cultural Arts Commis sion, which received a grant from the Middlesex County Cultural and Heritage Commission. From the moment Queen Nur (Karen Abul-Malik) came on stage backed by drummer Yomi Jojolo (Abayomi Awodesu) and his African instruments, she began distributing sweet potatoes to the children and the youngsters were entranced. Showing the difference between what a sweet potato looks like and that of a yam, Queen Nur held the children's attention equally as easily as the vegetables in her hands. The children responded to whatever they were asked to do-call back, clap hands, stand up and dance. Queen Nur recited the story of Imani-a very small mouse who is put down repeatedly for his size by giraffe, bird, hippo and lion, with the children chanting, "They might call me teeny tiny, but in my mind I'm mighty, mighty," along with the motions she introduced. Imani triumphs in the end, rescuing the captured King of the Jungle






# **GEPA Man Inspires Students**

In preparation for Grade Eight Proiciency Assessment (GEPA) at the Aiddle School this month, students n Gail Merlow's art class created 'GEPA Man" to inspire students takng the tests. The students drew two limensional shapes, studied in math class and transformed them into three dimensional forms using construction paper, plaster and paint.

Teachers spend many hours before school and in their daily lesson plans preparing eighth graders for the state mandated math, science and language arts literacy test administered every year. The GEPA measures whether the students have gained the knowledge and skills identified in the Core Curriculum Content Standards. These standards, adopted by the State Board of Education, identify what students should know and be able to do at the completion of eighth grade. The GEPA replaced the Grade B Early Warning Test that was administered from 1991

through 1998. The new test determines if students have made satisfactory progress towards mastering the skills they need to pass the new graduation test, the High School Proficiency Assessment (HSPA). The HSPA measures eleventh grade achievement of the Core Curriculum Content Standards. The GEPA also helps schools determine which students may need additional help to pass the HSPA in a few years. Local school districts use the results to determine the appropriateness and strength of the local curriculum and to develop remedial programs to help students improve knowledge and skills. Results are also used to satisfy federal requirements under the No Child Left Behind Act.

The science portion of the test will take place on March 12; math on March 13 and language arts literacy on March 14 and 15. The proficiency goals this year are 80% in math and 85% in language arts.





# **County Human Services Seeks Agencies for Pilot Program**

If you administer, direct or work for a social service agency in or around Middlesex County, you can play an important role in a new local initiative.

The New Jersey Department of Children & Families has offered an opportunity for counties to respond to a Request for Proposal (RFP) to develop a Differential Response Pilot Initiative. Differential Response involves taking calls from DYFS (Department of Youth and Family Services) that do not rise to the level of child abuse or neglect and provide an array of supportive social services intended to strengthen families. The state

collaborators who are helping shape the proposal include the United Way of Central Jersey, InfoLine (2-1-1) of Middlesex County, Catholic Charities, the Puerto Rican Action Board and the Jewish Renaissance Foundation.

The State RFP encourages the engagement of the grass roots community in developing the array of social services to be provided. The HSAC and agencies planning the initiative proposal are actively soliciting community-based social service agencies to participate as an integral part of the Middlesex County Differential Response Pilot Initiative. intends to fund up to four pilot projects in the first year.

Families referred to Differential Response may voluntarily choose to confer with a case manager and play a key role in identifying local services that will help strengthen the family. Often these families are struggling to attain the basic necessities in life and lack the resources or experience to take advantage of an important array of supportive social services.

Services include temporary assistance for needy families, childcare, food stamps, health benefits, rental or utility assistance, mental health supports and substance abuse treatment.

Based on recent data, DCF records indicate as many as 450 Middlesex County families may have been able to benefit from a Differential Response program in the past year.

The RFP requires the County Human Services Advisory Council (HSAC) to take the lead in overseeing the planning, implementation and evaluation of the initiative. The key


