Rosado Touts 07-08 Budget

School Board Candidates Debate Tentatively Set for April 5

Now that the Board of Education (BOE) has given their approval of the 2007-2008 budget, Superintendent of Schools Dr. Robert Rosado has been visiting local groups and organizations to garner voter support and to stress the importance of casting an informed vote.

The \$51,438,932 budget, which calls for \$40,050,318 to be raised by local property taxes, is a 2.27 percent increase over last year's budget—an increase of \$1,140,267.

After the voters turned down the 2006-07 budget, the Borough Council made cuts of \$1,182,000, which makes the 2007-2008 budget almost

the same amount as last year. If the budget fails to get voter approval, it will be up to the council to make cuts again at its discretion.

Although no teachers will be cut, middle school sports have been eliminated from this year's budget and funding for freshman sports does not include the full \$100,000 needed to fund the program.

A candidate's debate is being organized for April 5 at the Roosevelt Administration Building. The candidates will have a chance to speak to the public on their reasons for running for the BOE and to answer questions from the audience.

Last year only eight percent of eligible voters in South Plainfield took the time to come out to the polls and vote for a budget that represents almost 80 percent of local property taxes.

Rosado will present the budget in the Riley School library on March 26 at 7 p.m.; the high school cafeteria on March 27 at 7 p.m.; Franklin School on April 2 at 7:30 p.m. and Roosevelt School on April 4 at 7 p.m. All are welcome to attend any of the above presentations.

If you are unable to attend a presentation, a recently recorded presentation will be broadcast on Comcast Channel 74 on Saturday, March 24 at 8 p.m. and Thursday, March 29 at 7 p.m.

The last day to register to vote for the upcoming school board election is Tuesday, March 27. The Borough Clerk's Office will be open until 9 p.m. on that night for voter registration. The upcoming School Board Election will be held on Tuesday, April 17.

A formal budget hearing to adopt the final budget is scheduled for Wednesday, March 28 at 7 p.m.

The event was held at the Edison Elks Lodge. Honorees and guests enjoyed dinner and music after the presentations.

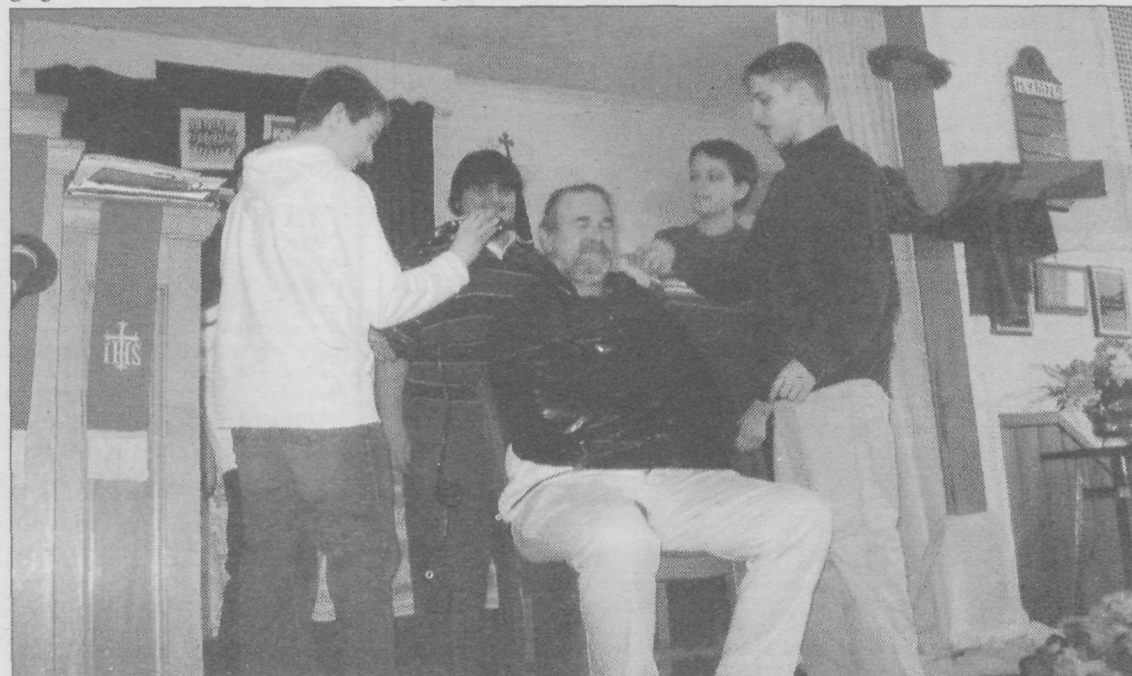
Teens "Starve Hunger"

On Feb. 23 and 24, 10 teens from the First Baptist Church of South Plainfield participated in World Vision's 30-Hour Famine. The youths went without food for 30 hours in order to raise donations to help provide clean water and food for children in Uganda. They raised over \$5,500 from family, friends, the church congregation and local businesses.

Pastor Gordon Braun, at the start of the famine, challenged the group that if they raised more than their original goal of \$3,600, he would let the youth shave his head and beard. On Sunday, Pastor Gordon kept his word and the teens gave the pastor a new look.

First Baptist was one of nine youth groups that banded together for the

famine weekend, bringing together 150 kids and nearly 40 adults. During their time together, the teens made 300 sandwiches for a community service project that benefited the homeless, watched videos on the situation in Uganda and played the Tribe Game. The weekend concluded with an Ecumenical service and a pasta dinner.

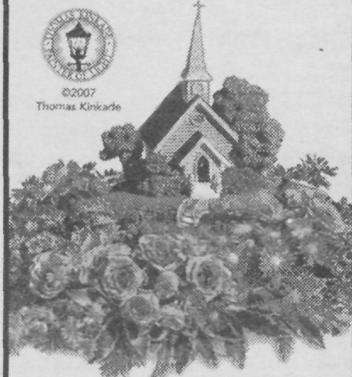

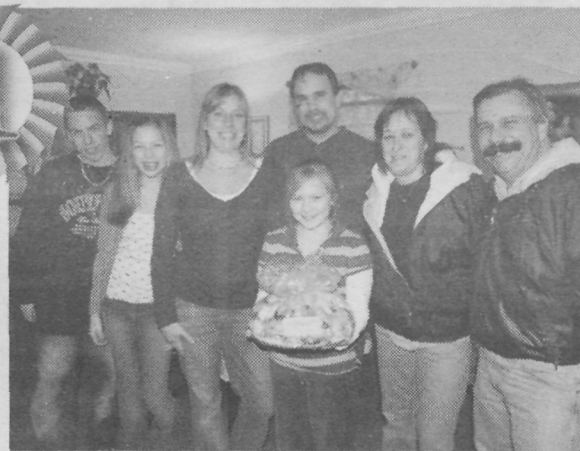

Ord. 1781 entitled: AN ORDINANCE ESTABLISHING THE REGULATIONS OF THE OPERATION OF TRAFFIC CONTROL DEVICES AT VARIOUS LOCATIONS IN THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY was adopted on first reading and advertised in The Observer on Friday, March 23, 2007 and that a public hearing be scheduled for Tuesday, April 3, 2007 at the Public Meeting which will begin immediately after the 7:00 p.m. Agenda Meeting in the Municipal Building, 2480 Plainfield Avenue, South Plainfield, NJ 07080.

ORDINANCE NO. 1781

AN ORDINANCE ESTABLISHING THE REGULATIONS OF THE OPERATION OF TRAFFIC CONTROL DEVICES IN THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

BE IT ORDAINED BY THE GOVERNING BODY OF THE BOROUGH OF SOUTH PLAINFIELD, NEW JERSEY as follows:

Section 1. That the following roads and/or intersections shall be controlled by a Traffic Control Signal in accordance with the plan bearing the date of March 2007:

- A. Helen Street / Bushwick Avenue Intersection
- B. Ryan Street / St. Nicholas Avenue
- C. Durham Avenue
- D. Belmont Avenue
- E. New Market Avenue

Section 2. That the Traffic Signal shall be in accordance with the provisions of the Manual on Uniform Traffic Control Devices, Title 39 of the Revised Statutes and the New Jersey Administrative Code, and SHALL BE OPERATED IN CONFORMANCE WITH THE DESIGNATED PLAN.

Section 3. That all prior ordinances or resolutions or portions thereof of the Borough of South Plainfield inconsistent herewith be and they are hereby repealed.

Section 4. This ordinance shall become effective upon adoption and publication as required by law and upon the approval of the Commissioner of the Department of Transportation.

Section 5. That if any clause, section or provision of this ordinance is declared invalid by a Court of competent jurisdiction, such provision shall be deemed a separate, distinct and independent provision and shall not affect the validity of the remaining portion hereof.

Section 6. When the ordinance is finally adopted, the Clerk of the Borough of South Plainfield is to send a certified copy to Douglas R. Bartlett, manager, Bureau of Traffic Engineering and Investigations, NJ Department of Transportation, P.O. Box 613, Trenton, NJ 08625-0613.

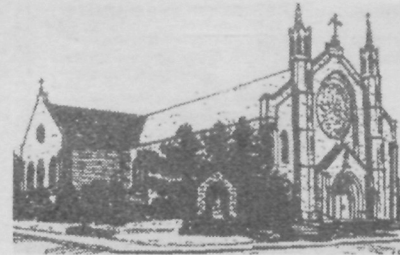

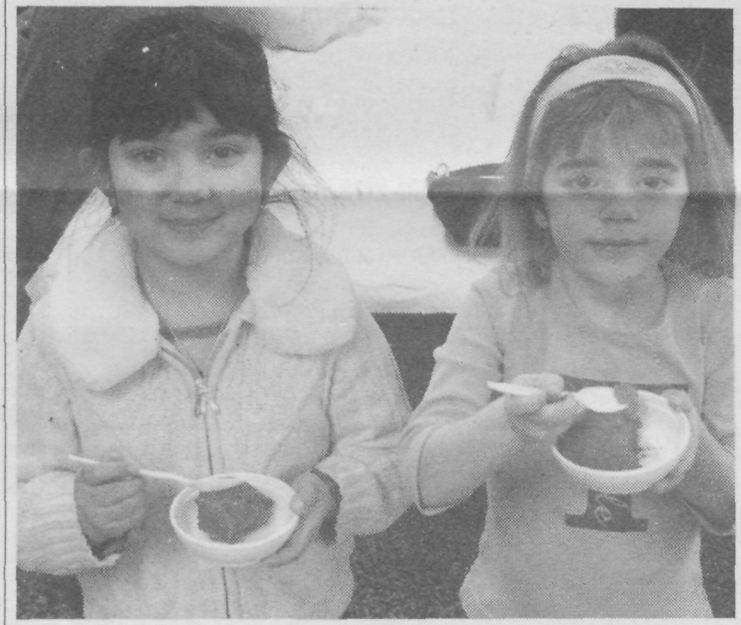

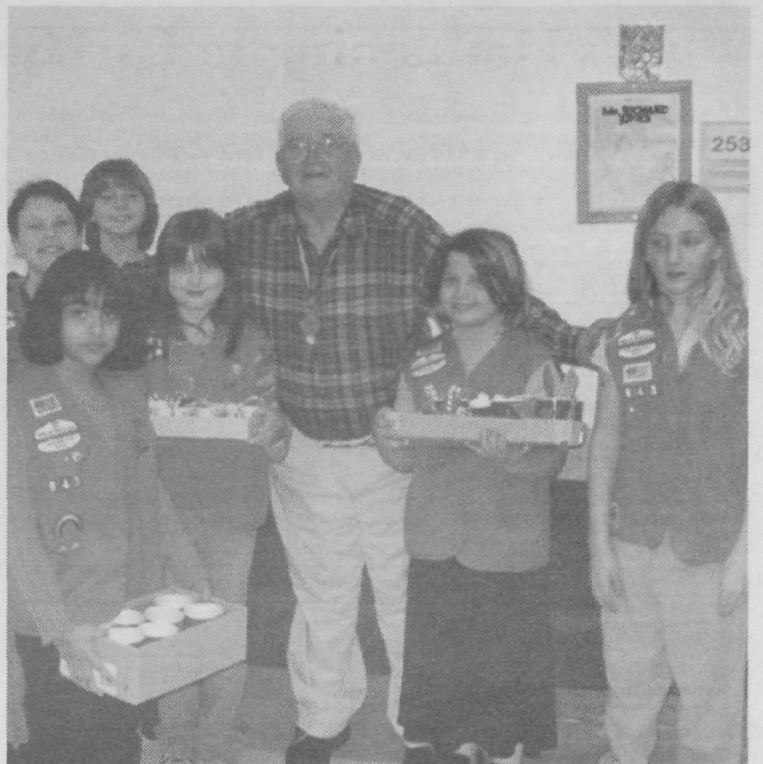
Jr. Troop 843 Visits Cedar Oaks Care Center

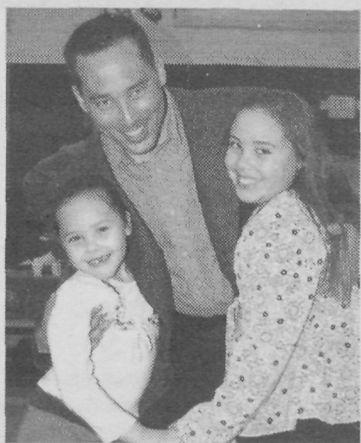

"Block Party" Brightens Up Winter

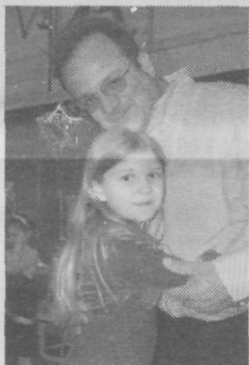
