Republicans Win Control of Council

McConville, Rusnak Win Gives Republicans 4-2 Majority

Republicans will control the South Plainfield Borough Council for the first time in more than a decade with their victory on Tuesday. Republicans Tim McConville and Ray Rusnak defeated incumbent Democrats Dennis Cerami and Kathy Thomas. Cerami had been on the council since 1996, while Thomas served three short terms during the past few years. McConville and Rusnak will both be serving a first term on the council.

The control of the council

will take affect at the January 2008 reorganization meeting. At that time the Republicans will announce what changes they intend to make. One change will be the position of borough attorney, which was an issue addressed in campaign literature.

Voter turnout was 35.51 percent, or 12,800 eligible voters, and is down from last year's 52.11 percent turnout.

Republican Tim McConville was the top vote getter with 2,407 votes, followed by Ray Rusnak with 2,400.

Democratic candidates Dennis Cerami and Kathy Thomas received 1,951 and 1,890 respectively.

"I am here for the people of the town. I don't care about parties. The only decisions I'm going to make are for the people," said Councilman-elect Ray Rusnak.

"I would like to say thank you to the people of South Plainfield for electing both Ray and I and my wife, who has supported me throughout the entire ordeal. I look forward to working for the people to

make South Plainfield even better. And definitely, thank you Bob Jones for all of your hard work. I will be doing what is right for the people of South Plainfield," said Councilman-elect Tim McConville.

After thanking those who worked on the campaign, Democratic Chairman Patrick Diegnan said, "The people have spoken. Obviously the residents of South Plainfield wanted to go in another direction. We want to congratulate our opponents and

growing and adding the nave section of the building, but he always gave time to minister to all of them.

In 1978 Pastor Mingle was asked by parishioners at Sacred Heart Roman Catholic Church to become the spiritual advisor of a Spirit of Christ Prayer Fellowship they wished to start. Mingle met regularly with the prayer fellowship until a priest from St. Mary's in Plainfield was able to take over.

Pastor Mingle also spent many years with Boy Scout Troops 309 and 324, while his son, Philip, advanced to the rank of Eagle Scout. Pastor Mingle has also been a member of the Greater Plainfield Clergy Association and FISH in South Plainfield.

Recognizing his "service and commitment to the community of South Plainfield and on behalf of the citizens of Middlesex County," members of the New Jersey State Legislature honored Pastor Mingle with a Joint Legislative Resolution initiated by Senator Barbara Buono and Assemblymen Peter Barnes and Patrick Diegnan, who presented

First Responders Train for Crisis

Middlesex County recently tested its First Responder Distribution Program during a county-wide, full-scale event to demonstrate how medication would be distributed to emergency personnel throughout the county in the event of a public health emergency.

The distribution program offers oral medication to first

responders, critical infrastructure personnel and those living in their households during a public health emergency, in case of an attack of bacterial agents such as Anthrax, Plague and Tularemia. It will enable them to distribute medication in order to provide emergency services to the community.

The exercise took place in a borough warehouse and included 25 municipalities and agencies throughout Middlesex

County. Bulk medication was received, boxed and distributed to other municipalities, county departments and participating agencies. The exercise began early in the morning when an alert went out to all county agencies of a potential attack of a bacterial agent. Each agency was advised where to pick up the medication for their first responders at a location in South Plainfield. As each agency arrived, they received only their allotted amount of medication. Police were on hand to make sure only the proper personnel were allowed to enter the warehouse. Each allotment was determined by the number of first responders and their families living in that district. In case of a medical emergency it is important the first responders receive the medication so they are healthy enough to help distribute medication to the general population.


"Emergency first responders are the individuals who are

Greetings from Taji, Iraq. I hope this finds everyone in good health and spirits. I thought I'd scratch down a few words since it's nearly impossible to join you this evening and I most certainly regret being preoccupied.

You must wonder what a 48-year-old middle aged man (wake up folks, we are middle aged) is doing in a war zone. Well, I remained in the Navy Reserves after my four year hitch out of high school and traveled around the world doing some interesting things. In February I retired from Delta Airlines after 25 years and went to work for the FAA. I also had the opportunity and was selected to do some work with Unmanned Aerial Vehicles (UAV) in the Navy, which brought me back on active duty in May of this year.

I've been in theater now since July in command of a UAV team and also flying as a mission commander. I have a split crew of military and civilians and all I can really say is we work for some special folks doing special things.



We've got room this week for a reminder and a question. First, the reminder. Many people come to the library to use our computers and bring along their own storage media (like discs and flash drives) to save their work. Unfortunately, they don't always leave with them. We've had several instances where people will forget their storage items and leave them in the computers. Even worse, most of these items aren't labeled, so we aren't able to find out who they belong to. So, we ask that you make sure you have all your materials before you leave the computer. In fact, make sure you have all your stuff (like keys, bags, wallets, etc.) before you leave the building. It'll save you a massive amount of hassle.

Finally, a patron recently asked if we stocked HD or Blu-Ray DVDs in our collection. Well, at the present moment, we only stock one HD-DVD; it's a combo copy (both standard and HD) of "Music and Lyrics," starring Hugh Grant and Drew Barrymore. Beyond that, we don't stock either of the new formats either in our permanent collection or via the DVD circuit. This is because, at the moment, most of our patrons don't have the more advanced equipment for these new formats, so there's no need to stock the new stuff. Also, there's the titanic and as-yet-undecided struggle between HD and Blu-Ray to be the dominant format (think VHS vs. Beta for reference). That said, once there's a higher demand for the new stuff and a better idea of which format is more prevalent, we'll see about adding HD or Blu-Ray to the collection. (Looks like we'll have to get "Star Wars" again, not that I'm complaining.)

us remember our neighbors in need, just as the Native Americans did for those struggling Pilgrims. Many businesses, churches and community organizations organize special collections to help others during this time of year. As a community, South Plainfield's churches participated in the annual CROP Walk last month, raising funds and emphasizing the need to be aware of those who go to bed hungry some, or most nights. These caring acts benefit those who need our help—but there is more. Other side effects result from kindness.

The act of helping others—and of giving thanks—helps us, too. How? Studies have shown that reaching out and helping someone in need—visiting a shut-in, serving a meal at a soup kitchen, giving to a worthy cause—lifts our mood. And the practice of thanksgiving yields similar results. In a controlled study among people suffering from depression, the group was divided into two smaller groups. One group was given the daily task of writing down, before bedtime, 10 things for which they could give thanks, even something as small as hearing a bird's song, or the smell of freshly baked cookies. The other group was given no special task. At the end of one month, the group with the "thanksgiving" writing assignment showed a statistically significant improvement in their illness, while the group that was not required to give thanks showed no significant change.

This year, I encourage each of us not only to give thanks, but to get involved in helping someone else. It not only does good for them—it does good for us, too.

Priest Arrested for Sex Crimes

On October 23, Reverend Edgardo D. Abano, 51, was charged with criminal sexual contact and arrested by members of the Middlesex County Prosecutor's Office Sex Crimes/Child Abuse Unit and the Piscataway Police Department's Special Victim's Unit. Criminal sexual contact is a fourth degree crime which carries an 18-month maximum sentence.

At the time of his arrest, Albano was the pastor of the Saint Francis Cabrini Roman Catholic Church in Piscataway. Albano served at various parishes in New Jersey: Our Lady of Lourdes in Whitehouse Station, Immaculate Conception Church in Somerville, Saint Philip and Saint James Church in Phillipsburg and Our Lady of Fatima in Piscataway.

According to the Diocese, Abano has taken a voluntarily leave of absence and has voluntarily agreed to have his priestly faculties suspended.

County Seeks Grant For Shared Services Web Site

Middlesex County's newly formed Shared Services Department is seeking a \$200,000 State grant to establish an Internet portal, or Web site, that all municipalities, agencies, authorities and school districts throughout the county can use when looking to explore shared services in the areas of specialized equipment or vehicles, combining professional services and purchasing supplies.

The graphic rich, easy-to-use Middlesex County Shared Services Portal will allow users to sign in on a secure site to communicate with one another their interests and needs for shared services initiatives of all types.

Towns may pool their resources to purchase such equipment as street sweepers or share administrative services.


An interactive pricing database will enable local and school officials to see what other municipalities are paying for things such as vehicles, equipment, janitorial, office supplies and rock salt.

They then can shop for the best price and purchase directly from the vendor or join with another entity and create joint bid specification. This aspect of the site ties into the county's highly successful Common Cents cooperative purchasing program.


Currently, all 25 Middlesex County municipalities, 10 school districts and three authorities participate in the County's Shared Services program.

After the vote count gave them a victory, Bob Jones announced that he will be stepping down as Republican Chairman.

Voters in New Jersey also rejected referendum question one, which would have dedicated one percent of the sales tax to property tax relief and question two, referring to borrowing money for stem cell research.

They approved question three, referring to borrowing money for open space and question four, which will change the wording on the constitution to remove offensive phrases such as "idiot" or "insane" person.

Assemblyman Patrick Diegnan was re-elected, receiving 18,121 votes; and his running mate Peter Barnes III was elected to his first term in the Assembly with 17,844. Republican opponents Joseph Sinagra received 13,597 and William England had 13,431 votes.

responsible for the protection and preservation of life and property," said Freeholder John Pulomena, chair of the County Public Health and Education Committee. "They are continuously thinking of other people's well-being, even before their own."

The distribution program was developed by the Middlesex County Public Health Department, but has since been adopted by the New Jersey Department of Health and Senior Services as a model to be used statewide. South Plainfield serves as the base for the program.

In the event of a public health emergency, more than 20,000 Middlesex County first responders and their household members would potentially receive the antibiotics. The First Responder Program is one of several elements within the County Public Health Department's Bulk Antibiotic Distribution Program.

Freeholder Christopher D. Rafano, chair of the County's Law and Public Safety Committee, explained that the recent exercise was a culmination of a training program that began in June to strengthen the county's first responder program.

"The exercise focuses on how we can protect our most important emergency asset, the emergency first responder," Rafano said. "This program protects them, so that they can protect all of us."
