

Democrats and Republicans Vie For Control of Borough Council

Number of Registered Voters Up 11.2% Over Last Year

In addition to next week's Presidential Election on Tuesday, Nov. 4, votes cast locally will have an effect on business in the Borough.

On the local level voters will decide the fate of the four candidates running for two available seats on the Borough Council.

Republican incumbents Matt Anesh and Rob Bengivenga are seeking re-election and Democratic challengers and newcomers Chrissy Buteas and Franky Salerno are hoping to unseat the two councilmen, who have both served one term. With this election, the voters have

the opportunity to sway control of the borough council.

Currently there are 14,349 registered voters in the Borough of South Plainfield; 4,393 Democrats; 2,222 Republicans; and 7,731 Undeclared. The number is an increase of 1,549

voters (11.2%) over the number of registered voters in November 2007.

Polls will be open locally from 6 a.m. until Polls are open 6 a.m. to 8 p.m. 8 p.m.

Due to the extremely large voter turnout anticipated, it is strongly recommended that voters go the polls as early in the day as possible and try to avoid voting after 7 p.m. when the longest wait is anticipated.

As long as voters are in line by 8 p.m. their vote must

be counted.

Polling places will be designated on sample ballots, which were mailed to registered voters on Tuesday, Oct. 28.

Builder: Bus Site Clean Up verstated

The cost of cleaning up the former Suburban Transit Corp. bus site has been a hot issue during the last month. Estimated cleanup costs-according to PMK Group, a consulting and environmental engineering firm hired by Middlesex County-may be as high as \$442,000. However, another environmental assessment completed in 2005 disputes the amount of contamination on the property.

After reading news articles concerning the purchase of the property located on New Market Avenue, local builder Larry Massaro has come forward to say the clean up of the

property may not be nearly as costly as reported, because he had already completed a Phase 1 cleanup on the property in 2005.

Massaro, owner of Lordina Builders, explained that he had a contract to purchase the property in 2005 for \$750,000. He made a \$10,000 down payment and performed a Phase 1 cleanup of the property. He then paid Terms Environmental Services, Inc. of Berkeley Heights \$15,000 to perform an environmental study to investigate specified areas of concern and provide a complete summary report of the results. He wanted to determine

the extent of remedial activities that would be required since he planned to build houses on the site.


Massaro asked Suburban Transit for an extension on his contract, but was refused. Shortly thereafter, the Borough purchased the property (Continued on page 11)

Former South Plainfield High School student Christina Martin, who graduated in 2005, helped bring the third presidential debate to Hofstra University's David S. Mack Sports & Exhibition Complex in Hempstead, Long Island. Christina is currently a senior Hofstra. The debate was broadcast nationally on October 15.

"In my sophomore year I was one of three students serving on the Board of the Middle States Commission on Higher Education when the Provost mentioned that Hofstra would be sending an application to the Commission on Presidential Debates and asked if anyone would be interested in being involved. I got involved in the application process," Christina said. Christina was notified of Hofstra's selection as the debate site when

she was in London during the first semester of her junior year. She learned of the need for volunteers to help with the project. "I knew



that this was something that would be exciting, but I didn't want to be on the floor with the debate. I knew that this was something I wanted to be part of by putting it all together," she explained.

Christina put her application/ resume together to be a volunteer and included a long list of her stu-

included being a delegate in student government. She was chosen out of the 300 volunteers to be one of three to work with the Commission on Presidential Debates at the media center and the Commission and the Secret Service to oversee the issuing of press credentials. "There were 3,100 press credentials issued. I was responsible for issuing credetials to members of the press as well as individual staff members of the McCain and Obama campaigns. I also gave credentials to the Hofstra Republican Group and every member of the Biden family," she said.

Christina was located in the media center separated from the debate. However there was a lot of activity in the hall where she met Caroline Kennedy, Bill Richardson and Mitt Romney while they were being interviewed. "I think that what was the most interesting was dealing with the individual members of the press. (Continued on page 10)



Tuesday is Election Day which is a legal holiday in our state. The library will be closed that day. Election Day was set by Congress as the first Tuesday after the first Monday in November (meaning the earliest date can be November 2). This year we are in the midst of one of the most exciting elections in decades. For the first time ever we have an African-American as a nominee for president and the oldest man to run for the presidency for the first time, if elected John McCain, would be 72 years and 144 days old versus Ronald Reagan who was only 69 on his inauguration day in 1981. Also for only the second time in American history is there a woman at the top of a major party ticket (Geraldine Ferraro ran as the vice-presidential nominee on the Democratic ticket in 1984).

The library has a lot more materials on presidential history and topics. Purple Ribbons Remind of Domestic Violence Month

October has been declared Domestic Violence Awareness Month. It is a time to recognized all of the important work done by domestic violence programs that need to continue the effort. All residents are urged to participate in the acknowledgement and support of victims and to focus on programs and continued to work toward improving victim safety and holding perpetrators accountable for their actions.

Battering is more than physical abuse. It is methods of domination enforced by violence in which all parts of a victim's life are subject to the batterer's control. In addition to physical abuse, it generally includes sexual, emotional and economic abuse. Batterers choose to cause fear, injury and/or pain in order to gain control.

The goal of the South Plainfield Domestic Violence Response Team is to provide services to victims designed to ensure their safety and access available resources. The team strives to create a safe haven where victim's questions can be answered and concerns expressed. They operate under the guidance of the Borough of South Plainfield Police Department. To con-

Please take notice of the purple ribbons tied around the trees in town. during the month of October. If one person is able to see her/himself in a controlling, violent and dominating relationship and realize the unhealthy and dangerous consequences most often resulting from these relationships, they are one step closer to making victims survivors and helping them take back control of their lives.

Council Tables Bee Ordinance By Libby Barsky

Borough residents have been keeping beehives in their backyards as a hobby without any restrictions describing the size of their property or the number of beehives allowed on it until the council introduced an ordinance on beekeeping practices two weeks ago.

The ordinance was the result of a complaint by Eleanor Painton about her neighbor's beehives in the adjoining yard. Painton was concerned about the possibility of a severe reaction to a bee sting her son may suffer if stung.

The second reading and final adoption of the beekeeping ordinance was to take place at the October 27 meeting of the Borough Council. Instead, the ordinance was tabled when Diane Sheaffer of 2529 Linden Ave., who is Painton's neighbor, asked that modifications be made to the ordinance. Sheaffer noted the ordinance allowed for only one type of beehive, the Langstroth type hive, with multiple removeable frames. Sheaffer said another type of hive, the Kenyon Top Bar Hive, was easier for hobbyists to take the comb out.

Sheaffer also disagreed with the policy declaring "all colonies shall be maintained with marked queens." Sheaffer pointed out that only purchased queens are marked. Wild queens are not. Sheaffer began beekeeping with a swarm that had left the wall of her friends barn and collected on the branch of a tree. She cut down the branch and started them in their own Langstroth hive, calling herself an organic beekeeper whose honey is given as gifts. "The bees in that swarm had

healthy genes. They had survived the mice and elements for over 30 years," she said.

Sheaffer has no problem with the provision to have colonies registered with the South Plainfield Health Department and pay an an annual permit fee of \$25 or forcing the bees to fly six feet above ground level by providing fencing or vegetation six feet high and extending 10 feet beyond the colony. Other provisions include two colonies on a 1/4 acre, four colonies on more than 1/4 acre and that hives be 200 feet in any direction from all property lines of the tract.

If compliance of the provisions of the ordinance aren't maintained, then the owner will be cited for violations and the hearing officer may have the bees destroyed.

A motorcyclist pinned underneath a van had to be extricated last Thursday afternoon after colliding with a van pulling into the parking lot at 340

According to South Plainfield Police under investigation. Traffic Safety Supervisor, Lt. Kevin Murtagh, Martin Alpert, 64, of South Plainfield was traveling on the southbound side of Lakeview Avenue passing stopped traffic on the left before the New Market Avenue intersection when he struck the van. After being extricated by the fire department, he was treated at the scene by Somerset Medical Center EMS and Muhlenburg Hospital paramedics. Alpert was then air-lifted by helicopter from the grounds of Our Lady of Czestochowa Church to Robert Wood Johnson University Hospital in New Brunswick where he was placed in surgical intensive care with multiple injuries.

Alpert sustained a serious back injury and was scheduled to be transferred to Kessler Institute for Rehabilitation in West Orange on Monday.




Middle School Peer to Peer recently collected 75 pairs of used sneakers and cleats to donate to the Perpetual Prosperity Pumps Foundation.

for \$750,000, putting \$75,000 in reserve for cleanup, netting Suburban \$675,000. He contends that according to his environmental study, the cost of cleaning the property is far less than the estimated \$442,000 reported by PMK. Massaro's cleanup was done before the buildings on the site were demolished, after a 3,000 gallon #2 fuel oil tank was removed in July of 2005. Soil borings were taken outside of the perimeter of the excavation to a depth of eight feet below grade and a second boring was taken in the center of the excavation to a depth of eight feet below grade. Soil and water tests showed no chemicals were detected except for naphthalene in the soil at a level of 263 ug/kg, and well within acceptable limits.

The environmental report recommended monitoring wells be installed. Massaro contends that all that needs to be done, if contamination is still found, is to remove the top three feet of soil, replace it with clean soil and that would cost around \$70,000, far less than the estimated \$442,000.

Massaro said his next step would have been to request a letter from NJDEP saying the site was clean, but since the property was sold to the borough, Massaro did not follow through.

In last week's Observer, we reported

that on December 5, 2006 the council approved an ordinance to purchase the property; however, that ordinance was not to purchase the property but to authorize the mayor and municipal clerk to execute an Open Space Grant and Conservation Restriction Agreement between the borough and Middlesex County for the purchase of the property.

"The report contains no cost estimates, but instead only details of what type of contamination was found. Our own engineers came up with a much higher cost than this man is claiming," said Councilman Rob Bengivenga after reading the report

"In my opinion, the report also does not include samplings that are as extensive as those done by the environmental experts hired by the county," commented Councilman Matthew Anesh.

As reported last week, it is still not clear as to why the borough signed a hold harmless agreement with Suburban Transit or why an ordinance and resolution to purchase the property had never taken place.

The Observer has made an OPRA request to the New Jersey Department of Environmental Protection to determine the status of the property and what permits have been issued. As of presstime, we have not received an answer.





ideas. For example, we want to rejuvenate our business districts, like those on Plainfield and Park avenues, and we want to make the compost and recycling hours more convenient for working parents.

Anesh pointed to traffic as another concern. "One of our first acts was to appoint a committee to look at getting trucks off Hamilton Boulevard and New Market Avenue. Regardless of what the partisans say, I'm proud that we appointed a bipartisan committee that included people from all parties, not just our own. We need to work together toward a solution."

"The committee has recommended Hollywood Avenue as the ideal route. Our goal now is to make Hollywood Avenue a reality," added Bengivenga. "But Hollywood Avenue won't be cheap. That's one of the reasons why we oppose extending New Market Avenue over the Superfund site. Doing that will cost more than \$10 million and expose us to environmental liabillywood Avenue, which won't be cheap.3

"We wish the other side had listened when for years we asked them not to put all their eggs in one basket with Helen Street," added Anesh, "but that's the past. Let's all get behind Hollywood Avenue now."

Anesh and Bengivenga also want to look for new routes that will reduce traffic other places in town. That's why the council paved Metuchen Road.


"People now have an alternate route to Edison, which will be especially useful when the county closes the Park Avenue bridge for reconstruction," said Anesh.

"Metuchen Road is not a major thoroughfare," explained Bengivenga, "but it takes several hundred cars a day off Oak Tree Rd. While our opponents have criticized this project, we think it was an innovative, low-cost solution."
