Matt Anesh Sworn in As 18th Mayor

Council Reorganizes... Borough Gets First Republican Mayor in 16 Years... McConville, Rusnak Sworn In... Barletta Fills Vacated Seat... Mayor Butrico Bids Farewell

Republican Matt Anesh was sworn in as mayor of South Plainfield at the January 2 reorganization meeting. Anesh will be the borough's first Republican mayor in 16 years. Also sworn in for a second, three-year term were Councilmen Tim McConville and Ray Rusnak. The 2011 council will be made up of a Republican mayor, four Republican councilmen and two Democratic councilmen.

The meeting began with the *National Anthem* performed by Taylor Kurilew. Rev. Charles Mingle offered the invocation. Outgoing Mayor

Charles Butrico gave a short farewell speech before stepping down.

Congressman Leonard Lance administered the oath of office to Anesh, McConville and Rusnak.

The council voted unanimously to appoint Alex Barletta to fill the council seat vacated by Anesh. He was sworn in by former New Jersey Governor Donald DiFrancesco, a partner in the borough's legal firm.

Ray Rusnak was unanimously elected to serve as council president and Di-Francesco gave him the oath of office. Mayor Matt Anesh presented Charles Butrico with a plaque of appreciation on behalf of the council. Butrico served four years as mayor.

The members of the council then voted on the contracts awarded, as well as all the mayoral and council appointments to committees and commissions. Democrats Chrissy Buteas and Franky Salerno voted against the appointments of April Bengivenga and Robert Bengivenga, Sr., citing relatives of council members shouldn't be appointed to boards or commissions. They also voted no to the appointment of a new insurance broker/consultant as well as the appointment of Glenn Cullen as PARSA Commissioner.

Mayor Matt Anesh gave the annual message, and Councilwoman Buteas gave the minority report.

Contracts were awarded to the firm of DiFrancesco, Bateman, Coley, Yospin, Kunzman, Davis, Lehrer, P.C.-borough attorney, T&M Associates-borough engineers and planners, Suplee Clooney & Coborough auditors, Thomas Lanza and

The council unanimously selected Alex Barletta to fill the unexpired council seat that was vacated when Matthew Anesh took the oath of mayor at Sunday's reorganization meeting. Last month, the Republicans announced the three candidates they would be choosing from—Alex Barletta, Bob Jones and Derryck White—and

they held off the announcement until the reorganization meeting. Barletta will serve for one year. A special election will be held in November to fill the seat for the remaining year on the three-year term.

Former Governor Donald DiFrancesco administered the oath of office to Barletta while his wife, Susan, and sons, Alex Jr. and Adam, held the bible.

In 2006, Barletta and Dave Sesok

were the Republican candidates for council, along with Robert Bengivenga, Jr., who was the Republican candidate for mayor. All three lost to the Democratic ticket headed by Charlie Butrico for mayor and Ray Petronko and Joe Scrudato for council

"When I ran in 2006, it was a great experience meeting so many people while going door to door. We worked hard and it was a tough loss," said Barletta

During the campaign for council, Barletta recalls talking about utilizing shared services to cut borough expenses. "There wasn't a recession then, but we were talking about the concept," he added.

As the newest council member, Barletta will be a member of the Shared Services Committee, along with Council President Ray Rusnak.

"I will examine Governor Christie's "tool kit" for shared services, and explore expanding some of the shared services with the Board of Education and possibly other municipalities," he said.

Barletta was appointed to a fouryear term on the Zoning Board of Adjustment in 2008. Members of the Zoning Board of Adjustment elected him vice chairman for two years–2008 and 2009–and chairman in 2010. He resigned as chairman prior to being (Continued on page 14)

Charlie Butrico said goodbye to politics after one term as mayor and nine years of service to the Borough of South Plainfield.

Butrico was elected to the Borough Council for two terms on the Democratic ticket prior to a successful bid for mayor in 2006. Two of the four years Butrico held the position was under Republican control of the council.

According to Butrico, some of his proudest accomplishments as mayor include improvements to Veterans Park, the installation of the turf field at the PAL building, acquiring and preserving over 100 acres of open space, performing weddings and being able to donate over \$20,000 to local charities, and keeping taxes affordable.

Among his other endeavors was the permanent banning of truck traffic in 2006 on the newly reconstructed Hamilton Boulevard.

Much of his mayoral campaign was based on extending New

County Unveils College Scholarship Program

Taking a page from recent announcements of public-private partnerships formed to improve education and job opportunities and building on a federal program that supports returning college students, Middlesex County Freeholder Deputy Director Ronald G. Rios unveiled plans for the Middlesex County Education Stimulus Plan.

Rios said the Middlesex County Education Stimulus Program would establish a public-private partnership to provide scholarships to 100 residents to attend Middlesex County College. Scholarships will include full tuition, a voucher for books at the college bookstore, application fees and counseling services.

The Middlesex County Education Stimulus Program will focus on adults returning to or beginning college to complete a degree for increased employability. Eligible students are high

school graduates who are at least 21 years old, who have been laid off for more than six months from a full time position or whose job has become obsolete.

Rios unveiled the county program on the heels of an announcement of a new partnership between Middlesex County College and the federal government. The federal government granted the school \$75,000 to provide free counseling for adults with at least 31 college credits who wish to return to school to complete a degree. The counseling services at the college's new "Center for Adults Returning to Education" will include support with the enrollment process, special workshops and tutoring and bookstore vouchers.

Rios said the County's Education Stimulus Program will expand the federal program by offering counseling to all 100 scholarship winners, regardless of how many college credits they have earned.

"We are very pleased to collaborate with the county to expand our CARE program to those with fewer than 31 credits," said Dr. Joann La Perla-Morales, president of Middlesex County College. "If they otherwise meet the qualifications, they'll be able to come to the college and receive services."

KC's Korner Dining Room **Reopens After 20 Years**

For more than 20 years, the dining room at KC's Korner held little more than a pool table and some tables with chairs. Now, after a more than a twoyear renovation project undertaken by owner Walter Kurilew, the bar and restaurant is open for business with a new chef, a new style and a new menu.

The Jagrah's Experience, featuring executive chef James Graham, has found a new home at KC's Korner, bringing world fusion dining to South Plainfield. A combination of Asian, Cajun, French and southern cuisine, Graham has perfected his niche by creating unique appetizers, soups, salads and entrees that include seafood, fish, chicken, lamb, steaks, chops and ribs.

Educated in Manhattan at the New York Food and Hotel Management School, Graham began his career as a sous chef at Top of the Sixes in Manhattan. He was also the executive chef at the Chart House in Weehawken and managed the dining room at the American Express corporate offices in New York City. The owner of a catering business of the same name, The Jagrah's Experience is based in Edison where Graham resides with his wife Stephanie, and three children, Christiana, 17, Jayson, 14 and Ethan, 6.

It was after a particularly difficult catering job that Graham and his staff stopped by KC's Korner to relax and have a drink. A conversation about the empty dining room ensued, which led to a meeting with Kurilew who ultimately brought Graham and his associates, Erika Lytell, Mathew DelValle and JoAnn Bruckman, to the bar/restaurant to manage the kitchen and the dining room.

Graham, who was raised in Bolton, N.C. by his grandparents, always knew he wanted to be a chef. "When I was growing up, I was the only boy in the kitchen. My grandfather wouldn't let anyone else in," he said. "I got my passion for food and cooking from my grandparents, Ishmel and Fronnie Mitchell.'

Among Graham's favorite dishes is his Lobster Martini appetizer: large



portions of poached fresh lobster on top of fresh Pico de Gallo and diced avocado served in a martini glass. Another favorite on the menu is the southern fried catfish. Blackened or fried, but not battered, the catfish filet is prepared with a dry rub and served on a bed of red beans and dirty rice with Cajun aioli. Not on the menu yet, but prepared as a special when available, is pan seared duck breast served with duck confit, lotus root, enoki mushrooms, tarro and chives.

New to KC's Korner in February will be Sunday brunch served from 11:30 a.m. to 7 p.m. The menu will include many breakfast favorites such as scrambled eggs, bacon and sausage as well as omelets and waffles made to order, sunrise potatoes, grits, chicken marsala and other entrees sure to entice even the most discerning palate.

The new dining room and renovated bar dining area at KC's Korner is open seven days a week for lunch and dinner. The Jagrah's menu will be served in both the restaurant and the bar, keeping the classics of KC's bar menu and adding new items soon.

Lunch will be served Monday through Saturday from 11:30 a.m. to 3:30 p.m. with dinner served Monday through Thursday from 4:30 to 10 p.m. and Fridays and Saturdays until 11 p.m.




Finally, I would like to thank my family and friends from the bottom of my heart for their moral support over these past years. Your support has been invaluable.

– Minority Address From – ouncilwoman Chrissy Butea

I would first like to congratulate Matt, Tim and Ray on their victories in November. You have been granted the greatest honor of any person, that of serving as an elected official.

As we move into a new year, it goes without saying that we have many challenges ahead of us in 2011.

Revenue is down, tax appeals are skyrocketing, our roads need resurfacing, our parks need to be rejuvenated, not to mention the need for a new library, additional recreation space and additional public safety equipment.

As you act to tackle these challenges, I encourage you to look at ways to budget for these expenses. I am concerned that the governing body is taking the easy way out and bonding for what I consider everyday expenses or non capital projects. Of course there are exceptions throughout any year, but what worries me is the overall trend. During 2010, the Republican Majority bonded for playground equipment, tax appeals, employee payouts, the paving of Cherry

Street, DPW apparatus, speed humps, essentially every project put forth. We need to tighten our belts and look for innovative ways to pay for these projects. No doubt, these projects benefited some, but at the expense of many.

I am never a fan of pointing out things I

question without offering solutions. I have offered these suggestions in the past, but will gladly offer a couple of the suggestions for cutting the budget to prevent the out of control bonding: reduce the fees paid to our professionals by 10%, fundraise for any new park equipment purchased, consider closing Borough Hall for one day a week during the summer months and I am sure there are many others we can discuss throughout the year.

Councilman Salerno and I look forward to working with this mayor and council for the coming year. We truly enjoy serving the residents of South Plainfield and will add constructive thought to the matters that

Mayor Butrico has dedicated his time and effort to the borough and championed many causes. His motivation has always been to do what's best for South Plainfield. Mayor, on behalf of the residents of South Plainfield, I wish you all the best in your future endeavors.

We welcome back Councilman Rusnak, now Council President Rusnak, and Councilman McConville. Your re-election victory is evidence of the voters' trust and approval of your performance as public servants. Continue to place the best interests of our town above all and you are sure to succeed over the course of your new term.

We also welcome Councilman Alex Barletta. Alex, the council looks forward to benefiting from your experience as Zoning Board chairman and as a business executive. Follow your instincts and you will serve the residents of the borough well.

2010 by all counts was a challenging year for the nation, the state, municipal governments and families everywhere. Economic challenges continued to present themselves in the form of high unemployment, layoffs, furloughs, a depressed real estate market and rising costs to Americans everywhere. The excesses of past administrations and the current economic climate forced Governor Christie to reduce aid to municipalities across the state in 2010. The fate of municipal aid for 2011 is unclear.

However, in spite of these tough challenges the 2010 governing body was able to introduce a budget with some bipartisan help that included a \$178 municipal tax decrease for the

average South Plainfield resident. In fact, the adopted budget was smaller than each of the budgets from the previous two years. Municipal spending was reduced without cutting essential services that our residents rely on, or borough wide events such as the Labor Day parade and fireworks.

We trimmed the size of the borough workforce by more than a dozen spots through attrition and reorganization. We sought and found innovative ways to reduce costs for basic services, such as utilizing competitive bidding for recycling services that in the past were simply contracted through the county. We saved over \$200,000 by refinancing borough debt and taking advantage of an improved bond rating for the municipality. This was at a time when, according to one statewide newspaper, most towns in the state saw their bond ratings downgraded. South Plainfield was one of a select group of municipalities to see their bond rating improved during a period of historic economic strain.

In a bipartisan effort led by Finance Chair Ray Rusnak, the borough council was able to eliminate a \$100 increase in school taxes without affecting vital programs. In fact, the revised school budget passed the council with a unanimous vote. We invested in our town infrastructure with the completion of Stage 1 of the New Market Avenue reconstruction project. Cherry Street was fully repaved after decades of neglect. We provided the Department of Public Works with the necessary equipment to complete their vital jobs. The Safe Streets, Safe Kids program was expanded through the approval of resident petitions for speed tables on Cherry and Walnut streets. But we know our work is never complete.

In 2011, this governing body will once again need to navigate through a challenging economic climate to deliver vital services to our residents while controlling taxes and spending. I'm eager to work with our Finance Committee and Chief Financial Officer Glenn Cullen to introduce a budget that holds the line on taxes and spending. To do so, we'll be working with our municipal workforce to finalize labor contracts that balance their needs with the realities of today's economic climate and a newly introduced 2% budget cap. We'll continue to look to streamline borough government where possible and seek savings from all borough departments.

Aside from fiscal challenges, I encourage this governing body to continue to oppose over development and high density projects that will strain our schools, borough services and infrastructure. I know it took courage, but the right decision was made in December 2009 to oppose the pending developers agreement that would have paved the way for an additional 700 units in South Plainfield. We can't correct the mistakes of the past but we must remain dedicated to preventing them in the future and protecting the small community atmosphere that is South Plainfield.

Much has been accomplished with the Hollywood Avenue Extension. We are on the verge of filing an application with the New Jersey Department

of Environmental Protection. As this project enters a new stage the need for increased council oversight and management is warranted. Today, we welcome Jake Cataldo to the Ad hoc Truck Committee formed by Council President Bengivenga in 2008. Mr. Cataldo long ago saw the potential of Hollywood Avenue as a viable alternative for truck traffic in South Plainfield. Councilman Bengivenga will also take the lead as council liaison to the Ad hoc Truck Committee. I look forward to working with Councilman Bengivenga, the committee, our state government, the Christie Administration and the entire council to see this project progress. Make no mistake about it, we expect opposition and know that great challenges still lie ahead. However, if we as a community continue to unite behind the effort, we can overcome the obstacles

In late 2010, the governing body was presented with the findings and recommendation of the library committee. I ask the council president to formally authorize the committee as a council committee. I look forward to working with the council, library board and committee to advance the planning for the future of South Plainfield's public library.

In addition, I encourage the governing body to continue to expand the Safe Streets, Safe Kids program. By leveraging enhanced road markings, improved signage, speed tables, raised crosswalks and enhanced radar tools, we can continue to improve the safety of our residential streets. I've identified the area of Cady Lane, which encompasses our community pool and Police Athletic League as a priority zone for safety improvements. I've directed the council and our engineer to look into improvements that will increase pedestrian safety in the area. Additionally, we must continue to invest in our public safety departments to ensure they have the tools necessary to protect our borough. To that end, just last week I submitted a request to Bill Baroni, the deputy executive director of the Port Authority of New York and New Jersey for First Responder Funds offered by the agency.

Investments made over the last several years continue to pay dividends, allowing us to maintain our parks for thousands less than contracting for basic borough services. Please work with our department heads, grant coordinator and administrator to identify grants, state and federal funding that will assist us in reaching our goals while maintaining our fiscal focus.

Last but certainly not least, I encourage this council to work together on a bipartisan basis. You have my word that I will work with each member of this council to advance initiatives that put the interests of our residents first. My door is always open and I encourage your thoughts and ideas. It's clear to see that 2011 will be a challenging year, however I'm convinced that if we work together we can accomplish great things.

Again, thank you for providing me with the opportunity to serve as your mayor. I want to thank my wife Kimberly, sons Harrison and Joseph, my parents, brothers, sisters, in-laws, nieces, nephews and friends for your support. Without you, nothing would be possible.

Thank you all for coming today, best wishes for a happy and healthy 2011. May God continue to bless you and your loved ones, our town and these United States.

Principal Dedicated to Student Achievement Retires

After a 42-year career in the South Plainfield School District, Middle School Principal Steven Novak retired from his position on July 1.

Novak began student teaching in the borough in 1968; the following year he was hired as a U.S. and world history teacher at the high school. In the 1970s he pioneered the government and law curriculum, which is still in place today.

After becoming an assistant principal at the high school, Novak instituted the "four A's": academics, athletics, arts and activities, something he believes every student should benefit from and strive for. In 2005 he was named principal of the middle school.

Passerby Discovers Decomposing Body in Van on Metuchen Road

A decomposing body was found in a white 1992 Ford Econoline van on Metuchen Road on the border of South Plainfield and Edison on July 15. It is being investigated as a fatal one car crash police believe happened six days prior.

A witness told police that they had noticed a vehicle in the woods off to the side of Metuchen Road on July 10, but thought nothing of it while driving past. According to Sgt. Dominick Masi, commander of the Edison Township Serious Crash Investigation Team, the witness noticed the same vehicle in the same position while driving on Metuchen Road on July 15. After pulling over and walking towards the van, the witness smelled a strong, foul odor, and as they got closer, saw a body slumped over the steering wheel.

The unidentified body was severely decomposed and no cause of death was determined.

OSHA Fines Sodexo For Safety Violations In Schools

The South Plainfield school district's maintenance provider, Sodexo, was fined \$8,100 by the Occupational Safety and Health Administration (OSHA) for nine serious safety hazards that endangered workers and could have potentially harmed students.

OSHA cited Sodexo for failing to assure that workers received adequate training, protective equipment and labeling information when using dangerous chemicals. They also cited Sodexo for unsafe storage of flammable and combustible liquids, failure to guard live parts of electronic equipment, and requiring workers to operate industrial trucks without testing their ability to do so safely.

The nine violations OSHA found at the schools were classified as "serious," meaning there was substantial probability that death or serious injury could occur from a hazard about which the employer knew or should have known.

Mayor Butrico Named Labor Day Honorary Grand Marshal

The South Plainfield Public Celebrations Committee chose Mayor Charles Butrico as the honorary grand marshal for the 53rd annual Labor Day Parade to be held on September. 6. Not only has Butrico been mayor of the borough since 2006, but he has served the community in various areas of civic service in tandem with his political aspirations.

Butrico is a lifelong resident who began volunteering his time coaching t-ball and softball for his three daughters, Dana, Kristie and Michelle, who are now grown. In 2001 he ran for public office and was elected to the borough council, and he was reelected in 2004. He has remained a member of the Planning Board, Business Advisory Group and Economic Development Committee since 2002. A devoted Catholic, Butrico spends a good part of his spare time as a member of the Knights of Columbus doing charity work.

Kevin Hajduk Appointed Middle School Principal

Kevin Hajduk, assistant principal of South Plainfield Middle School, was appointed middle school principal, replacing Steve Novak, by the Board of Education at a special meeting

held on July 28. He had been the assistant principal at the school since 2008. Hajduk holds an Educational Leadership and Educational Specialist certification from Seton Hall University. He is 12 credits away from receiving a Ph.D. in educational leadership.

Hajduk, a 1995 graduate of South Plainfield High School, was Novak's Social Studies student. "Novak was a great teacher. He was the kind of teacher in high school that you couldn't wait to get to class because he always had some sort of hook to catch your attention, to get you engaged," recalled Hajduk.

He began his career in 2000 teaching special education at Roosevelt School after graduating from East Stroudsburg University in Pennsylvania. In his junior year in college he, along with Addison Williams, coached students for Special Olympics events held every June in Trenton. Hajduk is still associated with the Special Olympics.

Council Approves Amended Budget

The 2010 calendar year budget, which received final approval by the Borough Council, boasts a \$178 tax decrease and 1.226 tax rate for the average home in South Plainfield assessed at \$122,400. Councilwoman Chrissy Buteas was the lone dissenting vote. Councilman Franky Salerno was not present.

Even though state aid was down \$682,703, the municipal budget totaled \$25,966,432 compared to the 2009 calendar year budget of \$26,228,607.70. The 2008 calendar year budget of \$26,284,414.63 was the first year Republicans had control of the council in a decade.

Acting Chief To Retire

After four months as Acting Chief of Police Paul Brembt officially retired from the force effective April 1, 2011. His last active



day was September 10. Brembt took over former Police Chief John Ferraro's position on April 16, who retired after 28 years.

Brembt is

a 25-year veteran of the South Plainfield Police in promoted to the

Department, having been promoted to the rank of captain in 2005 and commanding the Patrol Division, Detective Bureau and Staff Services. He is also the department's grant writer and a community policing

advocate who headed up the local women's domestic violence volunteer group.

Captain James Parker, who was promoted on April 19 following Brembt's appointment to acting chief, will take the title of "provisional chief" as of September 10 at a pay rate of \$73.03 per hour.

School Board Appoints New Law Firm

The Board of Education voted 7-1 to replace its legal counsel, Schwartz Simon Edelstein Celso & Zitomer of Morristown, and appoint the law firm of Schenck Price Smith & King, also of Morristown, during a special meeting held August 3. The board has worked with attorney Nicholas Celso and his firm for many years. "It was a tough decision," said Pio Pennisi, vice president of the board.

According to Pennisi, the board took this action in order to retain three attorneys—Mark Zitomer, Joe Roselle and Robin Ballard, a special education attorney. The three had worked closely with the board for the past three years and recently joined the newly appointed law firm.



Richard Costello Named State Trooper of the Year

Det. Richard Costello, a resident of South Plainfield, was honored by Congressman Leonard Lance and the Borough Council at the August 16 meeting for his recognition as 2009 Trooper of the Year, one of the most prestigious awards given by the New Jersey State Police.

Congressman Lance presented Costello with a flag that was flown over the U.S. Capitol. Mayor Charles Butrico presented him with a proclamation on behalf of the mayor and council. Butrico said he was doubly honored since he was the one who performed Costello's marriage ceremony a few years prior. He and wife, Rianna, reside in South Plainfield with their two children.

Negron Appointed Interim High School Principal

In a surprise motion made by Board of Education member Debbie Boyle at the August 18 Board of Education regular public meeting, Superintendent Jose Negron was appointed high school interim principal until the position can be permanently filled.

First Baptist Designated Oldest Church

The First Baptist Church of South Plainfield held a dedication ceremony on September 19 after it received an historic marker as a gift from the Middlesex County Board of Chosen Freeholders.

Located at 206 Hamilton Boulevard at the intersection of Church Street, the church has the distinction of being the oldest religious institution and church building in the borough.

According to local historian Larry Randolph, local Baptists founded the church in 1792 and named it the Samptown Baptist Church. The first church building was constructed the same year outside the colonial hamlet of Samptown on what is now Hillside Cemetery on New Market Avenue. A larger structure was built there in 1832 which was destroyed by a fire in 1879.

School Board Ousts Superintendent

The Board of Education (BOE) voted 5-0 to place Superintendent of Schools Jose Negron on paid administrative leave until further notice at a special meeting held September 30. Negron had come under fire as interim high school principal recently by SPEA Vice President Diana Joffe for instituting new practices at the high school and shutting out teachers from the process. He had also been at odds with the BOE in respect to his recommendations for interim principal and his overall lack of communication with members, employees and the public during his tenure.

Elementary Music Lessons Eliminated

Acting Superintendent Dr. Lorraine Cella announced that third grade students will no longer receive string instrument music lessons, and the district will no longer provide band lessons for fourth graders; however, each K-4 school will have its own full time music teacher for weekly class instruction.

Cella explained that the decision included input from the music staff and principals. They worked "many hours examining schedules and discussing optimum learning opportunities for your child's music lessons without pulling them out of language arts and math."

Instrumental and band lessons will still be offered, commencing in fifth grade, where Cella says, it is "a time when students are ripe for band instruction." All instrumental lessons in the remainder of borough schools will go on uninterrupted.

Matt Anesh will vacate his council seat in January when he is sworn in as mayor, and the Republicans will name someone to fill his seat until the next election.


A total of 6,218 of the 14,087 registered voters (44%) cast their votes on Tuesday, down from last year's turnout of 46%.

Report Shows Significant Drop In School Violence and Vandalism

For the past five years vandalism at district schools, as well as the cost of repairing the damage, has declined from a high of 46 incidents of vandalism in the 2005/2006 school year to six as reported in the statemandated Violence and Vandalism Report for 2009/2010. Ten vandalism incidents had been recorded in the previous school year, 2008/2009. The report was released at the October 27 Board of Education meeting.

Costs to the district have decreased from a high of \$23,651 five years ago to repair 13 vandalism incidents in 2005/2006 to \$450 for two vandalism incidents in 2009/2010 compared to last year's cost of \$2,479.

Two Arrested In Burglary

Two Staten Island men were arrested and charged with burglary and possession of burglary tools on November 8. Louis Scala and Jason Reiff are being held at the Middlesex County Adult Correctional Facility in lieu of \$50,000 bail with no 10% option.

The arrests are the result of the South Plainfield Police responding to the 100 block of Pomponio Avenue on a possible burglary in progress report. As police units arrived, Officer Fusaro observed a silver vehicle leaving the area and proceeded to make a motor vehicle stop. The suspects were detained and arrested a short time later.

Franklin students wore an array of red, white and blue. The younger students made hats decorated in the American Flag colors. Students filled the center area of the gym while the guests of honor–veterans of all ages and areas of our country's armed forces–were seated on the stage.



Middle School Cross Country Teams Take First and Second at GMCs

The Girls Middle School Cross Country Team was declared best in the county for the first time in school history. The Lady Tigers outpaced all of their competitors in order to finish first at the Greater Middlesex Conference Championships on October 30. In a tight race, the girls narrowly defeated Crossroads Middle School of South Brunswick, 67-66, avenging their dual meet loss the week leading up to the championships.

In the boys race, the tenacious Tigers were powered to second place by their talented team. The boys also took home a trophy for third place in the novice race.

The Board of Education appointed Nicholas C. Puleio interim business administrator to replace Richard Guarini.

Puleio started on November 29 at a salary of \$600 a day. The board also appointed him Affirmative Action Officer for Equity in Employment Practices and Public Agency Compliance Officer, the liaison official with authority to make corrections to the district's Affirmative Action contracting procedures for matters concerning P.L. 1975 C127. He was also appointed custodian of school records, purchasing agent, food service representative and special education-Medicaid initiative co-coordinator.

Taxpayers to Borrow \$590K to Fund Tax Appeal

The Borough Council introduced a \$590,000 bond ordinance to pay for a large tax appeal settlement with BIT Holdings Fifty Three, Inc., owners of property located at Park and Oak Tree avenues, which includes the years 2008, 2009 and 2010. The three-year bond will cost the average taxpayer approximately \$16.50 a year.

GOP Nominates Three to Fill Vacant Council Seat

The South Plainfield Republican Organization announced that they will choose from three of their members to fill the council seat vacated by Council President Matt Anesh when he is sworn in as mayor at the annual reorganization meeting on January 2.

The nominces are Bob Jones, a former BOE member and party chair and current Zoning Board of Adjustment member; Alex Barletta, Zoning Board chairman; and Derrick White, Republican Committee member. (Continued on next page)

Residential Sewer Rates To Rise 8.6%

The Borough Council introduced an ordinance at its December 6 meeting increasing the fee structure for the Middlesex County Utilities Authority (MCUA) residential, commercial and industrial users. Homeowners will see their bill go up 8.6%, from \$290 to \$315. The minimum commercial rate will be \$580, a 10% increase.

Voting in favor of the increase were Republicans Matthew Anesh, Rob Bengivenga, Tim McConville and Ray Rusnak. Councilwoman Chrissy Buteas voted against the measure. Franky Salerno was not present.

According to Borough CFO/Administrator Glenn Cullen, the increases are due in part to the reduction of industrial customers who went out of business.

Frank Cocchiola, Jr. as interim assistant superintendent of instruction and operations at the December 15 meeting.

Cocchiola began work on December 16 at a rate of \$575 per day. He replaces

Dr. Lorraine Cella, who will leave the district on December 30 to take the position of Edgewater superintendent of schools.

Cocchiola is currently an adjunct professor at both Felician and Caldwell colleges.

Weekend Blizzard Blankets Borough With Two Feet of Snow

The borough received a little over two feet of snow, which began early December 26 and continued overnight and into the next day during a weekend blizzard. The Department of Public Works (DPW) crew arrived at 5 p.m. on Sunday and worked 23 straight hours. "This was obviously not a typical storm," said CFO Glenn Cullen.

Over the course of the storm, the DPW dropped nearly 250 tons of salt on roadways. The town is separated into 13 plowing districts and two plows are utilized in each one.

Giant elves (parent volunteers) manned the booths and the food table. Pajama-clad Mayor-elect Matt Anesh took a turn at serving ice cream.


The highlight of the evening was the arrival of Santa Claus. Children lined up to tell Santa their Christmas wishes and have their photos taken.



"Being on the Zoning Board was a great experience for me and I enjoyed every meeting. I can't say enough about the dedication and commitment of my fellow board members. When you drive by something that you have approved and you see it come to completion, you have the feeling of being part of something that has a positive impact for the town," said Barletta.

He received two council appointments during the reorganization meeting-Planning Board Class III Council liaison to the Planning Board and also Planning Board liaison to the

Market Avenue through the then yetto-be demolished Cornell-Dubilier Superfund site so that trucks may safely pass through what he termed a "less residential" area of town. The Republican council members opposed the idea, and when they took control in 2008 spent much of the year attempting to pass ordinances to repeal the ban. They claimed that Hamilton Boulevard was rebuilt specifically to accommodate trucks, therefore they should return to that route. Butrico's vetoing of the ordinances stalled the GOP attempt until the next election year when the Democrats once again regained control of the council.

Throughout that time, Butrico worked closely with the N.J. Department of Environmental Protection (DEP); the Cornell-Dubilier site has since been torn down and remediated.

The New Market Avenue extension opened for trucks this summer and plans for building along the new road are in the early stages.

The Helen Street extension project was a pet project of Butrico's during his council days; he spent many hours trying to improve truck traffic in the borough. However, after 10+ years, Butrico's hopes of having a truck route on the outskirts of town was put to rest when the project was stalled at the N.J. DEP. Seeing the need to continue to search for an alternate solution, Butrico appointed then Senior Center Director Joann Graf to head up the Ad hoc committee to investigate other solutions. After nearly three years the committee has redirected its efforts toward extending Hollywood Avenue. The engineering phase is almost complete, and permits for the proposed roadway are expected to be submitted to the N.J. DEP shortly.

Also on his list of accomplishments is getting the Rt. 287 exit corridor cleaned up (the proposed future site

of Progressive Insurance). More recently, Butrico chaired the Library Committee to seek a new, larger facility. His party's plan to

build a new library during his tenure was stalled after the GOP members initiated a Democracy Week in 2008 which was not received well by voters. The new committee findings were announced at the November 22 council meeting when Butrico enthusiastically laid out plans for expanding the current library. Funding for the project, as well as approval of the Library Board, will have to be secured.

When not embroiled in heated battles on the dais, Butrico enjoyed his role as mayor reading to school children for Dr. Seuss's birthday, attending Boy and Girl Scouting events, throwing out the first pitch at the opening days of the Junior Baseball Club and Ponytail Softball games and attending the annual Memorial Day services held throughout the borough each year.

Butrico has fond memories of being inducted into the South Plainfield High School Hall of Fame in 2009 and was honored to be named grand marshal of the 2010 Labor Day Parade. Another unforgettable experience he says was being invited to spend an afternoon with the National Guard in Florida before they were deployed

Aside from politics, Butrico spends his time doing charity work with the Knights of Columbus. He can always be seen cooking and serving meals at the Lenten fish dinners at Sacred Heart, the Don't Cook Friday spaghetti dinners, helping out at Trivia Night, the Special Citizens Drive and the annual Christmas party. Butrico also volunteers at the annual Feast of St. Anthony at Our Lady of Czestochowa Church, town wide cleanup day each spring, Sacred Heart Church Special Liturgy lunch and the Keystone Community.

Butrico was a producing board member for Summer Drama Workshop from 1998 through 2001. He has been a member of the planning board, Business Advisory Group and Economic Development Committee since 2002. He coached t-ball and softball for his three daughters, Dana, Kristie and Michelle, who are now grown up.

A graduate of Rutgers University, Butrico is currently employed as an account executive for Computer Sciences Corp., a Fortune 200 company, and one of the world's largest and most respected providers of information technology services.

As for the future, he plans to stay involved with the library committee as much as possible.

"I am somewhat saddened to be stepping down as mayor as I have truly enjoyed working for the people of South Plainfield and trying to improve our community," said Butrico, as the end of his term grew near. "I say thank you to all the residents of this wonderful town for allowing me the opportunity to serve you during these past four years. I have enjoyed working on your behalf."

At his Inaugural Address in January 2007 Butrico said, "Only in America can a young boy or girl tell his or her playmates, I am going to grow up to be mayor' and actually have that dream come true."

Welcome to a New Year! The South Plainfield Public Library is on track for another exciting year.

First of all our new circulation system is going great. It allows you to log in to check your account, place holds, renew materials, etc. There is an additional feature in this system which allows you to place a hold on materials which are listed as 'available.' Theoretically, these materials are on the shelf and we will put them on the request shelf for you. However, as with holds for materials which are checked out, a .50 fee will be charged to your account for each item held.

Speaking of renewing materials, that is just one way. You can also call the library while we are open or call our automated renewal system (ELVIS) at (908) 757-3280. If you choose either Elvis or online renewal you will need your library card (and with Elvis you will need the materials you are renewing so that you can read the barcode). Also, please remember our fines for overdue video materials are \$2/day. This means if you have four items out and return them one day late you will have an \$8 fine on your card. The library would rather not have to charge anyone late fees so please renew any items.

Furthermore, please check out all the databases to which the library subscribes. These can be accessed through

our website at www.southplainfield. lib.nj.us and include everything from testing sites (ASVAB, GED, GRE, etc.) to downloadable audiobooks and ebooks (ListenNJ). If you had to access these websites on your own they would cost you money, but the library subscribes to them so you get them for free.

Don't forget all the children's programs with Miss Mija and Miss Linda. Programs for three and four year olds and up are held Tuesdays at 10:30 a.m., Wednesdays at 6:30 p.m., and Thursdays at 1:15 p.m. "Time for Twos and Threes" is held Wednesdays and Thursdays at 10:30 a.m. and "Books and Babies" is held Fridays at 10:30 a.m. All programs are free and no registration is required; however, it is important that you arrive at least a few minutes before the program begins in order for Miss Mija and Miss Linda to create name tags and for your child to get the most out of the program. It is best if parents/ guardians remain in the room for the two and three year old programs, but for older children, Miss Mija and Miss Linda just request that they remain in the building. We will be announcing in this column all the guest entertainers they will have over the next year.


