## Heroes & Cool Kids Present Bullying Program

The South Plainfield High School Peer Leadership Heroes & Cool Kids spoke to Grant School sixth grade classes about bullying and sportsmanship on March 23. The Heroes & Cool Kids mentor, former L.A. Lakers basketball player John Celestand,

accompanied the peer leaders as they presented the "B's" of bullying; if you are the bully stop, if you are being bullied get help immediately and if you are a bystander then get someone to help the victim. Students were also encouraged to confide in the principal or assistant principal about bullying issues and to feel confident that they will assist them.

Heroes & Cool Kids, which began operating during the 1998/99 school year, is a nonprofit organization based in New Jersey. The program utilizes

the services of current and former professional athletes whose personal life experiences enable them to train high school student leaders. The high school students then mentor middle school aged students on important life skills including sportsmanship, conflict resolution and positive lifestyle choices highlighting drug, alcohol and tobacco prevention.

To prepare, high school students must complete three training conferences before mentoring students.

## Suspect Apprehended In Pharmacy Burglary

Local police responded to Twin City Pharmacy on Park Avenue at 11:19 p.m. on March 25 on a reported burglary. Upon their arrival, officers found the lower portion of the front door smashed. It was determined that someone had entered the pharmacy and removed a bottle of prescription pain pills. The bottle contained 500 Tylenol with codeine pills.

Earlier the same day, Yu Z. Lin, 22 of Clark, attempted to obtain Tylenol

with codeine from the pharmacy, utilizing a forged/altered prescription. The prescription was not filled and Lin left the scene.

On March 30, Lin was arrested at his home. He was charged with burglary, forgery, criminal attempt and possession of a controlled dangerous substance. Lin was positively identified as the person who attempted to pass the forged prescription and the burglary at Twin City Pharmacy.

Lin was held on \$35,000 bail.

## Middle School Peer Leadership Participate in Food Drive

For the second year, the South Plainfield Middle School Peer Leadership students participated in the Middlesex County Food Organization and Outreach Distribution Services (M.C.F.O.O.D.S.) spring school food drive from February 28 to March 11. M.C.F.O.O.D.S. was created by the Board of Chosen Freeholders in 1994 to help ensure that an adequate supply of nutritious foods and necessities are readily available to Middlesex County

residents in need at all times. Their food distribution network serves over 70 local food pantries and soup kitchens throughout the county.

## District to Comply with Audit of Federal Funds

The Board of Education is facing the possibility of having to return \$24,880.86 to the N.J. State Department of Education. An A2008-2009 No Child Left Behind Title I Audit conducted by the Office of Fiscal Accountability and Compliance in February disclosed the BOE inap-

propriately used \$24,880.86 of Title I allocations.

After accepting the corrective action plan resulting from the audit on March 16, the board voted to appeal a portion of the amount. According to Interim Board Secretary/Business Administrator Nicholas Puleio and

Interim Assistant Superintendent Dr. Frank Cocchiola, there is evidence of "adequate documentation for expenditures for purchased services totaling \$9,521."

According to Cocchiola, the district should learn in six weeks whether the appeal is accepted or denied.

## Volunteers Sought to Clean Up Litter

The South Plainfield Clean Communities Advisory Board has been contacting volunteer groups, asking for participation in Volunteer Litter Cleanup Week. This year's cleanup week will run from Saturday, April 23 through Saturday, April 30.

The big pickup day is scheduled for April 23. Volunteers will pick up equipment and assignments from the municipal building at 2480 Plainfield Ave. from 9 to 10 a.m. Roadsides, parks, streams and vacant lots will be targeted. Volunteers must provide

their own transportation to cleanup locations. Bagged litter does not have to be brought back; it can be left along the roadside for collection by the road department.

Volunteers are invited back to the municipal building at 12:30 p.m. for a pizza pickup picnic, complete with environmentally-friendly door prizes. Organize a crew, or come on your own.

As president of the Library Board of Trustees, I feel that it is necessary to clarify some of the information which was contained in the article that appeared in the April 1 edition of the *Observer* concerning the introduction of the 2011 municipal budget. Specifically, I am referring to the \$750,000 which the borough is anticipating as surplus revenue as the "library contribution."

I had the opportunity to address the council prior to the introduction of the budget, inquiring as to what the "contribution" was. Neither myself nor any other member of the Board of Trustees was aware that we were making a "contribution" until about 10 a.m. of the morning that the budget was being introduced, and even then, through a third party. No one in the administration had the decency or the courtesy to advise the library board that the borough was taking the \$750,000. When I asked Mr. Cullen as to the authority to take the money without the consent of the library board, the article correctly reported that he responded, "It's the law."

What the article failed to indicate and what Mr. Cullen failed to address, is the statutory procedure set forth in that law. As an initial matter, the statute that was enacted last year does require that excess funds be transferred to a municipality. "Excess funds" are any funds which exceed the operating expenses of the last audited year, plus an additional 20% of those expenditures which the library board must keep as surplus. The law further provides that "funds restricted for capital projects and grants" are specifically excluded from the monies which are turned over to a municipality.

The library board, through careful budgeting and responsible spending over the past 15-20 years, has managed to save funds, the use of which has always been intended for a new building. Last July, as required by the new law, the library board designated those funds as its "Capital Reserve Fund." In December, the library board transferred \$750,000 to that fund in anticipation of the negotiations that it would be entering into with the borough for a new library and with the knowledge that the library board would have to bear a significant part of the cost of any new facility. This is, apparently, the

\$750,000 "contribution" that the borough has anticipated in the proposed 2011 budget.

The statute under which the borough has taken the \$750,000 requires a three-step process. The first step is a resolution of the library board (not the council) of its intent to transfer excess funds to the municipality. The second step requires that the library board submit this resolution and certain reports and documents to the state librarian for review and approval. Once the state librarian receives the required information and documentation, she, in conjunction with the Division of Local Government Services, has 45 days to review the information and make a determination whether to approve or deny the transfer. Depending upon the decision, either the municipality or the library board has the right to file an appeal.

None of the required steps have been taken. For the borough to anticipate the \$750,000 "contribution" at this point in time is premature at best, and political at worst. Furthermore, to not even notify the library board that it was taking this action, particularly at a time when the trustees have entered into negotiations with the borough to get a new library, has to call into question the good faith of the administration in those negotiations.

It is difficult to be a team player when one member of the team doesn't tell another member what it is doing. Despite this, the library board is committed to moving forward to bring a modern state-of-the-art library to South Plainfield.

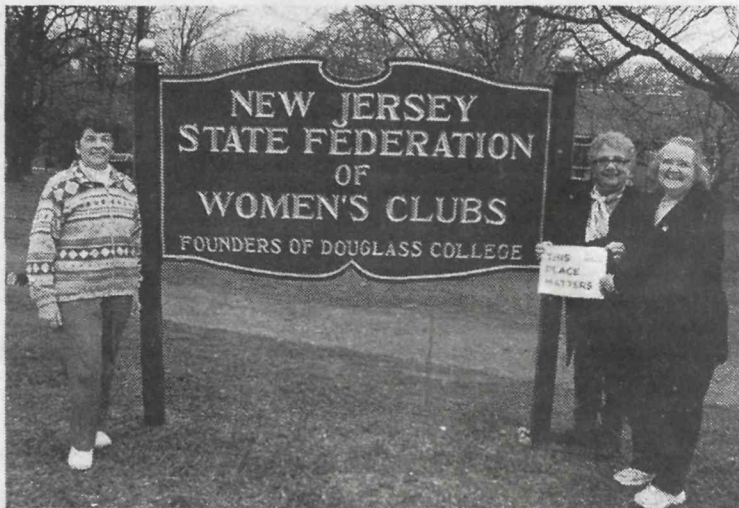
Five members will be attending the College District Spring Conference/Achievement Day to be held on Wednesday, April 27 at the Imperia in New Brunswick.

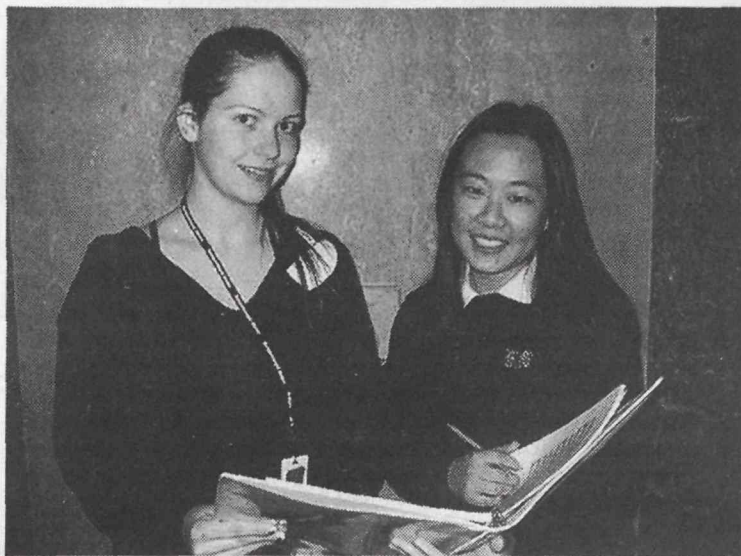

## Mt. Saint Mary Students to Perform in Children's Opera

South Plainfield residents Renee Parisi and Kristen Shiu, students at Mt. Saint Mary Academy in Watchung, have been rehearsing for the Tuesday, April 12 "Evening of Roses" production of the children's opera *Brundibar*. Kristen will play the role of the Sparrow in the production.

The Evening of Roses is the annual fundraising benefit for Seton Hall University's Sister Rose Thering Fund for Education in Jewish-Christian Studies. Conducted by New Jersey Opera artistic director Jason Tramm, directed by Daniel Neiden and orchestrated by Charles Czarnecki, *Brundibar* was written in 1938 and performed in 1943 and 1944 by the children incarcerated at the Nazi concentration camp, Theresienstadt.

At the April 12 event, held at South Orange Performing Arts Center (SOPAC), Holocaust survivor Ela Weissberger, one of the child Theresienstadt *Brundibar* performers, will be presented with the 2011 Seton Hall Humanitarian of the Year award.

The Sister Rose Thering Fund was established to perpetuate and extend

the inter-religious education work of Sister Rose in funding graduate scholarship assistance for teachers in Jewish-Christian and Holocaust Studies, developing teaching resource materials and presenting workshops for teachers in public, private and parochial schools.

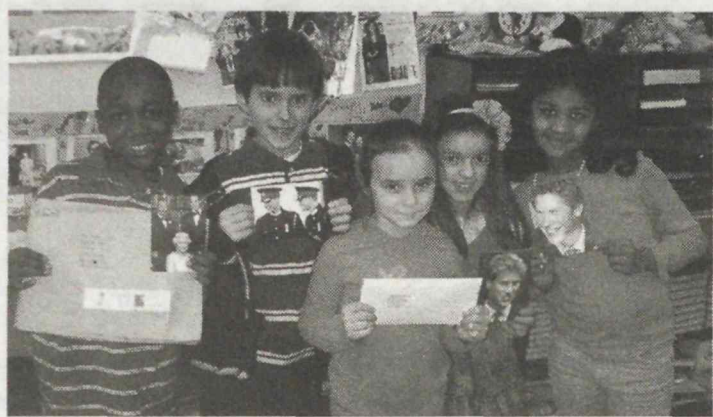

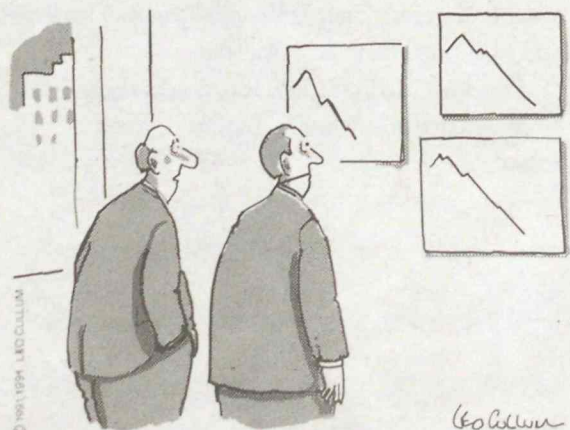

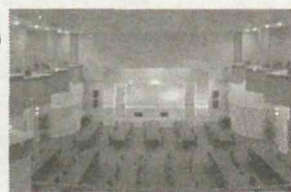

# Jackie Jackson Named Social Worker of the Year



Jackie Jackson will receive the award for National Social Worker of the Year this month.

Jacqueline "Jackie" Jackson will travel to Washington, D.C. this month where she'll be the first ever recipient from New Jersey to receive the award for National Social Worker of the Year from the National Association for Social Workers (NASW). The NASW's local New Jersey chapter also named Jackson as 2010 Social Worker of the Year.

Multiple Sclerosis weakened Jackson's muscles and left her unable to walk by her mid-30s. Battling sarcoi-

dosis, multiple sclerosis and fibromyalgia, Jackson admits she's not without difficult days, but her disability propels her forward.

Jackson met President Obama at a rally prior to his election. Last July she was invited to the White House for an event commemorating the twentieth anniversary of the Americans with Disabilities Act.

Since retirement is not a word in Jackson's vocabulary, she decided to pursue her education. Jackson entered Rutgers University in 1986 and earned a bachelor's degree in African studies, then completed a master's degree at the School of Social Work.

She also advocated for additional handicapped parking spaces and rest rooms and challenged elected officials to spend one day in her shoes—or wheelchair—on one of her accessibility tours. Jackson took elected officials on tours of their facilities to show them the daily obstacles faced by people with disabilities.

Even now, there is no slowing down for Jackson. She is currently pursuing a masters of divinity degree at the New Brunswick Theological Seminary. Her goal is to pursue a doctoral degree with a focus on church and community.

In five years Jackson hopes to be known as the Rev. Jackie Jackson, as she continues to empower those with disabilities to seek full inclusion in society.

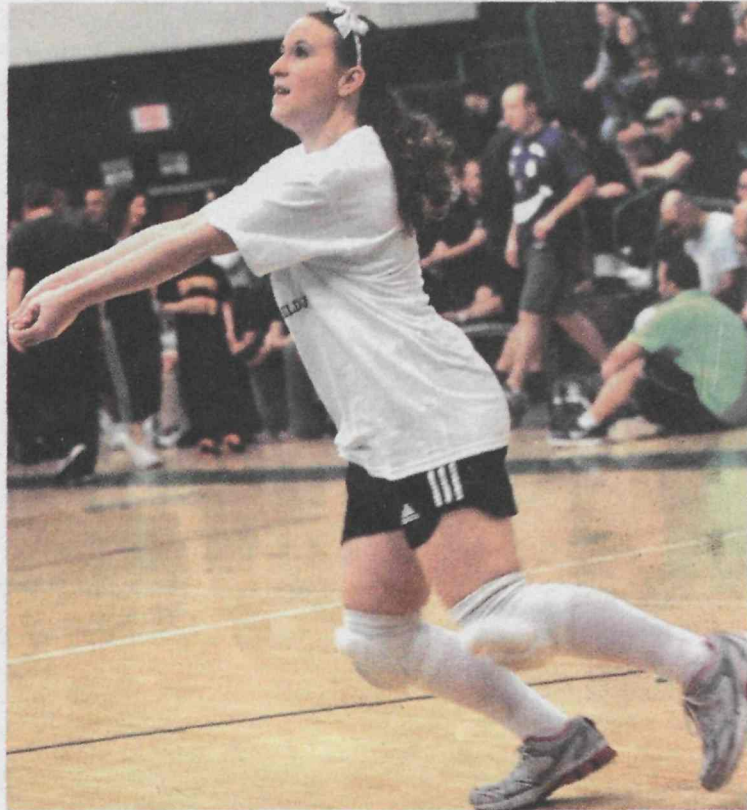

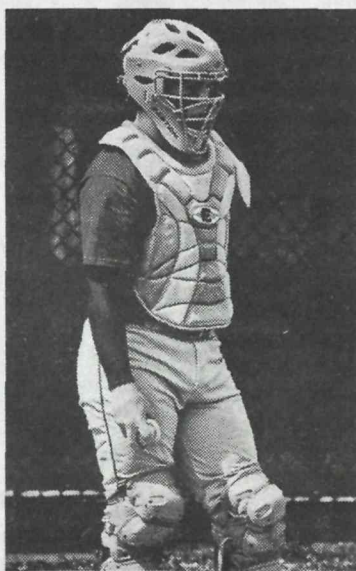
singled with RBIs.

ginning. Last year the legislature passed a law prohibiting library boards from maintaining more than a 20% surplus. According to the law, with limited exceptions, anything above 20% should go to tax relief.

The law passed overwhelmingly and was based upon the fact that the formula that funds libraries gave them huge budget increases year after year, even while other branches of government were doing everything possible to cut costs. Based on these huge increases, many library boards amassed huge surpluses. At the same time, libraries were immune from the cost cutting that was and is affecting other parts of government.

What did this mean in South Plainfield? Taxpayers were forced to give the library board over \$1.3 million each year for the last few years (much more than was needed). In the meantime, the board amassed a surplus of about \$2 million, which is nearly twice its operating budget.

The board members call the surplus theirs. The majority of the council disagrees. It belongs to the taxpayers. In other words, residents have been overtaxed and deserve to get their money back.

Councilwoman Buteas disagrees.

She has every right to, but you have to wonder if her position is based on principle or her impulse to say "no" to everything the new council tries to do. For example, while she says the money was purportedly saved for a new library, she forgets that the money belongs to the taxpayers, not the library board members (who were never elected by the voters). This has nothing to do with a new library.

Similarly, while the councilwoman complains that part of the surplus (\$750,000) will be a one-time revenue in the budget, she never worried about one-time revenues when her party was the majority and used much more in its budgets. Her position seems to be based on pure politics.

I simply don't understand how Councilwoman Buteas can oppose giving residents much-needed tax relief.

The South Plainfield Board of Education has been misusing funds throughout the current school year. Our tax dollars have been paying the expensive salary of a superintendent while he is on an administrative paid leave. Jose Negron is collecting his

yearly salary of \$177,598, plus the 3-1/2% raise he refused to freeze (\$183,813). He was our superintendent since October 2007 and his contract will finally expire on June 30, 2011. Since Negron was put on administrative leave, we have had Gary Bowen, as acting superintendent, collecting \$750 per day.

Jose Negron was not an effective superintendent. He was very unprofessional and callous towards employees and board members. Negron's lack of communication with the board caused much tension between the two. The relationship finally reached its breaking point and they relieved him of his duties. I agree that Negron needed to go; however, it infuriates me that he is being paid a hefty salary for doing nothing to help the youth of South Plainfield. An imperative task for the BOE in the upcoming months is to begin an extensive search to find a new superintendent of schools. Gary Bowen is doing a fine job as our interim superintendent; however, he has no vested interests in our community. We need to find a leader to take over that position and do everything necessary to

supervise our district. A committee needs to be formed to seek out someone that will do all the duties necessary to improve South Plainfield Public Schools. We also need to be mindful of the economy and budget problems in our district, and the new superintendent's salary has to be reasonable. We need to learn from past mistakes and have well-informed board members on this committee to make the right decisions.

When I decided to run for the South Plainfield Board of Education, I knew there would be many challenges put forth. The three candidates that win this election will be making vital decisions on upcoming budgets and overseeing the operation of all schools in the district. South Plainfield needs board members that put the students first. If elected, I will volunteer my time and will always remember that the main assignment at hand is to provide our students with a 21st century education that prepares them to be successful young adults. Also, technology in our classrooms is a must and we need to find a way to incorporate more.

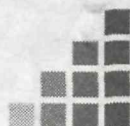

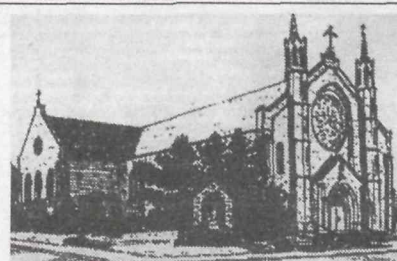
