# **Wesley Methodist** Welcomes New Pastor

Reverend Gina Kim will be officially installed as new pastor at Wesley United Methodist Church this Sunday. Kim replaces Reverend Nehemiah Thompson who was transferred Reverend Gina Kim

to North Brunswick. Thompson is credited with enlarging Wesley's congregation during his eight years of leadership.

Reverend Kim didn't grow up knowing she would someday become a pastor. Born in Seoul, Korea, her parents encouraged her to study and excel at her school subjects, but not cooking.

"My mother wouldn't let me in the kitchen. She would always send me away saying 'read, read'! She didn't want me to grow up to be a housewife," said Kim. Only when she married did Kim's mother acknowledge the subject of cooking. "Her gift to me was a cookbook," Kim said. Although

# **BOE** Appoints Bus. Admin.

James Olobardi was appointed business administrator/board secretary by the Board of Education at the Sept. 21 meeting at a salary of \$151,000.

The board has been without a permanent business administrator since December 2010 when former Business Administrator Richard Guarini departed. Interim Business Administrator Nicolas Puleio took over the position in December, but left in June 2011. Mark Resnick was then appointed to the position, along with Ernie Turner as consultant.

Olobardi will begin the new post after he is released from his position as board secretary/administrator for Englewood Public School District. Prior to his current position, Olobardi worked two years as board secretary for East Rutherford School District.



# Library Undergoing **Cleanup from Flooding**

One of the most ongoing reminders of Hurricane Irene is the damage to the South Plainfield Public Library caused by the four inches of water that seeped into the library, along with the sewage that backed up in the library's bathrooms.

For the past three weeks, the library has been closed to the public, but not to the staff who have been working to clean up the damage as the fans and dehumidifiers keep humming.

Library Director Sunni Randolph has contracted with First Response to help dry up the water clinging to the walls and floors. First Response has already disinfected and steam cleaned the bathrooms so they can be used while the staff is working in the building.

On September 20 the library staff began removing the collection of books from the shelves and packing them into boxes. University Van Line employees transferred the books into two large trailers donated by Halls Trucking. The trailers will remain parked in the lot behind the library until the cleanup is completed. Not only are the books being removed from the library, but the large bright panels that decorated the walls in the children's room are now outside and free to anyone who might want them to decorate their homes or classrooms.

Other items free for the taking include books displayed on outside

When the library is emptied of books, an appraisal of the condition of the walls and floor will begin. First Response will remove the wallpaper and test the sheetrock for stability and mold. The carpeting has been removed and the floor's condition is being assessed. Replacements will be made where necessary.

Randolph expressed concern that repairs may be delayed due to current demand for construction workers to make repairs on the numerous homes and buildings that were damaged by the hurricane. In contrast, there has been no delay in attempting to complete the cleanup as quickly as possible despite the possibility that there will be no insurance payment for work done.

According to the borough Chief Financial Officer Glenn Cullen, the borough has been informed by the Middlesex County Insurance Fund that it didn't have flood insurance for the library. "The attorneys are looking into it," said Cullen. Library Director Randolph intends to submit hurricane damage claims to FEMA.

Randolph anticipates the probable re-opening of the library to be around Halloween. In the meantime, residents are advised to use libraries in the surrounding communities.



Barletta pointed to the 700-unit apartment complex that was proposed for the south side as an example of the constant battle to prevent overdevelopment.

"Thank goodness the Republicans on the Council stood up to the Democrat ex-mayor," said White. "If not, we'd now have 700 more apartments."

For years more apartments were almost certain, but when Governor Christie was elected he vowed to get rid of COAH, the agency that sets low-income housing quotas. Republicans on the Council saw that as an opportunity to halt the project, which had been required until then.

But when the council considered the issue, Democratic Councilwoman Buteas refused to take a position. Even when pushed for a direct "yes" or "no" answer, she would not commit.

"Her political ally, the ex-mayor, even berated the Republicans, saying they didn't know what they were doing," added Barletta. "But once again it was the Democrats who were wrong. Just two weeks ago COAH was eliminated."


 Nicole Sutherland was appointed as a social studies teacher at the high school. She is a graduate of Montclair University and has previously substituted in the district.

"When a big business loses money, the corporate tax code offers them a potentially life-saving break, yet small business owners have no such protection," Buono told the business owners. "This tax disparity becomes even more harmful to the small businesses we will need to grow our economy. Our taxes need to be fair to businesses of all sizes, and not stick to a mistaken model of bigger is better."

The law provides sole proprietors and other small business owners with a tax cut by requiring the tax code to treat them the same way as it does larger corporations. "Despite what we are told, a majority of Americans are employed by small businesses, not global corporations. It is more impor-

tant that we in Trenton and Washington keep this in perspective and give small business owners the tools that they need to grow our economy one neighborhood at a time," said Barnes. The new law will help small businesses that do not file through corporate tax code by giving them many of the same benefits enjoyed by their larger counterparts.

Under prior tax law, state gross income taxes were calculated through 16 separately defined categories of income. Unlike the federal tax code and the tax laws of 48 other states, New Jersey law did not permit small business filers to carry forward operating losses. The measure consolidates four income categories, and allows a 50% "cross-netting" of gains or losses from one category of income to another.

There are plenty of resources still available while the library is closed. We hope that the restoration of the library building goes smoothly and that we will be able to announce a grand reopening very soon.







God spoke to me telling me to 'take care of my children'. I told my Pastor about what I had experienced," said Kim.

Her pastor encouraged Kim's vocation by having her take over the Youth program and provided a scholarship for her to study Christian education at the Seminary Alliance in Nyack, New York. When her husband was transferred to Ohio, she faced a big question.

"Why did God pull me out of a successful youth ministry and send me away to Ohio?" she asked herself.

In Ohio Kim had another revelation that put her on the path to being a congregational pastor. The original message she received when she returned from Paraguay-"to care for My children" held a larger context. It didn't mean only "children"-it meant the total congregation.

She continued her theological studies in Ohio and received a Master of Divinity from Ashland Seminary. She met with recruiters and within three months the Ohio Bishop placed her at a Caucasian Church as a lead pastor. She served three congregations there before she was transferred to New Jersey.

For the past five years Kim was associate pastor and head of four associate pastors and 10 part-time pastors for the Korean Community Church in Englewood.

Since last July she has been with Wesley United Methodist Church in South Plainfield. She started three bible study groups and leads two Sunday services at 9 and 10:30 a.m.

Kim loves her diverse and welcoming congregation and enjoys serving people of all ages and backgrounds. Her passion is to preach the Word of God to all people that they may experience and express the love of God.

# **Baseball Club Dedicates Twin Towers Beam**

Last Saturday evening members of the South Plainfield Junior Baseball Club (SPJBC) dedicated a monument in memory of all who lost their lives on September 11, 2001.

Attending the ceremonies were members of the South Plainfield Fire Department, the South Plainfield Rescue Squad and the South Plainfield Police Department as well as Mayor Anesh and members of the Borough Council, parents, friends and Junior baseball players of all ages.

The centerpiece of the monument is a beam from the foundation of one of the Twin Towers which was destroyed after two planes flew into them.

The dedication took place in front of field three where the monument, constructed of stone masonry, is installed. Three plaques are affixed to the wall-each representing the State of Pennsylvania with the location of Shanksville marked, the Twin Towers and the Pentagon.

The monument was constructed by SPJBC Building and Grounds Board Member Bob Bors, who acted as chief project manager, and a support team of volunteers who wish to remain anonymous.

"This monument is not just for the present, but for the past and the future." The National Anthem was sung by Lainie Harris, invocation was by Deacon Tammas Gray, St. Johns, Baptist Church in Scotch Plains.

Those attending were given candles to hold during the dedication. At the close of the program, Lainie Harris sang a song about the Twin Towers and the lights on the wall behind the monument and the steel beam were officially turned on.


