# Ashnault to Join Ranks of Cappy Recipients

Longtime volunteer wrestling and baseball coach Bill Ashnault has been named the recipient of the ninth annual Cappy Award, and will be honored with a dinner tomorrow night at the Senior Center.

Named for late Deputy Police Chief Tulio "Cappy" Capparelli, the Cappy Award is a combined effort of the Recreation Commission and the Police Athletic League. The Cappy Award recognizes those individuals who selflessly donate their time for the betterment of the youth of South Plainfield.

Ashnault's career began in 1985 as a volunteer assistant wrestling coach with the high school, where he remained until 1998. For the next three years he served as the Middle School wrestling coach. In addition, from 1998 to the present, he has served in various capacities with the South Plainfield Wrestling Club, from coach to president. He currently serves on their board as a trustee.

He has not only been instrumental in the coaching of children, but has been a key figure in running tournaments, organizing fundraisers and helping lead the wrestling club to contribute to the PAL expansion.

Ashnault has also been a coach in the baseball community, from tee ball to teener ball, through to the South Plainfield Junior Baseball Club from 1995 until 2008. In the SPJBC, he served as a member of the Executive Board and was on various committees including buildings and grounds and canning. In addition to regular season coaching, he was an all star coach for over 10 years. Ashnault was also a Pop Warner coach for a year.

In addition to his coaching exploits, Ashnault has been a member of the Recreation Commission since 2001. In that time the commission has been instrumental in upgrading the lights and facilities at the football, baseball and soccer complexes, as well as the PAL expansion and the building of Memorial Field behind the PAL.

# Labor Day Throat Slasher Gets 26½ Years

Anthony K. Cole, 25, of Woolworth Avenue was sentenced to 261/2 years in prison with credit for two years served on Tuesday in Middlesex County Superior Court by Judge Bradley Ferencz on various charges, including the attempted murder of Department of Public Works (DPW) employee David Donatelli. The in-

cident occurred after the Labor Day fireworks display in Spring Lake Park on September 7, 2009.

Cole was convicted on August 12 of attempted murder, unlawful possession of a weapon, possession of a weapon for an unlawful purpose and hindering his apprehension after fleeing the scene. A separate indictment charged Cole with a count of certain persons not to have weapons. He was prohibited from possessing a weapon after he was found guilty and sentenced to a five year term on an aggravated sexual assault charge in Edison in 2001.

South Plainfield Police were able to prove that Donatelli, 53, was ap-

proached from behind by Cole who cut his neck with a knife as he was shutting off the park lights shortly before 8:48 p.m. Donatelli was taken to Robert Wood Johnson University Hospital in New Brunswick where he underwent emergency surgery for his injury. He has since retired from the DPW.

# Scalera to Head Up SPVFD

Deputy Chief Tom Scalera of the South Plainfield Volunteer Fire Deptartment will take the reigns as chief this month from Larry Del-Negro who has held the position since 2002.

Scalera, known to many as "Bubba," is a lifelong resident. He has held the position of deputy chief for the past 11 years and is currently employed as a lieutenant with the Plainfield Fire Division for the past

Scalera has served as a part time fire official for the Fanwood Fire Department for the past 15 years. He has also served as assistant commissioner with the South Plainfield Junior Baseball Club for five years and is a member of the Knights of Columbus.

"It comes natural to me," said Scalera, whose family has been fighting fires in the borough since 1937. He and wife Sharon have three school-aged children, Dominick, Nicholas and Jemma.

In the 100 years since a volunteer fire department was established in South Plainfield, there have been only 10 elected fire chiefs. Chief Del-Negro still plans to stay involved in some capacity with fire department.

# Rats Invade Eganey Street

Property owners who live next door to an Eganey Street residence brought their concerns about rat infestation before the Borough Council at the November 21 meeting.

O'Donahue Avenue resident Jeff Seider spoke about his efforts over the past seven years to enlist the health department to fine the owner under borough property violations to rid the problem in their yards.

"This year the rats came out in the early spring and are still present," said Seider, who says they are avoiding the traps. "The health department tells them to clean up their property, which they do, and the rats are back three weeks later." He claims that after Hurricane Irene in August the problem worsened to where the rodents were burrowing under the deck of his home, which has been in the family since 1949, and also in an air conditioning unit.

Seider claims that findings by profes-

sional exterminators blame a rotting stump underneath the neighbor's shed for creating the problem. "We need to get to the root of the problem and need an inspection weekly. I'm not satisfied with the health department's response. Enough is enough.'

Georgeann Cochrane, who lives next door to the property in question, said that the rat problem has been "unbelievable this year." She has two puppies and four granddaughters who cannot roam her yard. "I can't deal with it anymore. This has to be taken care of."

Seider, Cochrane, another neighbor who is experiencing the rat problem and the property owner met with CFO Glenn Cullen and members of the health department on Tuesday. Cullen said they agreed to hire another exterminator to inspect the property, and the homeowners agreed to abide by the findings. Cullen said the health department has been cooperative during the past seven years. No date has been set for the inspection.

## Resident Arrested in Child Sex Scandal



Brown, 38, of Central Avenue was arrested on November 22 after exposing himself on the Internet to

whom he believed to be a 14 year-old girl.

A teacher at Woodbrook Elementary School in Edison, Brown was charged with two counts of attempting to endanger the welfare of a child and two counts of attempted criminal sexual contact. All charges are for alleged third degree crimes.

According to an investigation conducted by the Bergen County Prosecutor's Office Computer Crimes Unit (BCPO), Brown used the Internet to engage in sexually explicit conversations with an individual he believed to be 14 years of age. During these conversations, he exposed himself via webcam in view of the purported child.

Edison Township Superintendent Richard O'Malley said that Brown is currently on administrative leave. He was arraigned on November 25. Bail was set at \$25,000 with no 10 percent option and he was banned from using the Internet. In lieu of bail, Brown has been remanded to the Bergen

### Two Assaulted on Pitt Street

South Plainfield Police responded to the report of a disturbance at Pitt Street and Jackson Avenue on Sunday at approximately 10:30 p.m. Upon arrival, officers located two males who stated they were assaulted. The males, age 27 of South Plainfield and age 50 of Smyrna, Ga., were walking on Pitt Street when they were confronted by a group of four individuals. The

individuals were identified as Jared Jones, 22 of South Plainfield; Allen Pittman, 20 of Avenel; a juvenile male, 17 of South Amboy; and a 14 year-old female of South Plainfield.

According to police, a confrontation started when Jones approached the men and demanded a cigarette. When they refused, Jones allegedly

This is normally a quiet, residential street located in a residential neighborhood that has the misfortune of being off of Hamilton Boulevard; a county road with an 18 wheel tractor trailer ban on it. 

# Czaplinski Charged With Several Counts Of Fraud and Theft

# Former Borough Payroll Clerk Charged with Theft

Middlesex County Prosecutor Bruce J. Kaplan and Chief James Parker of the South Plainfield Police Department announced that a former clerk was charged with stealing more than \$3,000 in overtime while she worked for the borough.

Marie K. Smith, 62 of Brennan Court was charged with a third degree count of theft by deception for paying herself overtime for work she never performed.

Smith was charged after Investigator Lisa M. Collins of the Middlesex County Prosecutor's Office determined that Smith gave herself overtime payments in various amounts after becoming the borough's payroll clerk in January 2010.

The investigation began after borough officials became suspicious and contacted police.

Smith, who worked for the borough for 23 years, was dismissed from her job on March 21, 2011.

As is the case with all criminal defendants, the charge against Smith is merely an accusation and she is presumed innocent until proven guilty.





# A Bright Idea For Holiday Savings

Save money and energy this holiday season by switching to strings of LED decorative lights for your house and Christmas tree. According to the U.S. Department of Energy, Consumer Reports and dozens of other environmental resources, the switch is a really bright idea.

LED (light-emitting diode) lights are a great alternative to strings of traditional incandescent lamp lights. The most attractive benefit of using LEDs may be the significant savings on the holiday utility bill. LEDs use 90% less electricity than the glass incandescent type. Because they use less power, plastic LEDs also run cooler, reducing fire risk, are safer to connect end-to-end sets without overloading the wall socket, and are more durable because there are no filaments to burn out (thus no bulbs to replace).

According to the U.S. Department of Energy, LEDs last longer and have an operational life span of approximately 20,000 hours. That's enough to last for 40 holiday seasons.

Is there a downside to LEDs? Yes. The C7 and C9 size incandescent bulbs are five to six times brighter, and LEDs may cost a little more; however, for long-term monetary savings, longevity of light sets and reduction of fire risk, LEDs might be worth the purchase. Check out the sales at local retailers.

Whatever your choice of decorative lights, be aware that Christmas trees are involved in about 300 fires every year, according to Consumer Reports. Be sure to inspect your light sets before you hang them. Check to see if each string has a holographic "UL Listed" tag. It is imperative to discard strings with broken sockets, frayed or bare wires or loose connections. Do not plug more than three strings of lights into an extension cord, and be sure to turn off all your holiday lights when leaving home or going to bed.
