Gov. Christie Addresses Town Hall Meeting

Governor Chris Christie's Town Hall Meeting held at the PAL building last Thursday drew more than 400 residents from various parts of the state waiting to question him on a variety of issues.

The governor's entrance into the PAL garnered thunderous applause and a standing ovation from the crowd. A banner over his head read, The Jersey Comeback Has Begun.

In a lengthy pre-question speech, Christie spoke of a "sense of despair" among residents of the state when he took office in 2009. He said that during the prior eight years the legislature had raised taxes 115 times and that property taxes alone had risen 70% in the past 10. Businesses were moving out of the state at a fast pace and there were 117,000 private sector jobs lost as a result. He said he was faced with an \$11B deficit in a \$29B budget that former Governor Jon Corzine had left behind, and they needed to come up with \$2B to make payroll for the second pay period in March.

Through massive spending cuts, Christie said he has been able to keep his promise of making government smaller and lowering property taxes with a "real" 2% cap since he took



office. He made tough decisions with \$2.4 billion in small pension reform and by having everyone "pay their fair share."

During the question and answer session, a Piscataway resident commented that his town council was bonding for more items than usual and he wanted to know if it was legal. Christie replied that there are three ways to get around the 2% tax cappension and health benefit costs and debt. "If they are bonding for things they shouldn't be, then I'm glad you gave me the tip," said Christie, and he said he would have someone from Local Government Services that oversees the cap investigate.

An Edison resident asked the governor if there was going to be any help for small business owners. Christie said that he wants to "put people back to work." He has made

business tax cuts, of which 70% of the 75,000 new jobs are, in fact, small businesses that have been created in the state. Information

for small business owners that qualify can be obtained through the N.J. Business Action Center.

A Lake Hopatcong resident stated that heroin use was huge in the state and wanted to know what we are doing as a state to save the youth from this epidemic. She had recently spent \$30,000 on rehabilitation for her son. Christie called for drug treatment for non-violent offenders. "I've never met anyone who is willing to go for treatment-they go at the end of a threat or in the middle of a crisis," said Christie.

A borough grandmother of an autistic grandeniid questioned the governor as to what is going to happen when children age-out of the school system. Christie said that he is consolidating services for the developmentally disabled so that they have one case worker that is knowledgeable in all services. He does not want to see people move out of town to receive better services and called for "Centers of Excellence" to be created in each town. "We want everyone to reach their maximum potential instead of institutionalize them as they are not a danger," stated Christie. "We care about this issue deeply."

When asked if he would accept the vice presidential nomination, Christie replied, "I have no intention of leaving New Jersey," and "I don't have the personality for a vice president. I will still be governor in 2013.

"I love public schools and teachers," said the governor after being asked about unions and taxes. "I don't want unions that are taking advantage of their members." Christie referred to

union dues as a "slush fund." He also called for tenure reform and felt that "teachers who are good should get

Christie's feelings about "Obamacare" were quite clear as he reiterated that he was opposed to it. "People are angry about it," replied Christie, to the woman in the audience. If the legislation fails in the Supreme Court, he wants to see Democrats and Republicans work together to come up with a plan.

At the end of his hour and a half long visit to the borough Christie said, "Things are heading in the right direction. Thanks for giving me the chance to do the job." He concluded by saying, "I love my job."

Dear Editor,

I am usually not at a loss for words, but after reading a letter to the editor from BOE member Joe Sorrentino I am almost speechless. He talks of a meeting when I asked the Board of Education to pay their fair share of tax appeal refunds as if he has an idea of what I was speaking about. In his letter he states that we should have budgeted for tax appeals. We did, and we refunded \$280K last year, which also includes the portion attributed to the Board of Ed's share of the refund.

Here is how this works. Taxes are collected for the municipality, county, and school. When a tax appeal is awarded to a property owner, the full amount comes from the municipal budget only. This in turn comes from the taxpayer. The tax bill portion for the school is 57% of the bill. I, in turn, asked the board to refund their portion, which last year equaled \$159K back to the borough. In essence, I simply asked the board to pay their portion of the bill. The council would then refund the full amount back to the residents for tax relief. And he has a problem with this? He even stated he would "never vote to give money back."

It is not as if the Board of Ed has no money. Their auditor found \$1.3M they didn't know they had and the state has given them an additional \$735K in aid above and beyond the amount they received the prior year. And he doesn't think paying the board's share is fair? He expresses that we want to do this to look like heroes. No. the Board of Education



Library Plans for Larger Movie Audience

South Plainfield Public Library is planning to move the Monday Night Movie series from the children's room to the larger space in the main room in order to provide more seating.

The series, which began on March 19, allowed for seating of 20. At the April 9 movie night, seats were filled well before the 6:30 p.m. showtime, and more had to be added.

Library Director Linda Hansen said that before the movies can be moved into the larger space a speaker and amplification would have to be installed as well as "split lighting" (lighting to darken only the center of the library), while the lights on the periphery would remain on.

"When we shut the lights in the library, the entire area is dark," said Hansen at the Library Board of Trustees meeting on April 13, adding that with split lighting patrons could still use the library to read newspapers and magazines located in the same area.

The Board of Trustees approved Hansen's proposal to contact electrician Richard Little of RT Tech in South Plainfield to make the adjustments in the larger space of the main library area.

The board approved the fees for two library employees to attend all day, in-state conferences; Hansen for librarians and Ken Morgan for library assistants; and for Chris Grippo to attend the Book Expo in New York City without an overnight stay.

Hansen also reported on the recent revival of the Friends of the Library group which will meet on the first Thursday of each month. The next meeting will be held at the library on May 3 at 7 p.m. The library will present a free program on couponing at on Thursday, April 26 at 7 p.m. Space is limited; register at the library or by calling (908) 754-7885.

Hansen also said they plan to establish adult computer classes which would provide basic skills use of the computer as well as teach patrons how to navigate and use the databases available through the library in areas of genealogy and foreign languages.



The year 1940 was very important in the history of the United States. The Great Depression had been in existence for the previous decade and Europe and Asia had been at war since at least the previous year. It was also time for the sixteenth census of the United States.

The census is taken every 10 years and usually is primarily concerned with the reapportionment of congressional seats and a general view of characteristics of the American people. In light of both the national and international situations, the 1940 census for the first time asked many more detailed questions concerning the economic status of the American people while also trying to get an idea of movements of population that had occurred in the United States.

To help our patrons navigate this census we are offering a workshop on Thursday, May 3 at 6 p.m. in the library. This census has not yet been name indexed so access to the raw data can only be obtained through the Enumeration District in which the census was taken. In this workshop you will be shown the census forms and various questions which were asked (and in some cases why), and we will discuss the easiest ways to find the Enumeration District where the people you are researching lived. The workshop is free, but we request that you register as we would

like to know the number of people interested in this topic.

A more general workshop on genealogy (including earlier census) will be presented on Thursday, May 17 at 6:30 p.m. in the library. As anyone who has tackled the subject of one's ancestors knows, this can be quite a daunting topic. In this workshop we would look at a variety of sources in addition to the census and the two databases to which the library subscribes, Ancestry. com and HeritageQuest (each has its own benefits). 





Middlesex County Improvement Authority's four golf courses saw a total of 7,366 rounds of play in January and February. Logistically speaking, between the three sites Tamarack Golf Courses in East Brunswick recorded 4,510 rounds; the Meadows at Middlesex Golf Course in Plainsboro confirmed 1,331 rounds; and the Raritan Landing Golf Course in Piscataway acknowledged 1,525 rounds in that two-month span.

Quite a difference a year makes, considering the opposite was true for the start of 2011, when a record-breaking winter in its own right, dumped more than 20 inches of snow and downed dozens of trees, all but halting play at

Rain or shine, the MCIA's diligent staff members continue their maintenance schedules so the courses are well kept and open for play for the many loyal golfers that frequent them.

The most visible of these efforts includes the aerification of the tees, fairways and greens, a rarely interrupted reseeding routine and a supervised team of border collies at Tamarack, wardingoff Canada Geese.

The New Jersey Retail Merchants Association and the Retail Gift Card Association have released a study that estimates between \$64 million and \$94 million in sales tax revenue would be lost each year if shoppers in New Jersey stopped shopping with gift cards.

The governor was quoted as saying he's not worried. Maybe he isn't but both consumers and businesses throughout the state are. He should admit that this ill advised grab at gift cards to balance the state budget was a mistake. All that is needed to reverse it is his signature on my legislation.

To the Editor:

The school district issued its budget on March 28. Once again, as in several prior years, it includes a property tax increase. This in spite of the fact that for the 2011/2012 school year the district received \$1,120,805 in additional state aid, and for 2012/2013 received additional state aid of \$735,783. The audit report as of June 30, 2011 issued in December 2011 showed the

following:

Excess Surplus: \$1,343,401.54; Emergency Maintenance and Capital Reserve: \$1,197,613; Designated for subsequent year expenditure: \$600,000; Unassigned Fund Balance: \$348,924; Encumbrances: \$386,078; and Capital Projects Fund Balance: \$1,685,607.

When totaled, this results in an audit district balance of \$3,876,016 plus \$1,685,607 in the Capital Project Fund. The interim superintendent initially took the position that there was no excess surplus; however, in a press release dated February 14, 2012, he admitted that in fact a surplus of \$1,343,402 was available and also that there was \$678,309 in deferred state aid for use in the 2012/2013 budget.

In summary, the 2012/2013 budget does use the \$1,343,402 as revenue but makes no reference to the \$600,000 in the audit or the \$678,309 deferred state aid. We should be told how and where these funds were applied.

Also, if the \$1,685,607 in the Capital Project Fund Balance were used for roof repairs, there would be no need for the taxpayers to be asked to pay \$1,271,606 for the roof capital expenditure. This item is reported in the advertised 2012/2013 school budget published in the Observer.

By accounting for and reconciling all the financial funds and resources, and applying them accordingly, there would be no increase in school property taxes.

I am responding to Joseph Sorrentino's letter printed in the April 13 edition of the Observer

Joe, while I applaud you for standing up last year and running for the BOE, I need to address your comments from last week. Please check your facts before sending lengthy letters to the editor. Yes, Councilman Rusnak asked for money back from the BOE to be used for the tax appeals. He did this because property values are down and

the businesses and homeowners in town have received tax credits after their properties were reevaluated. He asked for 57% of the total amount appealed. I don't think this request is unreasonable because 57% of our taxes goes to the schools in the first place. Also, 57% represents \$159,000. This is a lot better than requesting the \$1.3M surplus that the BOE is holding. At a recent BOE meeting, you thought it was better to hold this surplus money so that it could be used for the children because you thought it would only amount to \$20-30 relief to the average household. Thankfully, Councilmen Bengivenga and Rusnak were there to correct you. The actual relief would have been about \$120 per household or two percent of your tax bill.

You mention in your letter that the governor cut state aid over the last three years. This is correct, he cut state aid the first year he was in office. However, you failed to mention that since then, he increased it last year by more than \$600,00 and again this coming year by about \$750,000. Plus, South Plainfield is getting an additional \$600,000 in aid which is not reflected in your budget.

Now let's talk about the condition of the school roofs. After all this talk started about the roofs being unsafe and costing millions of dollars to fix, our town engineer has deemed them safe. An independent roofing contractor along with a BOE member inspected the roofs and estimated that the cost to fix them would only run in the thousands, not millions. I believe that if the company that the BOE hired to maintain the grounds and buildings did their job, this problem wouldn't have materialized:

You state that the council has been raising money by taking money from the library. The money that they were asking for from the library is money that came from the borough and was sitting in a reserve account. If you check the records, the library did not return the original amount that was requested of them. They chose to return a small portion of it.

While it is great that you want to always put the children first, do you feel that at this time, with the way the economy is, that it's prudent to have a budget that's in the range of a 31/2% increase?




