Former Borough **Activist Dies**



George H. Reinhardt, 80, a long time resident of South Plainfield died suddenly on Wednesday, May 14, at his home in Coconut Creek, Fla.

George Reinhardt

Reinhardt was born in Newark where he grew up. He had lived in Irvington before moving to South Plainfield, where he resided for 42 years. He moved to Florida two years ago.

During World War II, he served as

a sergeant in the US Army with the 29th Infantry Division in the 894 Signal Radio Relay Company. He had been in combat action in the Invasion of the D-Day Normandy Beach in France, in central Europe and in Germany. He was awarded four Battle Stars and the Good Conduct Medal, He was recalled to army duty during the Korean War Conflict. He was a life member of the VFW Memorial Post 6763.

After his discharge from the Army, he began his 34 year career with New Jersey Bell Telephone Co. in Newark, where he was a Central Office Technician. He retired 15 years ago. He had been a member of the Telephone Workers Union Local 827 and had served as the chairman of Unit 14 for four years and was a member of the Telephone Pioneers of America since

While in South Plainfield, George had been involved in politics and joined the Democratic Club, serving as a first vice-president. He had also served as the Democratic Municipal Chairman in South Plainfield from 1973 through 1976 and was a Democratic committeeman for 10 years. In 1963 he ran for the Borough Counas the Democratic candidate and had served as a member of the Recreation Commission from 1967-1972 and was a former member of the Ad-(Continued on page 12)

On May 10, the South Plainfield Police Department hosted its Sixth Annual Bicycle Rodeo at Spring Lake Park. Over 200 residents attended the event, which promoted bike safety and theft prevention. The children first had a safety check performed on their bike by the staff of Ken's Links, a bicycle store in South Plainfield. They then took part in a safety obstacle course staffed by State Farm Insurance, where upon completion they received a 'photo license." To further emphasize helmet use, the children participated in a safety demonstration conducted by Joann Cummings, R.N. of Robert Wood Johnson University Hospital, where the children observed the effects of a fall and its effects on the human brain. Cummings utilized a brain made of Jello to demonstrate these effects.

As part of the "Baron Von Pedaloff" anti-theft program, approximately sixty children registered their bikes with the police department. This program, designed by retired South Plainfield Police Officer William Frink, encourages the children to register their bikes with the police department in the event they are stolen.

The Department distributed approximately eighty bicycle helmets to the children that attended and did not have a helmet. This effort was brought about because the original tombstones on these graves were badly deteriorated and there was a fear that the graves them-selves might be lost. The new markers were provided with the help of the New Jersey Department of Military and Veterans Affairs. The grounds crew of the cemetery donated the labor and materials necessary to install the markers on the graves.

New markers were placed on the graves of the following men:

2nd Lieutenant George C. Boice-Com-pany G; 11th Regiment, New Jersey Volunteers. Lieutenant Boice was killed in action at the Seige of Peters-

burg, Va. on Oct. 8, 1864.

Private Auron F. Randolph—Company H; 30th Regiment, New Jersey Volunteers. Private Randolph died of a fever while serving with his regiment as part of the Army of the Potamac at Belle Plains, Va. on March 9, 1863.

Sidewalks to be Installed Along Belmont Ave.

During the years Frank Mikorski served on the School Board of Education, he asked the council on numerous occasions to install sidewalks along Belmont Ave., saying the board would save money on the cost of busing. Mikorski, who began his campaign in 2000, was delighted to hear his request is finally being answered.

At present, children attending Roosevelt who are not usually eligible for busing are bused because of the lack of sidewalks along Belmont Ave.

In 2000 the council applied for a grant to do the project and received \$72,000, which was not enough to cover the cost of the project. They applied again the next year and got an addition \$100,000. Since then they have received a third grant which will cover not only sidewalks on both sides of the road, but also curbs and the resurfacing of Belmont Ave.

A legal notice published on page 10 of this week's Observer is asking for

bidders to submit bids on the project. There are already sidewalks on several sections of Belmont Ave., but pedestrians cannot travel very far without having to walk along the road dirt. When the new sidewalks and curbs are installed they will run on both sides of Belmont from Hamilton Blvd. to Metuchen Rd.

The sidewalk, curb and resurfacing project will be started shortly after the winning bid has been awarded.

A Reflection of the First Year of College Life: A Contemporary Perspective

College is a unique experience. It can be fun, exciting, developmental and enlightening. The studies can be seemingly overwhelming at times, but there is more to higher learning than the academic aspect. It is a completely different environment than high

There are no distinctive social factions, because status is not of great concern. Most students have a select group of friends they associate with. Gossip does not spread like wildfire, because everyone does not know who everyone else is and what's more, they don't care. You are forced to separate and distinguish yourself from your influences and peers, because college by nature fosters self-reliance. All of a sudden, preparation for your future and further establishing your own life become primary focuses. One decision that will profoundly

affect your college experience is whether or not you choose to become a resident or commuter; they are two dif-ferent lives. Being a resident who knows both commuters and fellow residents, I can decidedly say that I

prefer my current situation.

While every student's preferences and predilections are different, I think that you can get more enjoyment and appreciation out of the college experiliving there. You can meet many different people from various backgrounds. You will likely connect with people that you probably would not have associated with in high school, because when you live around and see the same people day-in, day-out, at all times of the day, you realize that you want to get along with as many of them as you can. One advanmany of them as you can. One advantage to living with others at college is that you will form many types of relationships and open yourself to interacting with people outside the types you did in high school. In my opinion, this better equips you for "the real world," because it is a skill that you can apply in life offer college. can apply in life after college

Colleges sponsor plenty of activities, trips, events, and clubs that cater to every group and interest. There are ample opportunities to become involved at college, and truthfully, residents are more likely to do this than commuters. Commuters tend to retain their old ways of life, which are usually outside of the college environment. Residents, on the other hand, usually cannot keep the ones they established at home, so they are likely to turn to their new living environment - the school.

In either situation, there is an importance in social life at college. Irreportance in social file at conege. Inte-furably, the main reason for you to go to college is to pave your path for the rest of your life, but there is no reason you can't have fun along the way. In fact, I would argue that enjoying your time at college is conducive to academic performance, provided prioritization takes place.

Your interactions with fellow students will differ greatly from high school. Remember how teachers used to have to control constant talking in classes? That doesn't exist in college. Professors are there for you to gain a better knowledge of the material and will not tolerate extra conversations in their classes. Students tend to show professors more respect. It is understood that outside of class participation, when professors talk, you listen (or at least don't distract them or others). Students are not particularly lo-quacious in classes, because they often do not know one another. In college your friendships are often formed ide the classroom.

My class sizes ranged from a dozen or so students in my smallest classes to about 40 in my largest classes. This is not usually the case with a larger school, though.

If you are lucky, you can avoid Fri-day classes and find yourself with a nice three day weekend. Most full-time students take around fifteen credits per

semester, which is usually five classes at three credits each. Some classes four credits, usually sciences. Each generally denotes one hour of class time per week. Every school is different in regard to how the hours per week are broken up, but at St. Thomas Aquinas College, I have ei-ther two one hour and twenty five minute classes or one two hour and fifty minute class per week. I found this to be a big change from the 44 minute periods that I had in high school five days per week, and it takes some adjustment, like many other as-

pects of college life do.

The personal attention professors give to students varies. Depending on class size, some will barely know your name and could care less whether or not you attend their class, while others will communicate with you on a fairly regular basis and strictly enforce attendance policies. "Extra help" is given during office hours, not after classes are over. Also, outside of extenuating circumstances, if you fail to show up for an exam, you receive a zero for it; there are rarely make-up sessions. Your interactions with your professors will differ quite a bit from those you experienced with your high school teachers.

Now to either confirm or dispel a few rumors. Pll start with the less in-cendiary ones. Cafeteria food is not as bad or disgusting as people make it out to be, but is often a mixed bag sometimes the food is surprisingly good, other times egregiously unpleas-ant. Sometimes sleep will be compromised due to your roommates' behav-iors and activities. Time management is essential to academic survival. There will be plenty of distractions and time will be plefity of distractions and time to slack off and procrastinate, espe-cially if you become involved in cam-pus activities; you will be up very late writing that paper or studying for a test for the next day (or rather, that) should you do this. Cram sessions and late night writing sessions can of-ten, although not always, be avoided. If vou do not get adequate sleep, one of three things will happen to you in class the next day: you will either still be



wired and manage to stay surprisingly alert, somewhat drowsy and zone out act; somewhat drowsy and zone on from time to time, or drained and en-ervated, unable to pay attention to your professor as you fight your body's natural urge to close your eyes.

Now on to other concerns. I don't care what the Residence Life Director or President or whoever says about any dry campus policies or alcohol prevention attempts, hear me loud and clear, you WILL be exposed to drinking. How you choose to handle your-self is up to you. More than likely, your roommates will come up with the ingenious brainstorms to either have a party in your room, go to where a party is being held, or to go off cam-pus to get wasted. You WILL witness an abundant amount of drunken be-havior, you WILL have to encounter situations where you will be encouraged to drink, and you WILL get to know substance abusers of all kinds. I was fortunate to not be exposed to any drugs besides alcohol, but that is not to suggest that that you will have the same fortune. You will be expected to act safely and responsibly or face consequences if you are stupid enough to get caught.

The fact of the matter is that col-

lege is what you make of it. This goes for what you learn in and out of the classroom and how you value and respond to it. You will learn things about yourself and others that will be eye-opening. You will have to make decisions you've never been faced with before and be put in situations you've never been in before. College is a learning experience, but that does not mean it cannot be an enjoyable one.





This high profile law enforcement is a two-pronged effort, utilizing enforcement and education, in an effort to save lives and decrease injuries through the increased use of seat belt and child restraint usage. Educational materials, such as posters and morning announcements, will be provided at SPHS.

Drivers should be aware that police will be issuing tickets if they see drivers and passengers not using their seat belts or children who are not restrained.

In an effort to increase child safety seat usage, the police department has a limited number of child booster seats which will be provided to residents free of charge
